MOREOVER, THEY WERE LARGELY UNINFOMRED ABOUT THEIR FATHER'S WORK. THEY KNEW HIS TITLE AND WHERE HE WORKED, BUT LITTLE MORE. AUDRAN DISCOURAGED HIS FAMILY FROM DISCUSSING, EVEN AT HOME, HIS JOB.
