SUBJECT: NIGHT OF BOMBINGS IN MEDELLIN

1. (U) ACCORDING TO PRESS REPORTS AND BNC MEDELLIN DIRECTOR, A TOTAL OF EIGHT BOMBS WERE EXPLODED IN MEDELLIN ON THE NIGHT OF FEBRUARY 7. AROUND 11 P.M., ROUGHLY SIMULTANEOUSLY EXPLOSIONS OCCURRED AT OR NEAR THE OFFICES OF XEROX, IBM, UNION CARBIDE, THE CONSERVATIVE GROUP TRADITION, FAMILY AND PROPERTY, A HARE KRISHNA TEMPLE, A YOGA/TRANSCENDENTAL CENTER, A COLOMBIAN FIRM TECNOQUIMICAS, AND AT AN UNSPECIFIED LOCATION IN THE NORTH OF THE CITY, WHERE A VEHICLE WAS DESTROYED. SO FAR THE ONLY REPORT OF CASUALTIES IS THE REPORTED DEATH OF A NIGHTWATCHMAN AT THE IBM OFFICES, WHERE THE MOST POWERFUL OF THE BOMBS WENT OFF. EXTENSIVE PROPERTY DAMAGE IS ALSO REPORTED. A COMBINED GROUP FROM THE CHE GUEVARA FACTION OF THE NATIONAL LIBERATION ARMY (ELN) AND THE "RICARDO FRONCO FRONT", A DISSIDENT GROUP OF THE FARC HAS REPORTEDLY CLAIMED RESPONSIBILITY.

2. (LOU) COMMENT: THE EMBASSY IS SEEKING ADDITIONAL INFORMATION ABOUT THE BOMBINGS. THE USIS BINATIONAL CENTER IN MEDELLIN WAS NOT ATTACKED. IMMEDIATELY

SUBJECT: DIRECT ACTION SLAYING OF GENERAL AUDRAN

1. A US JOURNALIST TOLD POLITICAL OFFICER, AMEMBASSY PARIS, ON 2/6/85 THAT HE HAD SUCCEEDED IN ENTERING THE AUDRAN HOME LAST WEEK AND INTERVIEWING THE THREE AUDRAN CHILDREN (RANGING IN AGE FROM 31 TO 19). THEY CONFIRMED THAT A GERMAN-ACCENTED INDIVIDUAL HAD TELEPHONED THE HOUSEHOLD THE EVENING OF THE KILLING TO ASK FOR GENERAL AUDRAN. THE 19 YEAR-OLD TOOK THE CALL, SAYING AUDRAN WOULD BE COMING HOME AT 9:00 P.M. THE CALLER SAID SOMETHING ABOUT AN "APPOINTMENT" AND POLITELY RANG OFF.

2. THE AUDRAN CHILDREN SAID THEY HAD RECEIVED NO INSTRUCTIONS ON SECURITY PROCEDURES AND WERE UNAWARE THEIR FATHER WAS A POTENTIAL TERRORIST TARGET. MOREOVER, THEY WERE LARGELY UNINFORMED ABOUT THEIR FATHER'S WORK. THEY KNEW HIS TITLE AND WHERE HE WORKED, BUT LITTLE MORE. AUDRAN DISCOURAGED HIS FAMILY FROM DISCUSSING, EVEN AT HOME, HIS JOB.
