1. ONE FIREBOMB AND TWO EXPLOSIVE DEVICES EXPLODED IN GUADELOUPE THE NIGHT OF MARCH 9-10, THE EVE OF CANTONAL ELECTIONS. FIVE PERSONS WERE INJURED. AT ABOUT 22:30, ONE BOMB HIT THE GOSIER GENDARMERIE, THE THIRD IN 13 MONTHS, WOUNDING ONE GENDARME AND THREE INNOCENT CIVILIANS IN A NEXT DOOR HOUSE. THE GENDAROEIE WAS ALSO SERIOUSLY DAMAGED. A SECOND EXPLOSIVE DEVIC E WAS LEFT IN A PUCKAGE OUTSIDE A STORE AT THE POINTE A PITRE MARINA AND WENT OFF WHEN IT WAS KICKED BY A RESTAURANT OPERATOR, COSTING HIM HIS FOOT WHICH HAD TO BE AMPUTATED. THE MARINA IS A FAVORITE CENTER FOR LUXURY SHOPPING AND DINING. ALSO AT ABOUT 22:30 A FIREBOMB DESTROYED A PUBLIC WORKS TRUCK AT PORT LOUIS.
