TRUSTED SYRIAN AGENTS. [REDACTED] HOWEVER, THAT THE SYRIANS INVOLVED IN THE BOMBINGS ARE NOT UNDER THE COMMAND OF SYRIAN INTELLIGENCE CHIEF IN LEBANON COL. MUHAMMAD G H A N I M, BUT RATHER ARE MEMBERS OF A SPECIAL SECURITY APPARATUS WHICH REPORTS DIRECTLY TO THE OFFICE OF SYRIAN PRESIDENT HAFIZ A L - A S A D. THIS UNIT, THE FATAH [REDACTED] CLAIMED, HAS BEEN GIVEN A BUDGET OF FIVE MILLION SYRIAN POUNDS TO CONDUCT ITS CAMPAIGN OF TERROR PRIOR TO A MEETING PLANNED FOR MID-OCTOBER OF THE SYRIAN-PALESTINIAN-LEBANESE NATIONAL MOVEMENT HIGHER COORDINATING COMMITTEE.

2. ACCORDING TO INFORMATION [REDACTED]

[REDACTED] THE PRIMARY OBJECTIVE OF THE BOMBINGS IS TO STIR POWERFUL FEELINGS OF INSECURITY AMONG RESIDENTS OF AREAS NOT NOW UNDER THE CONTROL OF THE SYRIAN ARAB DETERRENT FORCES (ADF). HAVING STIRRED SUCH FEELINGS, THE SYRIAN NEGOTIATORS INTEND TO DEMAND THAT THE ADF ASSUME FULL CONTROL IN THOSE AREAS FROM THE PALESTINIAN AND LEBANESE NATIONAL MOVEMENT GROUPS WHICH NOW DOMINATE THEM. AS EVIDENCE FOR THIS ANALYSIS, [REDACTED] MANY OF THE RECENT EXPLOSIONS, AS WELL AS THE MANY EXPLOSIVE DEVICES WHICH WERE DEFUSED BEFORE THEY COULD DETONATE, HAD BEEN PLACED IN PALESTINIAN-CONTROLLED NEIGHBORHOODS.

[REDACTED] A NUMBER OF SYRIAN DEFENSE COMPANIES AND INTELLIGENCE PERSONNEL HAVE BEEN INSERTED INTO SA'IGA AND GIVEN SA'IGA IDENTITY PAPERS AND UNIFORMS, PERMITTING THEM TO MOVE FREELY IN PALESTINIAN-DOMINATED AREAS. SOME OF THESE SYRIANS, [REDACTED] BELONG TO THE SPECIAL UNIT WHICH HAS BEEN PLANTING THE BOMBS.

WHILE PRIVATE SPECULATION AMONG MANY SEGMENTS OF LEBANESE SOCIETY HAS POINTED AT THE SYRIANS, PUBLIC STATEMENTS BY THE PALESTINE LIBERATION ORGANIZATION (PLO) AND LEBANESE NATIONAL MOVEMENT SPOKESMAN HAVE ACCUSED ISRAEL, THE PHALANGE AND LEBANESE ARMY MILITARY INTELLIGENCE (G-2) OF BEING RESPONSIBLE FOR THE EXPLOSIONS.)

1. DURING AN EARLY OCTOBER 1981 PRIVATE CONVERSATION,  
[Redacted] PHALANGE [Redacted] OFFICER STRONGLY DENIED ANY  
PHALANGE INVOLVEMENT IN THE RECENT SERIES OF CAR BOMB EXPLOSIONS  
IN BEIRUT AND OTHER AREAS OF LEBANON. HE CALIMED THE PHALANGE  
BELIEVED THE CAR BOMB EXPLOSIONS WOULD ONLY BENEFIT THE SYRIANS  
JUSTIFY THEIR CONTINUED "OCCUPATION" OF LEBANON ON THE GROUNDS OF  
PROVIDING SECURITY. THE PHALANGE OFFICER STATED THAT AFTER THE  
16 SEPTEMBER EXPLOSION IN SAYDA WHICH DAMAGED THE JOINT PALESTINIAN/  
LEBANESE NATIONAL MOVEMENT OPERATIONS CENTER AND RESULTED IN  
HEAVY CASUALTIES, PHALANGE [Redacted] RECEIVED A CALL FROM  
[Redacted] FATAH WHO REQUESTED ANY DETAILS THE  
PHALANGE MIGHT HAVE ON THOSE RESPONSIBLE FOR THE BOMBING. THE  
FATAH OFFICIAL WAS GIVEN ASSURANCES THE PHALANGE WAS NOT RESPONSIBLE

FURTHER DISSEMINATION AND USE OF THIS INFORMATION SUBJECT TO CONTROLS STATED AT BEGINNING AND END OF REPORT

FOR THE BOMBING AND WAS PROMISED FULL COOPERATION FROM THE PHALANGE. THE FATAH OFFICIAL REPORTEDLY RESPONDED THEY WOULD AWAIT THE RESULT OF THEIR INVESTIGATION BEFORE ACCEPTING PHALANGE ASSURANCES ON NON-INVOLVEMENT.

2. ACCORDING TO THE PHALANGE [REDACTED] OFFICIAL, AFTER THE PALESTINE LIBERATION ORGANIZATION (PLO) ARRESTED THREE SUSPECTS WHO WERE REPORTEDLY MEMBERS OF THE LEBANESE BRANCH OF THE SYRIAN BAITH PARTY AND OBTAINED THEIR CONFESSIONS THAT THEY HAD BEEN RESPONSIBLE FOR THE SAYDA BOMBING, THE FATAH [REDACTED] PASSED THIS INFORMATION TO THE PHALANGE. ACCORDING TO THE PHALANGE OFFICIAL, MEMBERS OF PHALANGE INTELLIGENCE ARE WORKING CLOSELY WITH FATAH IN INVESTIGATING THE BOMBINGS. ON 2 OCTOBER, PHALANGE INTELLIGENCE OFFICERS MET WITH FATAH SECURITY PERSONNEL IN THE SABRA PALESTINIAN CAMP. [REDACTED] COMMENT: THE PHALANGE [REDACTED] OFFICER STATED HE BELIEVED THE SYRIANS WERE RESPONSIBLE FOR THE BOMBINGS. THE REASONS FOR HIS SUSPICION OF SYRIAN INVOLVEMENT WERE THAT THE TARGETS OF THE EXPLOSIONS WERE IN AREAS NOT DIRECTLY UNDER SYRIAN CONTROL. CONTINUED EXPLOSIONS IN SIMILIAR AREAS IN WEST BEIRUT OR OTHER AREAS WOULD PERMIT THE SYRIANS TO USE THEM AS AN EXCUSE TO WIDEN THEIR AREAS OF CONTROL.)

3. DESPITE THE LIAISON WITH FATAH IN INVESTIGATIONS INTO THE EXPLOSIONS IN WEST BEIRUT, [REDACTED] SINCE EARLY SEPTEMBER, THE PHALANGE HAS INTERCEPTED OR UNCOVERED SIX CAR BOMBS IN EAST BEIRUT AREAS UNDER THEIR CONTROL. AS A RESULT OF THE

ARREST AND QUESTIONING OF THOSE APPREHENDED WITH THE VEHICLES FILLED WITH EXPLOSIVES, PHALANGE INTELLIGENCE HAS DETERMINED THAT ALL WERE WORKING FOR FATAH. INVESTIGATIONS RESULTED IN THE ROLL-UP A NETWORK OF 32 FATAH OPERATIVES IN EAST BEIRUT DURING LATE SEPTEMBER. THE PHALANGE OFFICIAL CLAIMED MOST WERE FORMER MEMBERS OF THE NATIONAL LIBERAL PARTY (NLP) WHO BEGAN TO WORK WITH FATAH AFTER THE JULY 1980 DEFEAT OF THE NLP MILITIA BY THE PHALANGE. OTHERS ARRESTED INCLUDED MEMBERS OF THE PROGRESSIVE SOCIALIST PARTY (PSP), THE COMMUNIST ACTION ORGANIZATION (CAO) AND THE LEBANESE COMMUNIST PARTY (LCP.) ALL, HOWEVER, ACCORDING TO THE PHALANGE [REDACTED] OFFICER, WERE UNDER THE DIRECT CONTROL OF FATAH. THROUGH THEIR LIAISON WITH FATAH, THE PHALANGE HAS CONFRONTED FATAH WITH DETAILS RECEIVED FROM THOSE ARRESTED. WHILE FATAH HAS NOT CONFIRMED NOR DENIED ITS INVOLVEMENT WITH THOSE ARRESTED, IT HAS REQUESTED THE PHALANGE "NOT HARM THE FAMILIES" OF THOSE ARRESTED. [REDACTED] COMMENT: ALSO DESPITE THE PHALANGE/FATAH LIAISON REPORTED ABOVE, ACCORDING TO "AS SAFIR" OF 3 OCTOBER, KHALIL AL-WAZIR (ABU JIHAD), MEMBER OF THE FATAH CENTRAL COMMITTEE HAS ISSUED A STATEMENT ACCUSING THE PHALANGE MILITARY COUNCIL OF COOPERATING WITH ISRAEL IN CARRYING OUT THE CAR BOMBINGS. AND BEING SPECIFICALLY TARGETED.

1. OVERALL RESPONSIBILITY FOR SECURITY DURING THE VISIT RESTS WITH A SECURITY COMMITTEE INCLUDING THE MILITARY, NATIONAL POLICE AND THE NATIONAL DEPARTMENT OF INVESTIGATION WHICH HAS THE PROTECTIVE RESPONSIBILITIES. THIS COMMITTEE WAS FORMED BY SECRETARY AND PLACED UNDER THE COMMAND OF BRIGADIER GENERAL BATES WHO IS KNOWN FOR HIS SOUND NON-CONFRONTATIONAL PROFESSIONALISM. SECURITY FORCE LEADERS MET ON SEPTEMBER 30 AND OCTOBER 1 AND FORMULATED PLANS TO DEAL WITH VARIOUS CONTINGENCIES.

2. IN ADDITION TO USUAL SECURITY MEASURES, THE GOVERNMENT WILL TAKE THE FOLLOWING ACTIONS (A) CLOSE THE UNIVERSITY AND SECONDARY SCHOOLS IN SANJO JOHNSON (PRINCIPAL MEETING PLACES FOR LEFTIST AGITATORS AND LEADERS) BEGINNING OCT. 3 UNTIL OCT 14, (B) POSITION MILITARY UNITS WITHIN SANJO JOHNSON TO SUPPORT NATIONAL POLICE, (C) CITY HAS BEEN DIVIDED INTO SECURITY ZONES WITH SPECIFIC SECURITY RESPONSIBILITY FOR EACH ZONE ASSIGNED TO SECURITY FORCES.

3. THESE PLANS ARE BASED UPON AN AWARENESS OF THE LEFT'S PLANS AND THE DETERMINATION OF TOP DOMINICAN MILITARY AND POLICE OFFICIALS TO FRUSTRATE THE LEFT'S PLANS AND AVOID GIVING THEM HEED. THEY ARE ACUTELY AWARE OF THE NEED TO AVOID OVER-REACTION BY THE FORCES UNDER THEIR COMMAND. A KEY ELEMENT OF THE SECURITY COMMITTEE'S PLANS, OUTLINED ABOVE, IS TO DENYVE THE LEFT OF POTENTIAL DEMONSTRATORS BY DECLARING A SCHOOL HOLIDAY OBTENSIBLY TO CARRY OUT LONG-NEEDED REPAIR AND MAINTENANCE WORK AT THE UNIVERSITY AND ELSEWHERE. SECONDLY, BY POSITIONING MILITARY UNITS IN ALL KEY SECTIONS OF THE CITY BEFORE DAYLIGHT. ON THE MORNING OF THE VISIT, THE GOVERNMENT INTENDS TO PREVENT SMALL GROUPS FROM COALESCING INTO A MASSIVE DEMONSTRATION INVOLVING LARGE SCALE CONFRONTATION AND POSSIBLE VIOLENCE. FIREWEBS, INCLUDING THE USE OF TEAR GAS WILL BE USED TO PREVENT SMALL GROUPS FROM MOVING TO ASSEMBLY POINTS. ALTHOUGH TROOP COMMANDERS WILL BE INSTRUCTED TO DROP RESTRAINT AS WELL AS FIREWEBS, THE CENTRAL DETERMINATION OF THE LEFTIST LEADERS TO OBTAIN A BATTLE PAVED IT PROBABLE THAT SOME DEMONSTRATORS WILL BE HURT, AND LOSS OF LIFE IS POSSIBLE.

4. CASUALTY OFFICERS MET ON OCTOBER 1 AND 2 WITH TOP MILITARY LEADERS, CHIEF OF THE NATIONAL POLICE AND THE DIRECTOR OF ONE TO DISCUSS SECURITY PREPARATIONS. THE DOMINICAN OFFICIALS WERE CONFIDENT THAT THEY ARE CAPABLE OF KEEPING THE SITUATION UNDER CONTROL. ON OCTOBER 4 AMBASSADOR OFFICERS LED BY OCS REVIEWED ENTIRE PROGRAM WITH DHT CHIEF GENERAL MADRICK AND OTHER SECURITY PERSONNEL. THEY AGAIN EXPRESSED CONFIDENCE OVER THEIR ABILITY TO HANDLE THE SECURITY SITUATION AND ARE PREPARED TO COOPERATE FULLY WITH AMBASSADOR AND THE VICE PRESIDENT'S ADVISOR TEAM. HE BELIEVES THAT PROTESTERS WILL BE PREVENTED FROM DISRUPTING THE GOVERNMENT.

[REDACTED] VICE PRESIDENT BUSH'S PLANNED VISIT TO THE DOMINICAN REPUBLIC 11-13 OCT 1981 IS CAUSING LOCAL ARMED FORCES AND NATIONAL POLICE TO FALL OUT IN FORCE TO INSURE THE SAFETY OF THE VICE PRESIDENT AS WELL AS TO MAINTAIN GENERAL ORDER THROUGHOUT THE CITY. THERE IS NO DOUBT THAT THE ARMED FORCES ARE IN CHARGE OF SECURITY FOR THE VISIT, ALTHOUGH IN COORDINATION WITH THE NATIONAL POLICE AND THE DEPT OF NATIONAL INVESTIGATIONS (DNI). THE RO AND ARMA ON 24 SEP 1981 ATTENDED A PLANNING SESSION, AS OBSERVERS, AT THE ARMED FORCES COMMAND CENTER (COFA) IN WHICH WERE PRESENT REPRESENTATIVES OF ALL MILITARY INTELLIGENCE SERVICES, NATIONAL POLICE (SECRET SERVICE) AND GEN OSCAR ((PABILLA)) MEDRANO, DIRECTOR OF THE DNI. IN CHARGE OF THE GROUP WAS GEN PANISO ((MATOS)) GONZALEZ, SUBSECRETARY OF STATE FOR THE ARMED FORCES (ARMY). MATOS OUTLINED THAT AS OF 0400 ON THE 11TH OF OCT, SANTO DOMINGO WOULD AWAKE TO FIND THE MILITARY OCCUPYING POSITIONS WITHIN THE CITY OF SANTO DOMINGO. THIS OCCUPATION OF THE CITY WOULD CONSIST OF EXECUTING A FORMERLY CONCEIVED CONTINGENCY PLAN WHICH DIVIDES THE CITY INTO EIGHT DISTINCT MILITARY ZONES, EACH THE RESPONSIBILITY OF EITHER THE ARMY, NAVY, OR AIR FORCE. ALSO WITHIN THIS PLAN IS THE LOCATION OF AN ARMY REACTION BATTALION LOCATED WITHIN THE CONFINES OF THE MOTOR TRANSPORT BATTALION HEADQUARTERS IN SANTO DOMINGO. WITHIN THESE AREAS ALSO WORK THE NATIONAL POLICE UNDER THE DIRECTION OF THEIR RADIC PATROL DIVISION). THIS COMBINED ARMED FORCES/NATIONAL POLICE FORCE WOULD ALL BE UNDER THE DIRECTION OF THE COFA, WITH REPRESENTATIVES OF ALL ARMED FORCES AND NATIONAL POLICE PRESENT ON A 24 HOUR BASIS. THE RESPONSIBILITY FOR CLOSE SECURITY OF VP BUSH AND OFFICIAL PARTY WOULD FALL TO THE DNI. OVERALL DIRECTION AND CONTROL OF THE TOTAL DOMREP SECURITY EFFORT WOULD BE THE RESPONSIBILITY OF GEN MATOS. AM-SADAT-LIBYANS

UNITED NATIONS, OCT 7, REUTER -- LIBYA, A TARGET OF AMERICAN SUSPICION IN THE SADAT ASSASSINATION, TODAY ACCUSED WASHINGTON OF PLOTTING TO KILL LIBYAN LEADER MUHAMMAR GADDAFI.

"THE LATEST TERRORISM ON THE PART OF THE NEW AMERICAN ADMINISTRATION, WHICH HAS BEEN REVEALED BY THE AMERICAN NEWSPAPERS AND CONFIRMED BY SOME OFFICIALS, IS THE EXISTENCE OF A PLOT TO ASSASSINATE... COLONEL MUHAMMAR GADDAFI," LIBYA'S CHIEF FOREIGN AFFAIRS SPOKESMAN, ABDULATI AL-OBEIDI, SAID.

HE SAID IN AN ADDRESS TO THE GENERAL ASSEMBLY THAT THIS CONFIRMED THAT "PHYSICAL LIQUIDATION AND TERRORISM" HAD BECOME A PILLAR OF U.S. POLICY.

MR AL-OBEIDI MADE NO MENTION OF YESTERDAY'S ASSASSINATION OF EGYPTIAN PRESIDENT ANWAR SADAT, WHO HAD WAGED A BITTER PERSONAL AND IDEOLOGICAL STRUGGLE WITH COLONEL GADDAFI.

BUT IN A SPEECH FILLED WITH ATTACKS ON U.S. POLICY IN VARIOUS PARTS OF THE WORLD, HE CASTIGATED WASHINGTON FOR ITS "COLLUSION WITH THE EGYPTIAN REGIME AND THE ZIONIST ENTITY IN ORDER TO IMPOSE SOLUTIONS FOR THE MIDDLE EAST PROBLEM" THROUGH THE CAMP DAVID ACCORDS.

"THE U.S. UNDER PRESIDENT REAGAN'S ADMINISTRATION PLAYS THE MAJOR ROLE IN DESTABILIZING PEACE AND SECURITY IN THE WORLD AND HAS REVERTED TO THE COLD WAR AND THE SCRAMBLE FOR SPHERES OF INFLUENCE," HE SAID.

AFTER YESTERDAY'S SHOOTING, SECRETARY OF STATE ALEXANDER HAIG, WHILE SAYING THERE WAS NO EVIDENCE OF LIBYAN INVOLVEMENT, SHARPLY CRITICIZED LIBYAN BROADCASTS HAILING MR SADAT'S DEATH. FORMER PRESIDENT JIMMY CARTER SAID HE BELIEVED LIBYA MOST LIKELY "ENCOURAGED" THE ASSASSINATION.

MR AL-OBEIDI SAID: "THE GOAL OF THE U.S. NOW IS TO MILITARIZE THE WORLD AND TO DIVIDE IT INTO TWO FACTIONS: ONE IT DRAWS INTO ITS IMPERIALIST REACTIONARY CAMP AND (THE) OTHER, WHICH INCLUDES BASICALLY THE NEUTRAL COUNTRIES, IT FORCEFULLY COMPELS TO JOIN EITHER ITS CAMP OR THE COMMUNIST CAMP."

HE URGED "ALL PEOPLES" TO STAND UP TO U.S. "AGGRESSION" AND NOT ALLOW WASHINGTON TO "BESTOW UPON ITSELF THE ROLE OF THE POLICEMAN WHO TRIES TO DICTATE HIS WILL UPON OTHERS."

HE CALLED ON THE INTERNATIONAL COMMUNITY, ESPECIALLY THE NON-ALIGNED COUNTRIES, TO CONFRONT SUCH PRESSURES SO THAT LIBYA WOULD NOT BE "COMPELLED TO ALLY ITSELF WITH THE FRIEND THAT AIDS IT IN RESISTING THIS PREMEDITATED AMERICAN AGGRESSION" -- AN ALLUSION TO THE SOVIET UNION.

CONDENNING WHAT HE CALLED WASHINGTON'S USE OF BACTERIOLOGICAL WARFARE AGAINST CUBA AND TERRORISM AGAINST NICARAGUA AND GRENADA, HE SAID THE UNITED STATES WAS "NO LONGER FIT TO HOST THE U.N."

THE WORLD BODY SHOULD BE TRANSFERRED TO "ANOTHER COUNTRY THAT RESPECTS OUR ORGANIZATION AND MAINTAINS ITS GOALS," HE SAID.

REFERRING TO THE SHOOTING DOWN OF TWO LIBYAN FIGHTERS BY U.S. NAVY PLANES IN AUGUST, HE SAID THIS WAS AN ACT OF AGGRESSION THAT VIOLATED LIBYAN AIR SPACE AND HAD BEEN APPROVED IN ADVANCE BY THE NATIONAL SECURITY COUNCIL.

WASHINGTON SAID AT THE TIME THE LIBYAN PLANES WERE DOWNED OVER INTERNATIONAL WATERS AFTER THEY ATTACKED AMERICAN NAVAL AIRCRAFT ENGAGED IN ROUTINE MANUEVERS.

PRESIDENT ANWAR AL-SADAT WAS ASSASSINATED AND THE INVOLVEMENT OF ELEMENTS WITHIN THE EGYPTIAN MILITARY IN HIS ASSASSINATION ARE CAUSE FOR CONCERN, THERE IS NO INDICATION THAT AN OUTBREAK OF VIOLENCE INVOLVING EGYPTIAN MILITARY FORCES IS LIKELY TO OCCUR IN THE NEAR FUTURE OR THAT ANY REACTION TO THE ASSASSINATION BY THE GENERAL PUBLIC WILL RESULT IN DISTURBANCES WHICH EGYPTIAN SECURITY FORCES CANNOT CONTROL.

2. GOV ACTIONS IN THE AFTERMATH OF SADAT'S ASSASSINATION HAVE BEEN SWIFT, WELL-ORDERED AND REASONABLE. SIMULTANEOUS WITH THE ANNOUNCEMENT OF SADAT'S DEATH A STATE OF EMERGENCY WAS DECLARED. THIS ACTION PERMITS THE GOVERNMENT TO EXERCISE MUCH BROADER POWERS THAN NORMAL TO INSURE PUBLIC ORDER. 7. GOR PLANS TO INSURE THE SAFETY OF FOREIGN DIGNITARIES WHO WILL ATTEND THE SADAT FUNERAL ARE NOT YET FULLY FORMULATED. ALTHOUGH EGYPTIAN MILITARY INTELLIGENCE HAD THE PRIMARY PROTECTION RESPONSIBILITY DURING THE ASSASSINATION ATTACK ON 6 OCTOBER 1981, THE PRESIDENTIAL SECURITY FORCES ARE CHARGED WITH SECURITY RESPONSIBILITY FOR VISITING DIGNITARIES. 3. ALMOST TWENTY-FOUR HOURS AFTER THE ASSASSINATION OF PRESIDENT SADAT, CAIRO IS SLOWLY SHEEDING THE PALL OF UNCHARACTERISTIC QUIET WHICH HAS SHROUDED THIS CITY SINCE YESTERDAY AFTERNOON. STREETS ARE STILL RELATIVELY FREE OF TRAFFIC AND PEDESTRIANS, ALTHOUGH LIFE IS BEGINNING TO PICK UP AS WE APPROACH THE NOON RUSH HOUR. (WE UNDERSTAND SOME PEOPLE WERE DETAINED LAST NIGHT, BUT APPARENTLY THIS WAS YET ANOTHER FOLLOW-ON MEASURE TO THE SEPTEMBER POUND-UP.) LIKEWISE, THERE HAS BEEN NO PUBLIC EXPLANATION OF THE ALLEGED ORGANIZATIONAL AFFILIATION OF THE PRESIDENT'S ATTACKERS. HOWEVER, WE UNDERSTAND THAT THE GOE SECURITY FORCES HAVE SATISFIED THEMSELVES THAT TWO OF THE ATTACKERS WERE INDEED CIVILIAN MEMBERS OF THE FANATICAL "AL-TAKFIR WA AL-HIJRA" (ATONEMENT AND HOLY FLIGHT) SOCIETY AND THAT THEY WERE ASKED TO TAKE THE PLACE OF TWO REGULAR SOLDIERS WHO WENT ON LEAVE BY A MILITARY OFFICER WHO WAS ALSO A MEMBER OF THE "TAKFIR WA HIJRA" GROUP. THIS REPORT IS CONSISTENT WITH FOREIGN MINISTER ALI'S REMARKS TO THE AMBASSADOR OCTOBER 6 (REF P).

8. EMBASSY WILL BE FORWARDING SEPARATELY LATEST INFORMATION CONCERNING SATURDAY'S STATE FUNERAL AND PROSPECTIVE FOREIGN DIGNITARIES WHO ARE EXPECTED TO PAY THEIR RESPECTS. CEREMONIES ARE TO BE HELD AT NOON AT HELIOPOLIS TO MINIMIZE SECURITY RISK.
