1. THE FOREIGN MINISTRY INFORMED EMBASSY EARLY MORNING OF MARCH 31 THAT THE PALACE WAS RELEASING THE FOLLOWING MESSAGE TO PRESIDENT FROM THE KING AND QUEEN OF NEPAL. MESSAGE IS BEING TRANSMITTED TO NEPALI EMBASSY IN WASHINGTON FOR DELIVERY TO THE WHITE HOUSE. FULL TEXT FOLLOWS BELOW:

2. QUOTE. THE QUEEN AND I HAVE BEEN DEEPLY SHOCKED BY THE NEWS OF THE ATTEMPT ON YOUR EXCELLENCY'S LIFE. THE GOVERNMENT AND PEOPLE OF NEPAL JOIN US IN PRAYING THAT YOU WILL RECOVER SOON AND WILL CONTINUE TO LEAD YOUR COUNTRY TO STILL FURTHER PROGRESS AND PROSPERITY.  
SIGNED, BIRENDRA K. UNQUOTE.

3. COMMENT: WHILE WE HAVE BEEN KEEPING THE FOREIGN MINISTRY AND PALACE SECRETARIAT INFORMED OF THE NEWS OF THE PRESIDENT'S HEALTH THROUGHOUT THE EARLY MORNING HOURS OF MARCH 31 LOCAL TIME (AS PER REYTEL), PALACE SECRETARY CHIRAN THAPA TOLD ME, SHOULD I NOT BE ABLE TO GET THROUGH TO HIM, TO CALL THE KING DIRECTLY WITH NEWS OF THE PRESIDENT'S HEALTH. TO THE BEST OF MY KNOWLEDGE THIS HAS NEVER BEEN SUGGESTED BEFORE, I.E., EMBASSY DIRECTLY TALKING WITH HIS MAJESTY. IN THE EVENT, IT WAS NOT NECESSARY, BUT I THINK IT IS AN ACCURATE REFLECTION OF THE DEGREE OF CONCERN AND DISTRESS FELT HERE.

THE NEWS WE HAVE RECEIVED OF YOUR CONDITION GIVES US CAUSE FOR RELIEF, AND WE EXPRESS OUR HOPES FOR A SPEEDY AND FULL RECOVERY. UNQTE.

3. TO MRS. REAGAN: GTE ALL AUSTRALIANS HAVE BEEN SHOCKED TO HEAR OF THE ATTEMPT ON THE PRESIDENT'S LIFE AND OF THE CONSEQUENCES FOR OTHERS. PLEASE ACCEPT OUR WISHES FOR A FULL AND SPEEDY RECOVERY FOR YOUR HUSBAND. MRS. FRASER AND I HAVE A VERY SINCERE CONCERN FOR YOU BOTH AT THIS DISTRESSING TIME. UNQTE.

4. TO SECRETARY OF STATE: GTE THE NEWS THIS MORNING OF THE ATTEMPT ON THE LIFE OF PRESIDENT REAGAN HAS HEARD IN AUSTRALIA WITH SHOCK AND DISTRESS. I HAVE SENT A MESSAGE TO THE PRESIDENT TO SAY THIS AND TO EXPRESS THE WISHES OF ALL AUSTRALIANS FOR HIS FULL AND SPEEDY RECOVERY. WE EXPRESS ALSO OUR SYMPATHY TO THOSE AIDES OF THE PRESIDENT WHO HAVE BEEN INVOLVED AND TO THEIR FAMILIES. THIS IS A TERRIBLE OCCURRENCE WHICH WILL BE DEPLORED AROUND THE WORLD. UNQTE.

1. FOREIGN MINISTRY ISSUED STATEMENT ON BEHALF OF GOV AFTERNOON

2. BEING TEXT, THE GOVERNMENT OF THE REPUBLIC, PROFOUNDLY  
DISTRESSED BY THE VILE CRIME SUFFERED A FEW MINUTES AGO BY THE  
PRESIDENT OF THE UNITED STATES OF AMERICA, RONALD REAGAN, IN  
WASHINGTON, ANNOUNCES ITS ABSOLUTE REPUDIATION OF THIS GRAVE  
NEW ACT OF INTERNATIONAL VIOLENCE. THE COURAGEOUS ACT NOT ONLY  
REPRESENTS A CRIME AND AN AFFRONT TO A SISTER NATION IN THE PER-

3. EMBASSY HAS BEEN FLOODED WITH CALLS FROM COSTA RICANS PUBLIC AND PRIVATE, ALL EXPRESSING SHOCK, SORROW AND SUPPORT. A COMMON THEME IS FULL UNDERSTANDING AND SYMPATHY, ESPECIALLY GIVEN COSTA RICA'S OWN SHOCKING INTRODUCTION INTO THIS KIND OF VIOLENCE MARCH 17, WHEN A US EMBASSY VEHICLE WITH THREE MARINES WAS THE OBJECT OF A TERRORIST ATTACK, AS WAS THE HONDURAN EMBASSY. 1. THE FOREIGN MINISTRY INFORMED EMBASSY EARLY MORNING OF MARCH 31 THAT THE PALACE WAS RELEASING THE FOLLOWING MESSAGE TO PRESIDENT FROM THE KING AND QUEEN OF NEPAL. MESSAGE IS BEING TRANSMITTED TO NEPALI EMBASSY IN WASHINGTON FOR DELIVERY TO THE WHITE HOUSE. FULL TEXT FOLLOWS BELOW:

2. QUOTE. THE QUEEN AND I HAVE BEEN DEEPLY SHOCKED BY THE NEWS OF THE ATTEMPT ON YOUR EXCELLENCY'S LIFE. THE GOVERNMENT AND PEOPLE OF NEPAL JOIN US IN PRAYING THAT YOU WILL RECOVER SOON AND WILL CONTINUE TO LEAD YOUR COUNTRY TO STILL FURTHER PROGRESS AND PROSPERITY.  
SIGNED, BIRENDRA R. UNQUOTE.

3. COMMENT: WHILE WE HAVE BEEN KEEPING THE FOREIGN MINISTRY AND PALACE SECRETARIAT INFORMED OF THE NEWS OF THE PRESIDENT'S HEALTH THROUGHOUT THE EARLY MORNING HOURS OF MARCH 31 LOCAL TIME (AS PER REPTEL), PALACE SECRETARY CHITRA THAPA TOLD ME, SHOULD I NOT BE ABLE TO GET THROUGH TO HIM, TO CALL THE KING DIRECTLY WITH NEWS OF THE PRESIDENT'S HEALTH. TO THE BEST OF MY KNOWLEDGE THIS HAS NEVER BEEN SUGGESTED BEFORE, I.E., EMBASSY DIRECTLY TALKING WITH HIS MAJESTY. IN THE EVENT, IT WAS NOT NECESSARY, BUT I THINK IT IS AN ACCURATE REFLECTION OF THE DEGREE OF CONCERN AND DISTRESS FELT HERE.
