MEMORANDUM FOR THE SECRETARY OF STATE

SUBJECT: Determination to Authorize the Furnishing of
Immediate Military Assistance to Chad

Pursuant to the authority vested in me by Section 506(a) of the Foreign Assistance Act, as amended ("the Act") I hereby determine that:

- 1) an unforeseen emergency exists which requires immediate military assistance to Chad; and
- 2) the aforementioned emergency requirement cannot be met under the authority of the Arms Export Control Act or any other law except Section 506(a) of the Act.

Therefore, I hereby authorize the furnishing of up to \$15,000,000 in defense articles from the stocks of the Department of Defense, defense services of the Department of Defense, and military education and training to Chad under the provisions of chapters 2 and 5 of Part II of the Act.

This determination shall be reported to Congress immediately and published in the Federal Register.

MEMORANDUM FOR THE SECRETARY OF STATE

SUBJECT: Determination to Authorize the Furnishing of
Immediate Military Assistance to Chad

Pursuant to the authority vested in me by Section 506(a) of the Foreign Assistance Act, as amended ("the Act"), I hereby determine that:

- 1) an unforeseen emergency exists which requires immediate military assistance to Chad; and
- 2) the aforementioned emergency requirement cannot be met under the authority of the Arms Export Control Act or any other law except Section 506(a) of the Act.

Therefore, I hereby authorize the furnishing of up to \$10,000,000 in defense articles from the stocks of the Department of Defense, defense services of the Department of Defense, and military education and training to Chad under the provisions of Chapters 2 and 5 of Part II of the Act.

This determination shall be reported to Congress immediately and published in the Federal Register.
