

Although neither you nor I know yet just what prompted this atrocity, all Americans share your sense of grief and anguish at the loss of life of some of your nation's finest and most respected officials.

Although it cannot console the families of those who have suffered this grievous loss, we offer to them and to you our sympathy and our prayers.

As has been the case too often in the past, Mr. President, our nations again are drawn together in an hour of tragedy and sorrow. Until I can convey my thoughts to you personally next month, I hope you will accept this expression of my deepest sympathy at your nation's loss.

1. FOLLOWING IS PRESS STATEMENT AND GUIDANCE NOW BEING
USED BY DEPT. SPOKESMAN CONCERNING THE BOMBING IN RANGOON:

2. STATEMENT:

AT ABOUT MIDNIGHT EDT LAST NIGHT, AN EXPLOSION OCCURRED
AT THE NATIONAL CEMETERY OF BURMA, WHERE THE PRESIDENT OF
THE REPUBLIC OF KOREA WAS EXPECTED SHORTLY TO TAKE PART
IN A WREATH-LAYING CEREMONY. KOREAN PRESIDENT CHUN DOO
HWAN WAS IN RANGOON ON THE FIRST LEG OF A PLANNED
SIX-NATION TRIP.

PRESIDENT CHUN HAD NOT YET ARRIVED AT THE CEMETERY WHEN
THE EXPLOSION OCCURRED, BUT EARLY REPORTS INDICATE THAT
FIFTEEN KOREANS AND AT LEAST THREE BURMESE WERE KILLED IN
THE EXPLOSION. NEITHER CHAIRMAN NE WIN NOR PRESIDENT SAN
YU WERE PRESENT AT THE SITE. WE HAVE NO FIRM INDICATION
OF BURMESE CASUALTIES; THE KOREAN DEAD INCLUDE THE DEPUTY
PRIME MINISTER, THE FOREIGN MINISTER, THE COMMERCE AND

INDUSTRY MINISTER AND THE MINISTER OF ENERGY AND
RESOURCES. THERE ARE REPORTS OF MANY INJURIES IN
ADDITION TO THE DEATHS.

PRESIDENT CHUN HAS CANCELLED THE REST OF HIS PLANNED
ITINERARY, AND IS RETURNING TO SEOUL WITH HIS PARTY.

WE HAVE NO INFORMATION YET ON THE CAUSE OF THE EXPLOSION.

THE UNITED STATES IS SHOCKED AND SADDENED AT THIS TRAGIC
INCIDENT, AND WE SEND OUR CONDOLENCES TO THE THE
GOVERNMENTS AND PEOPLE OF KOREA AND BURMA. END STATEMENT.

QUESTIONS AND ANSWERS:

Q: WAS IT DEFINITELY A BOMB?

A: --WE HAVE NO INFORMATION AS OF YET ON THE ORIGIN OF
THE EXPLOSION. THE INITIAL REPORT FROM OUR EMBASSY IN
RANGOON SAID AN "EXPLOSIVE DEVICE" HAD BEEN PLACED UNDER
THE REVIEWING STAND, BUT THAT HAS NOT YET BEEN CONFIRMED.

Q: HAS ANYONE CLAIMED RESPONSIBILITY?

A: --NOT TO OUR KNOWLEDGE.

Q: IS THERE ANY CONNECTION BETWEEN THIS INCIDENT AND THE INTERPARLIAMENTARY UNION MEETING IN SEOUL? THE KAL 007 INCIDENT? WAS IT DONE BY A BURMESE INSURGENT GROUP?

A: --WE HAVE NO INFORMATION ON THE ORIGIN OF THE EXPLOSION. EVEN ASSUMING THAT IT WAS DELIBERATE, WE CANNOT SPECULATE ON THE MOTIVES OF THE RESPONSIBLE PARTY.

Q: WHAT IS THE SITUATION IN KOREA? IS OUR MILITARY ON ALERT?

A: --THERE HAS BEEN NO CHANGE IN OUR NORMAL MILITARY POSTURE, BUT WE OBVIOUSLY ARE WATCHING THE SITUATION CLOSELY. ANYTHING FURTHER WOULD COME FROM THE PENTAGON.

Q: ;ILL THIS INCIDENT AFFECT THE PRESIDENT'S VISIT TO SEOUL?

A: --ALTHOUGH YOU SHOULD ADDRESS THE QUESTION TO THE WHITE HOUSE, THE INCIDENT WILL NOT AFFECT THE PRESIDENT'S TRIP TO SEOUL. SHULTZ
