Lt. Col. Daly was born on 6 March 1943 in Portland, Oregon. Upon graduation in 1965 from the University of Portland with a BA in Political Science, he was commissioned a Second Lieutenant in the U.S. Air Force.

He attended pilot training in 1966 at Williams AFB, Arizona.

From 1967 to 1973 Lt. Col. Daly served as a B-52 instructor pilot at Fairchild AFB, Washington. During this period he flew eight operation ARC LIGHT tours in Vietnam for a total of 365 combat missions.

From 1973 to 1976 Lt. Col. Daly instructed in the B-52 Combat Crew Training Squadron at Castle AFB, California. In 1976 he was selected in the initial cadre of the Central Flight Instructor Course also at Castle. He was appointed chief of the B-52 Division in 1978.

Lt. Col. Daly was assigned to the Directorate of Operations, Headquarters USAF, the Pentagon in 1979. In 1980 he was appointed as Chief, Contingency Operations and Exercise Division and served in this capacity until 1985. During this period Lt. Col. Daly's duties included the JCS and USAF Crises Staffing Procedures, the HQ USAF Contingency Support Staff, the JCS and USAF Exercise Programs, USAF Wargaming, Exercise Airspace, Non-Combatant, Evacuation Operations and the USAF Combatting Terrorism Center. Participation in Contingency operations have included: RUBBER WALL Lebanon resupply, ARID FARMER Operations in Sudan, ELF ONE operations in Saudi Arabia, EAGLE LOOK Operations in Egypt, the Beirut bombing, INTENSE LOOK the Red Sea mining, URGENT FURY operations in Grenada, operations in Central America, and ELOQUENT RIDE the hijacking of TWA 847.

Professional military education includes Squadron Officer School, Air Command and Staff College, Industrial College of the Armed Forces, Air War College and Crisis Management Seminar.

LIEUTENANT COLONEL ROBERT L. EARL, USMC

Lieutenant Colonel Earl is assigned to the Advanced Amphibious Study Group located at the Marine Corps Development and Education Command, Quantico, Virginia.

Lieutenant Colonel Earl was born on 13 November 1945 in Norristown, Pennsylvania. He graduated from the US Naval Academy and was commissioned in the Marine Corps in June of 1967.

Second Lieutenant Earl was a summer intern in the East Asia, Regional Affairs bureau of the Department of State prior to reporting to The Basic School at Quantico in September of 1967. After completing training at Quantico Lieutenant Earl became a reconnaissance platoon commander in the 5th Marine Division at Camp Pendleton, California.

In October 1968 Lieutenant Earl attended Oxford University in England as a Rhodes Scholar, studying Philosophy, Politics, and Economics (BA/MA degrees).

Returning to the United States in the summer of 1971, Captain Earl reported to the 2d Marine Division at Camp Lejeune, North Carolina where he served as Division Education Officer; as Operations Officer (initially as S-3A and later as the S-3) of the 2d Battalion, 2d Marines during a deployment aboard ship to the Mediterranean Sea; and as Commanding Officer of Company B, 1st Battalion, 2d Marines. In 1973 he became a student at the Amphibious Warfare School at Quantico.

Departing the United States again, Captain Earl joined the 3d Reconnaissance Battalion in Okinawa, serving as battalion operations officer (S-3) and as a reconnaissance company commander. He continued in the reconnaissance field upon his return to Quantico in 1974 with assignment as the amphibious reconnaissance project officer and the remote ground sensor project officer in the Development Center.

After three years in research and development Captain Earl became the Assistant National Intelligence Officer for the Near East and South Asia at CIA. Promoted to Major, he then became a student at the Marine Corps Command and Staff College in Quantico.

In June 1981 Major Earl reported to the 1st Marine Brigade in Hawaii, where he served in a variety of billets including infantry battalion executive officer, regimental operations officer (S-3), brigade operations officer (G-3 Ops), and infantry battalion commanding officer. During this three-year FMF tour Lieutenant Colonel Earl conducted two deployments to the Indian Ocean with the 31st Marine Amphibious Unit. From August 1984 until June 1985 Lieutenant Colonel Earl attended the Naval War College at Newport, Rhode Island.

Lieutenant Colonel Earl's decorations include the Navy-Marine Corps Medal, the Meritorious Service Medal, and a Meritorious Unit Citation.

CAPTAIN DAVID J. MCMUNN, USN

Biography

Captain McMunn was born in Pittsburgh, Pennsylvania on 16 July 1941. In 1963, he graduated from St. Vincent College in Latrobe, Pennsylvania, earning a Bachelor of Arts (BA) degree after majoring in Biology. He later attended Georgetown University in Washington, D.C., and received his Master of Arts (MA) in History, having majored in Middle East Studies and minored in Diplomatic History.

Captain McMunn received his commission through the Aviation Officer Candidate School at Pensacola, Florida in 1963. After attending the Air Intelligence School at the Fleet Operational Intelligence Center, Pacific; in Alameda, California, he served as the Air Intelligence Officer in Air Anti-Submarine Warfare Squadron Twenty One (VS-21), deploying to the Western Pacific in 1964 and 1966. He then completed the career level Intelligence Course at the Defense Intelligence School in Washington, D.C., graduating with distinction in 1967. Captain McMunn subsequently served as a Naval Intelligence Officer on the staff of the Commander, Middle East Force, homeported in Manama, Bahrain and operating throughout the Indian Ocean area. His next assignment took him to Bremerhaven, Germany, as the Deputy Commander of a Naval Intelligence Task Unit (CTU 157.2.2) with responsibilities in Northern Europe. As the Fourth Riverine Intelligence Officer, Captain McMunn commanded U.S. Naval intelligence Operations and headed the Naval Advisory Group intelligence effort in the Mekong Delta in 1971-72. He was then designated a Career Area and Regional Specialty Officer (CARSO) candidate and attended the Middle East Studies curriculum at Georgetown University and the Hebrew language course at the Foreign Service Institute prior to serving as the Assistant Naval Attache in Tel Aviv, Israel. Captain McMunn next moved to Naples, Italy, serving as the Intelligence Officer to the Commander of the Surveillance and Reconnaissance Force, Sixth Fleet (CTF-67) and the Commander, Fleet Air Mediterranean. His next assignment as Intelligence Officer for the Commander of Carrier Group Six took Captain McMunn on Battle Group deployments to the North Atlantic, the Mediterranean, the Indian Ocean and the Caribbean. Since October 1982, he has served at the Navy Operational Intelligence Center in Suitland, Maryland, and in the Soviet Doctrine, Policy and Strategy Division of the OPNAV Staff and as the Executive Assistant to the Director of Naval Intelligence. He is currently serving at the White House on the staff of the Executive Director of the Vice President's Task Force on Combatting Terrorism.

Captain McMunn is married to the former Susan Anne Fowler of Sewickley, Pennsylvania. They have a son, Ensign David J. McMunn, III, USN, and two daughters: Maura Leign and Caitlin Elizabeth. Captain McMunn is an active member of the Middle East Institute and the U.S. Naval Institute. In addition to his professional interests, he is a certified (YMCA) scuba instructor, enjoys a variety of racquet sports, and is an avid "sports fan."

Lt. Col. Daly was born on 6 March 1943 in Portland, Oregon. Upon graduation in 1965 from the University of Portland with a BA in Political Science, he was commissioned a Second Lieutenant in the U.S. Air Force.

He attended pilot training in 1966 at Williams AFB, Arizona.

From 1967 to 1973 Lt. Col. Daly served as a B-52 instructor pilot at Fairchild AFB, Washington. During this period he flew eight operation ARC LIGHT tours in Vietnam for a total of 365 combat missions.

From 1973 to 1976 Lt. Col. Daly instructed in the B-52 Combat Crew Training Squadron at Castle AFB, California. In 1976 he was selected in the initial cadre of the Central Flight Instructor Course also at Castle. He was appointed chief of the B-52 Division in 1978.

Lt. Col. Daly was assigned to the Directorate of Operations, Headquarters USAF, the Pentagon in 1979. In 1980 he was appointed as Chief, Contingency Operations and Exercise Division and served in this capacity until 1985. During this period Lt. Col. Daly's duties included the JCS and USAF Crises Staffing Procedures, the HQ USAF Contingency Support Staff, the JCS and USAF Exercise Programs, USAF Wargaming, Exercise Airspace, Non-Combatant, Evacuation Operations and the USAF Combatting Terrorism Center. Participation in Contingency operations have included: RUBBER WALL Lebanon resupply, ARID FARMER Operations in Sudan, ELF ONE operations in Saudi Arabia, EAGLE LOOK Operations in Egypt, the Beirut bombing, INTENSE LOOK the Red Sea mining, URGENT FURY operations in Grenada, operations in Central America, and ELOQUENT RIDE the hijacking of TWA 847. ✓

His decorations include the Distinguished Flying Cross with one oak leaf cluster, two Meritorious Service Medals and 16 Air Medals.

LIEUTENANT COLONEL ROBERT L. EARL, USMC

Lieutenant Colonel Earl is assigned to the Advanced Amphibious Study Group located at the Marine Corps Development and Education Command, Quantico, Virginia.

Lieutenant Colonel Earl was born on 13 November 1945 in Norristown, Pennsylvania. He graduated from the US Naval Academy and was commissioned in the Marine Corps in June of 1967.

Second Lieutenant Earl was a summer intern in the East Asia, Regional Affairs bureau of the Department of State prior to reporting to The Basic School at Quantico in September of 1967. After completing training at Quantico Lieutenant Earl became a reconnaissance platoon commander in the 5th Marine Division at Camp Pendleton, California.

In October 1968 Lieutenant Earl attended Oxford University in England as a Rhodes Scholar, studying Philosophy, Politics, and Economics (BA/MA degrees).

Returning to the United States in the summer of 1971, Captain Earl reported to the 2d Marine Division at Camp Lejeune, North Carolina where he served as Division Education Officer; as Operations Officer (initially as S-3A and later as the S-3) of the 2d Battalion, 2d Marines during a deployment aboard ship to the Mediterranean Sea; and as Commanding Officer of Company B, 1st Battalion, 2d Marines. In 1973 he became a student at the Amphibious Warfare School at Quantico.

Departing the United States again, Captain Earl joined the 3d Reconnaissance Battalion in Okinawa, serving as battalion operations officer (S-3) and as a reconnaissance company commander. He continued in the reconnaissance field upon his return to Quantico in 1974 with assignment as the amphibious reconnaissance project officer and the remote ground sensor project officer in the Development Center.

After three years in research and development Captain Earl became the Assistant National Intelligence Officer for the Near East and South Asia at CIA. Promoted to Major, he then became a student at the Marine Corps Command and Staff College in Quantico.

In June 1981 Major Earl reported to the 1st Marine Brigade in Hawaii, where he served in a variety of billets including infantry battalion executive officer, regimental operations officer (S-3), brigade operations officer (G-3 Ops), and infantry battalion commanding officer. During this three-year FMF tour Lieutenant Colonel Earl conducted two deployments to the Indian Ocean with the 31st Marine Amphibious Unit. From August 1984 until June 1985 Lieutenant Colonel Earl attended the Naval War College at Newport, Rhode Island.

Lieutenant Colonel Earl's decorations include the Navy-Marine Corps Medal, the Meritorious Service Medal, and a Meritorious Unit Citation.

He is married to the former Linda Joy Cadman of Bellingham, Washington. They live in north Arlington, Virginia with their son, Lawson.

CAPTAIN DAVID J. MCMUNN, USN

Biography

Captain McMunn was born in Pittsburgh, Pennsylvania on 16 July 1941. In 1963, he graduated from St. Vincent College in Latrobe, Pennsylvania, earning a Bachelor of Arts (BA) degree after majoring in Biology. He later attended Georgetown University in Washington, D.C., and received his Master of Arts (MA) in History, having majored in Middle East Studies and minored in Diplomatic History.

Captain McMunn received his commission through the Aviation Officer Candidate School at Pensacola, Florida in 1963. After attending the Air Intelligence School at the Fleet Operational Intelligence Center, Pacific; in Alameda, California, he served as the Air Intelligence Officer in Air Anti-Submarine Warfare Squadron Twenty One (VS-21), deploying to the Western Pacific in 1964 and 1966. He then completed the career level Intelligence Course at the Defense Intelligence School in Washington, D.C., graduating with distinction in 1967. Captain McMunn subsequently served as a Naval Intelligence Officer on the staff of the Commander, Middle East Force, homeported in Manama, Bahrain and operating throughout the Indian Ocean area. His next assignment took him to Bremerhaven, Germany, as the Deputy Commander of a Naval Intelligence Task Unit (CTU 157.2.2) with responsibilities in Northern Europe. As the Fourth Riverine Intelligence Officer, Captain McMunn commanded U.S. Naval intelligence Operations and headed the Naval Advisory Group intelligence effort in the Mekong Delta in 1971-72. He was then designated a Career Area and Regional Specialty Officer (CARSO) candidate and attended the Middle East Studies curriculum at Georgetown University and the Hebrew language course at the Foreign Service Institute prior to serving as the Assistant Naval Attache in Tel Aviv, Israel. Captain McMunn next moved to Naples, Italy, serving as the Intelligence Officer to the Commander of the Surveillance and Reconnaissance Force, Sixth Fleet (CTF-67) and the Commander, Fleet Air Mediterranean. His next assignment as Intelligence Officer for the Commander of Carrier Group Six took Captain McMunn on Battle Group deployments to the North Atlantic, the Mediterranean, the Indian Ocean and the Caribbean. Since October 1982, he has served at the Navy Operational Intelligence Center in Suitland, Maryland, and in the Soviet Doctrine, Policy and Strategy Division of the OPNAV Staff and as the Executive Assistant to the Director of Naval Intelligence. He is currently serving at the White House on the staff of the Executive Director of the Vice President's Task Force on Combatting Terrorism.

Captain McMunn is married to the former Susan Anne Fowler of Sewickley, Pennsylvania. They have a son, Ensign David J. McMunn, III, USN, and two daughters: Maura Leign and Caitlin Elizabeth. Captain McMunn is an active member of the Middle East Institute and the U.S. Naval Institute. In addition to his professional interests, he is a certified (YMCA) scuba instructor, enjoys a variety of racquet sports, and is an avid "sports fan."
