Attached is a draft summary schedule.

Event Concept

On Thursday, November 21, 1985, on the return to Washington, D.C. from Geneva, Switzerland, The President and Mrs. Reagan will make a brief stopover in Brussels, Belgium, where The President will consult with our Allies in NATO on the outcome of the Reagan/Gorbachev meetings. The stop will do much to further our relations with our alliance partners.

The Special Mission was very conscious of the tight time constraints that will be placed on the Brussels visit due to the lengthy travel time involved that day and the Joint Session of Congress Address at the conclusion of the trip; therefore, we recommend the following brief scenario.

The President and Mrs. Reagan will arrive at Brussels Airport at approximately 3:30 p.m., where they will participate in a brief arrival ceremony with the King and Queen of Belgium. The President will hold a five minute tete-a-tete with the King and then be joined by the Prime Minister and Foreign Minister of Belgium and their U.S. counterparts for an additional five minutes.

The President will then depart for the NATO Headquarters building, arriving at 4:00 p.m. We have proposed a brief handshake reception with all attending Heads of Government and a "class photo". At approximately 4:15 p.m., The President will participate in a 90 minute consultative meeting with our NATO Allies in a Special Meeting of the North Atlantic Council. Currently, as many as ten leaders (out of sixteen total) have accepted the invitation to attend and it is expected that at least four to five more will accept in the near future. The Special Session will conclude at 5:45 p.m. and The President and Mrs. Reagan will depart Brussels, Belgium at 6:00 p.m., arriving at Andrews Air Force Base at 8:30 p.m. EST. This will allow enough time for The President and Mrs. Reagan to arrive at The U.S. Capitol and be in place for an Address to a Joint Session of Congress and the Nation at 9:05 p.m.

Please note that Mrs. Reagan's participation and schedule during the Brussels stop is still to be determined, but the Queen has offered to host a tea for Mrs. Reagan at Laaken Palace, the residence of the King and Queen.

QUESTIONS/OPTIONS

1. As a result of consultations with U.S./NATO staff, it is our recommendation that the format for the special session of the NATO Council be structured so as to utilize a horseshoe table configuration that seats only the Heads of Government/Delegation that will be present from each country. The balance of each of the delegations would sit behind their leaders, with the U.S. entitled to six seats and the others entitled to four.

Another option for the session would be to expand it dramatically by configuring the seating so that each country would have three seats at the table, including a Head of Government/Delegation plus two others (Foreign Minister and Permanent Representative to NATO). It is the Special Mission's recommendation that we not choose this option, as it takes the emphasis away from the Heads of Government at the table. Further, it is our assessment that the visual of The President seated next to another Head of Government only (it would be Mrs. Thatcher) is much better and that this smaller arrangement is more manageable from a time standpoint.

3. Realistically reviewing the schedule for Brussels, Belgium, I believe it will be necessary to buy 20-30 minutes more time in Brussels. It is my assessment that the 90 minute Special Meeting of the North Atlantic Council may not be accomplished in 90 minutes. The proposed format is The President giving an approximately 15 minute report on his Geneva meetings and then each country (15) being given 5 minutes to respond.







MEETING WITH SOVIET LEADER IN GENEVA: THEMES AND PERCEPTIONS (U)

It is important that all agencies have a clear understanding of what I consider key themes that need to be emphasized as we approach my November 19-20 meetings with General Secretary Gorbachev. I will be emphasizing the opportunity that the Geneva meetings provide to address a variety of important issues in a businesslike and constructive manner. For their part, the Soviets are trying to focus public attention almost exclusively on arms control, particularly my strategic defense initiative, while virtually ignoring a host of regional and bilateral issues that separate us. (S)

To help ensure that my message reaches as wide an audience as possible, I urge all government officials who will be discussing the Geneva meetings in public forums to draw from the attached themes and perceptions. (S)

Themes and Perceptions for Public Presentation

Theme:

BUILDING A SAFER WORLD

Basic Messages:

-- We want countries to stop trying to expand their influence through armed intervention and subversion.

That is why we are proposing negotiated settlements, withdrawal of outside forces, and international efforts to build economies and meet human needs.

-- We have the mandate and opportunity to reduce the danger of nuclear war by drastic cuts in nuclear arsenals.

That is why we are proposing radical, verifiable and balanced reductions of offensive nuclear weapons and are pursuing research to identify defensive technologies - which threaten no one.

-- We must <u>defend human rights</u> everywhere, since countries which respect human rights are unlikely to unleash war.

That is why we insist that the Helsinki accords and other international commitments be observed.

-- We must <u>establish better communication</u> between our societies, since misunderstandings make the world more dangerous.

That is why we are proposing dramatic increases in people-to-people exchanges, programs to share information, and enhanced cooperation in meeting human needs.

-- The meeting in Geneva marks a new phase in this process.
Our efforts to reach these ambitious goals will continue.

PERCEPTIONS OF THE GENEVA MEETING

Working for a Safer Future

The President seeks to build the foundation for peaceful and constructive relations with the Soviet Union. This will require a long-term, sustained effort. It must be based on the principles of fairness, reciprocity and honest fulfillment of all agreements.

Soviet Behavior: The Roots of Tension

The use or threat of force by the Soviet Union and its proxies is an underlying cause of Soviet-American and world tension. The President is determined to defend the United States and its Allies. The USSR must cease using arms and force to expand its influence if tensions are to diminish.

Leading from Strength

The President's hand is strong: he has reversed the decline in American strength and has a robust economy, a united public and strong alliances behind him. He is able to defend us whatever the Soviets do. But he wants more: he wants to lower arms levels, reduce tensions and create a more cooperative relationship with the USSR.

Promoting Democratic Ideals

The President will speak out for democracy, freedom, justice and decency everywhere since these values are the surest foundation of a just and peaceful world in the future. He does not attempt to impose our political or economic system on others, but will insist that the Soviet Union also refrain from attempts to dominate others.

Probing Soviet Intentions

We can have a more cooperative relationship with the Soviet Union only if the Soviet leaders also want it. The Geneva meeting will determine whether there has been a change in Soviet policy or only in Soviet style.

Realistic but Determined Effort

The President is preparing seriously for the meeting in Geneva. He has no illusions about the profound differences in our philosophies and societies but will go the extra mile for enduring peace and a safer world. He will bring creative and ambitious ideas to the meeting. His efforts will not end when the Geneva meeting is over. He is in this for the long haul.

2. BEGIN TEXT: THE PRESIDENT, AS YOU KNOW, ATTACHES GREAT IMPORTANCE TO THE CLOSE CONSULTATION WITH OUR ALLIES IN CONNECTION WITH THE UPCOMING GENEVA MEETING WITH GENERAL SECRETARY GORBACHEV, AS EVIDENCED BY HIS MEETING IN NEW YORK AND HIS CONSULTATIONS.

THE PRESIDENT, AT THE OUTSET OF HIS MEETING ON THURSDAY IN NEW YORK, OFFERED TO THE FOUR NATO LEADERS WITH WHOM HE WAS CONSULTING TO ATTEND A SPECIAL SESSION OF THE NORTH ATLANTIC TREATY COUNCIL AT -- NORTH ATLANTIC COUNCIL AT NATO HEADQUARTERS ON NOVEMBER 21. HE ASKED NATO GENERAL SECRETARY CARRINGTON THAT EVENING TO CONSULT WITH THE ALLIANCE ON SUCH A MEETING. THE PURPOSE OF THE MEETING WOULD BE TO ENABLE THE PRESIDENT TO PROVIDE AN IMMEDIATE

AND FIRSTHAND BRIEFING ON HIS MEETING WITH GENERAL SECRETARY GORBACHEV AND TO CONSULT WITH THE ALLIES ON EAST-WEST RELATIONS.

LORD CARRINGTON'S CONSULTATIONS WITH OTHER MEMBERS OF THE ALLIES ARE STILL PENDING AND WE HAVE NOT RECEIVED A FINAL STATEMENT FROM HIM ON THE SUBJECT. HOWEVER, THE FOUR THAT HE CONSULTED WITH IN NEW YORK WERE ENTHUSIASTIC THAT SUCH A REPORTING MEETING SHOULD TAKE PLACE.
