The Frank,

This is just a note to tell you that I found the July briefing book a significant improvement over those that have been prepared previously. I would appreciate it if you would extend my thanks to those who did all of the hard work to prepare it.

I have a minor suggestion for the future. In addition to the regular briefings we provided to Johnson for four years, I had Henry or Dick Helms keep him informed on a personal basis of any significant development that occurred between briefing books. That way he was able to be prepared in advance for any questions that might arise asking for his reactions to Administration initiatives or foreign policy developments. You obviously would have a problem here of possible leaks of timely material, but when you feel you can pass on such information, you can be sure that it will be closely held. Unlike you and other members of the White House staff, I do not have to talk to the press!
