While talking to Deane Hoffman about CIA analysis of potential US/USSR grains sales, he mentioned that he checked out your report of last week that the Soviets might be planning a broad economic initiative. He checked with his experts, who had two reactions: 1) The source isn't great, and 2) Such an initiative would only be likely as part of a broader effort that would include arms control, etc., in which case the economic dimension would get lost in the shuffle.
