BOB HAWKE TOLD REPORTERS.

ASKED IF HE EXPECTED REAGAN TO VETO THE PROPOSAL, HAWKE
REPLIED: "YES, I WOULD HOPE SO."

WHEAT EXPORTS TO THE SOVIET UNION AND CHINA FROM AUSTRALIA IN
1985 AMOUNTED TO +420 MILLION. THE UNITED STATES HAS ALREADY
SOLD SUBSIDISED WHEAT TO AUSTRALIA'S MAJOR CUSTOMERS IN THE
MIDDLE EAST.

HAWKE SENT A STRONG LETTER OF PROTEST TO REAGAN EARLIER THIS
WEEK AND FOREIGN MINISTER BILL HAYDEN SAID HE WOULD RAISE THE
SUBJECT WITH SECRETARY OF STATE GEORGE SHULTZ DURING DEFENSE
TALKS IN SAN FRANCISCO NEXT MONTH.

HOWEVER, HAYDEN MADE IT CLEAR U.S. DEFENSE FACILITIES IN
AUSTRALIA WOULD NOT BE USED AS A BARGAINING CHIP.

HAYDEN'S STATEMENT FOLLOWED AN ANGRY OUTBURST ON THE WHEAT
ISSUE BY TREASURER PAUL KEATING WHO SAID AUSTRALIA "... OUGHT
TO USE WHATEVER INFLUENCE WE CAN ON THE U.S. ADMINISTRATION AND
WE WILL."

THE UNITED STATES HAS PASSED LEGISLATION CALLING FOR THE WIDENING

BIGGEST WHEAT MARKETS. THE TWO MARKETS ARE WORTH +700 MILLION
(AUSTRALIA DOLLARS -- FBIS) A YEAR TO AUSTRALIAS WHEAT FARMERS.

THE PRIME MINISTER, MR HAWKE, HAS CALLED ON PRESIDENT REAGAN TO
VETO THE SENATE DECISION. MR HAWKE SAYS THE SUBSIDY WILL HAVE A
DEVASTATING IMPACT ON AUSTRALIAS RURAL INDUSTRY. AS WELL, THE
FOREIGN AFFAIRS MINISTER, MR HAYDEN, SAID THE AMERICAN MOVE WOULD
PUT GREAT PRESSURE ON THE PRICE AUSTRALIAN FARMERS GOT FOR THEIR
GRAIN.

(BEGIN HAYDEN RECORDING) WE ARE GRAVELY CONCERNED ABOUT THIS
LATEST DEVELOPMENT. IT IS PUTTING GREAT PRESSURE ON THE PRICE WE
HAVE BEEN ABLE TO GET FOR OUR GRAIN PRODUCTS, AND THAT MEANS WITH A
SERIOUS TRADE ACCOUNT AND CURRENT ACCOUNT PROBLEM, WE ARE NOT
GETTING THE SORT OF INCOME WE MIGHT OTHERWISE GET. NOW, THESE ARE
THE THINGS WE ARE GOING TO MAKE QUITE CLEAR TO AMERICA. WE HAVE
MADE THEM CLEAR, BUT WE WILL HAVE TO MAKE THEM EVEN CLEARER.

(QUESTION FROM UNIDENTIFIED REPORTER) YOU ARE DISCUSSING THE
ALLIANCE WITH MR SHULTZ IN A FORTNIGHT. WILL YOU BE RAISING THIS IN
THAT CONTECT?

(HAYDEN) YES. WE HAD QUITE A CANDID EXCHANGE IN MANILA ON THIS.
I FEEL VERY STRONGLY ABOUT IT, AND ON THESE SORTS OF THINGS I AM NOT
TERRIBLY NOTABLE FOR SUBTLETY. AND WE HAVE A GREAT NATIONAL
INTEREST TO LOOK AFTER, AND I REMINDED THE AMERICANS THAT WE ARE
GOOD FRIENDS, AND GOOD FRIENDS EXPECT TO BE TREATED IN A DIFFERENT

(TEXT) CANBERRA, JULY 24 (AFP) -- THE GOVERNMENT SAID THURSDAY
IT WAS PREPARED TO EXAMINE THE FUTURE OF U.S. BASES IN AUSTRALIA
IF

WASHINGTON WENT AHEAD WITH THE SALE OF SUBSIDISED WHEAT TO CHINA AND
THE SOVIET UNION.

TREASURER PAUL KEATING TOLD REPORTERS THE GOVERNMENT "OUGHT TO
USE ANY INFLUENCE ON THE U.S. ADMINISTRATION WE CAN AND WE WILL" TO
STOP THE SALES WHICH WOULD HIT AUSTRALIAN WHEAT EXPORTS.

MR KEATING WAS REPLYING TO A QUESTION ON WHETHER THE U.S. BASES
IN AUSTRALIA SHOULD BE "PLAYED AS A BARGAINING CHIEF" TO PERSUADE
THE WASHINGTON ADMINISTRATION NOT TO PROCEED WITH THE SALES.

THE UNITED STATES MAINTAINS THREE COMMUNICATIONS AND SATELLITE
TRACKING BASES IN AUSTRALIA -- AT PINE GAP AND NURRUNGAR, BOTH IN
CENTRAL AUSTRALIA, AND NORTH-WEST CAPE.

MR KEATING WAS TALKING AFTER PRIME MINISTER BOB HAWKE THURSDAY
CONVENED A MEETING OF HIS SENIOR MINISTERS ON THE PROSPECTIVE U.S.
ACTION, WHICH THREATENS AUSTRALIAN WHEAT SALES TO CHINA AND THE
SOVIET UNION WHICH WERE WORTH 671 MILLION DOLLARS (ABOUT 423 MILLION
U.S.) IN 1984/85.

MR HAWKE TOLD REPORTERS HE ALREADY HAD RAISED THE MATTER WITH
PRESIDENT REAGAN AND WAS HOPING HE WOULD VETO THE MOVE FROM
CONGRESS.

"THIS CAN BE POTENTIALLY VERY VERY DAMAGING, BECAUSE THE SOVIET
UNION AND CHINA ARE THE TWO LARGEST MARKETS FOR AUSTRALIAN WHEAT,"
HE SAID.

"THIS REPRESENTS A FURTHER DEVASTATING IMPACT UPON AN ALREADY
SOVEREIGNLY PRESSED SECTION OF AUSTRALIAN RURAL INDUSTRY," MR HAWKE SAID.

FOREIGN MINISTER BILL HAYDEN SAID HE WOULD RAISE THE WHEAT ISSUE
WITH U.S. SECRETARY OF STATE GEORGE SHULTZ DURING ANZUS DEFENCE
TALKS IN SAN FRANCISCO NEXT MONTH.

ALTHOUGH HE DID NOT EXPECT THE WHEAT ISSUE TO AFFECT THE FORMAL
STRUCTURE OF AUSTRALIA'S ALLIANCE WITH THE UNITED STATES, FRIENDS
"EXPECT TO BE TREATED IN A DIFFERENT SORT OF WAY," HE SAID.

MR KEATING SAID THE U.S. ADMINISTRATION RELIED ON AUSTRALIA FOR
ALL SORTS OF ARRANGEMENTS, AS AN ALLY AROUND THE WORLD, AND NOW IT
WAS CONTEMPLATING TREATING AUSTRALIA SO POORLY.

HE SAID IT WOULD BE A MOST SERIOUS TRAGEDY FOR AUSTRALIA IF THE
U.S. CONGRESS IN THE ABSENCE OF A PRESIDENTIAL VETO WERE TO
SUBSIDISE WHEAT SALES INTO AUSTRALIA'S LARGEST MARKETS.

IF THE SUBSIDIES WENT AHEAD IT WOULD DEMONSTRATE CLEARLY WHY
AUSTRALIA WAS EXPERIENCING INTERNATIONAL TRADING DIFFICULTIES IN THE
ABSENCE OF "SOME BOUYANCY IN THE WORLD ECONOMY."

"THE COMMODITIES WE SELL ARE THE ONES WHICH HAVE FOR ALL SORTS
OF REASONS BEEN SIMULTANEOUSLY HIT AND IN WHEAT TO HAVE THAT SORT
OF

SUBSIDISATION GOING INTO OUR MARKETS WOULD BE A GREAT BLOW TO
AUSTRALIAN AGRICULTURE, THE AUSTRALIAN WHEAT INDUSTRY, THE
AUSTRALIAN BALANCE OF PAYMENTS AND THE AUSTRALIAN CURRENT ACCOUNT,"
HE SAID.

MR KEATING SAID THE INTERESTS OF THE WORLD WERE BEST ADVANCED BY
A FREE AND OPEN MULTILATERAL TRADING SYSTEM.

HE SAID THE SUBSIDISATION POLICIES OF THE UNITED STATES AND THE
EUROPEAN ECONOMIC COMMUNITY WOULD PULL THEIR STANDARDS OF LIVING

DOWN.

IN THE MEANTIME COUNTRIES LIKE AUSTRALIA, A FAIR AND OPEN TRADER, WOULD EXPERIENCE ACUTE PROBLEMS WHICH WOULD FORCE THE GOVERNMENT TO SLOW THE RATE OF ECONOMIC GROWTH.

THIS WAS A MESSAGE THAT WOULD HAVE TO BE RAMMED HOME VERY HARD TO THE U.S. ADMINISTRATION, MR KEATING SAID.


