2. AS REPORTED TO THE WORKING GROUP BY TELCON, THE SWISS EMBASSY IN TEHRAN HAS MADE ARRANGEMENTS FOR THE BODIES OF THE TWO DECEASED AMCITS TO BE FLOWN OUT OF TEHRAN VIA LUFTHANSA FLIGHT 601 (SIX-ZERO-ONE) ON DECEMBER 11 (ELEVEN), ETD TEHRAN 10:10, ETA FRANKFURT 14:55. THE COFFINS ARE ADDRESSED TO THE 97TH ARMY REGIONAL MEDICAL CENTER FRANKFURT, AIRWAY BILL AS YET UNKNOWN. THERE WILL BE A "DEATH PASSPORT" ON EACH COFFIN. THE COFFINS WILL BE LOCKED AND THE PILOT WILL HAVE THE KEYS. THE SWISS WILL CONFIRM THE DEPARTURE OF THIS FLIGHT WITH THE COFFINS ASAP DECEMBER 11.

3. IN VIEW THAT THE TWO SURVIVING AMERICAN CITIZENS WERE NOT ON THE PAKISTANI FLIGHT TO KARACHI, SPP TEHRAN IS DOING ALL POSSIBLE TO ARRANGE THE FIRST FLIGHT OUT FOR BOTH KAPAR AND COSTA. THEY ARE ATTEMPTING TO MAKE ARRANGEMENTS FOR DEPARTURE ON THE SAME LUFTHANSA FLIGHT TO FRANKFURT ON DECEMBER 11. SHOULD THE KUWAITI FLIGHT WITH A MEDICAL TEAM BE SENT TO TEHRAN TO ALLOW DEPARTURE ON/ABOUT SAME TIME AS THE LUFTHANSA FLIGHT,
