SUBJECT: Memorandum of Conversation with Kurt Lohbeck

Attached at Tab I is a Memorandum of Conversation that Judyt Mandel and I had with Kurt Lohbeck. The noteworthy thing in this memorandum is that Lohbeck was quite disturbed by the scorched earth policies being followed by the Soviets in Eastern Pakistan. He also expressed concern about increased Pakistan obstacles that were confronting Western journalists and the Mujeheddin.
