Enclosed are a few copies of Soviet ID's and papers which I collected from various Afghan sources during my recent trip to Peshawar. It became apparent that there is no concerted USG effort to arrange for the methodical collection of this type of information from the battlefield for use in a psycological warfare campaign against the USSR.

The dissemination of casualty information to the Soviet people will have a devastating effect inside the USSR which will lead to increased popular agitation against the conscription and continued sacrifice of Soviet youth resulting from the actions of Soviet combat forces inside Afghanistan.

One method of dissemination of this information to the Soviet people on a continuous basis would be via radio broadcasts by RFE/RL or other shortwave or medium wave stations to the USSR.



Khalilzad to Pakistan

Per our previous discussion, Zalmay Khalilzad of my staff is interested in traveling to Pakistan. As described in the attached memo, he has been invited for discussion of "regional issues" with the senior Pakistani leadership.

Khalilzad does seem to have special access given his background, and I believe such a trip could be valuable to our capacity to assess regional developments. His trip, however, could be unsettling to either your efforts or those of NEA, and I would not recommend his travel if it would cause folks problems. On the other hand, I believe he would be a responsible representative of the Department and would report his findings fully, apart from the analytical benefits to be gained.

An alternative to his traveling alone would be for him to accompany you on your trip to Pakistan in early April.

Please give me your judgment.

SUBJECT: Visit to Pakistan

The Pakistani Consul General in New York, Mr. Ali, called me on March 26. He said that he had been contacted by Mr. Fatemi from Foreign Minister Yaqub Khan's Office in Islamabad "suggesting" whether it would be possible for me to visit Pakistan during the last week of April. According to Ali, should I decide to do so, I will be meeting with President Zia, Prime Minister Junijo and Foreign Minister Yaqub. The reason for the choice of the date is that the Pakistanis would like the meeting to take place prior to the next and perhaps final round of the Geneva talks on Afghanistan. According to Ali the subject his superiors want to discuss with me will be Afghanistan and "related regional issues."

It appears to me that for several reasons it might be a good idea to take the Pakistanis up on this:

- 1. As the Pakistanis prepare for the next and perhaps decisive round of the Geneva talks it can be very useful for us to know more on what they are considering and whether their position on key issues is changing. Some of us suspect that Islamabad might be changing its negotiation policies in ways which are detrimental to our interests.
- 2. There may be some uncertainty among the Pakistani leaders whether an agreement with the Kabul government which in part might result form changes in the Pakistani position will lead to a workable solution. They might want the assessment of some of the people whose views they take seriously on the viability of a possible arrangement. This could be the reason why they are expressing an interest in talking with me. If this is the case, it will provide us with a unique opportunity to perhaps influence the internal discussion among Pakistani officials.
- 3. I want to go to the area at some point in the near future in any case. However, if I do it at the time suggested by the GOP it will provide unusual access which might not be available at a later day.
- 4. It is clear that should I go to Pakistan, I will work closely with our Embassy in Islamabad.
