

SUBJECT: PCG Meeting on Counterterrorism Finding (S)

At the Planning and Coordination Group (PCG) meeting held August 1, 1985 to consider the CIA draft Finding on Counterterrorism it was decided that three changes should be made. An amended draft incorporating the agreed textual revisions is attached for your concurrence. The change made to the language of the fourth paragraph of the Finding differs slightly from the language endorsed by the PCG principals. The sentence was adjusted to reflect that U.S. Law is specified rather than foreign law. This addition has been agreed to by CIA's General Counsel and is believed to conform to the spirit of the original objection posed by the Department of State. (TS/V)

Concurrence to the revised draft is requested no later than August 7 close of business. (S)


