PURPOSE I.

- (7) Receiving line: Photo opportunities with appointees and families.



SUGGESTED REMARKS: STAFF SWEARING IN -- JANUARY 21, 1981





TALKING POINTS: OPENING THE CABINET MEETING -- JANUARY 21, 1981

- 1) As you know, Yesterday I ordered a strict freeze on the HIRING of Federal civilian employees to be applied across the board in the Executive branch.
- 2) Today, I want to underscore directly to each of you the importance of this action. We must regain control of the Federal budget which has increased by about \$100 billion in the past fiscal year alone.
- This hiring freeze, with its rare and unusual exemptions, is a first step in the long process back to restoring our economic strength.
- 4) As I said yesterday, we will move by inches and feet in this struggle against our economic problems, but that we would move.
- OUR CITIZENS HAVE GROWN IMPATIENT WITH THE FAILURE TO TAKE ACTION. THUS, I WANT EACH OF YOU TO GIVE YOUR DIRECT, PERSONAL ATTENTION TO THIS DIRECTIVE. BEFORE LONG, I WILL EXPECT REPORTS THAT WE ARE MAKING SOLID PROGRESS.

Your Courtesy Telephone Calls Today to Heads of Allied Governments (All Economic Summit

Countries Plus Mexico later)

I have obtained from the State Department talking points for your courtesy calls to heads of Allied governments. I suggest the calls be made in the following order:

Calls/will be placed on your behalf at 3:30 p.m. our 1. time/to:

> Prime Minister Pierre Trudeau of Canada (Talking Points at Attachment 1)

> Prime Minister Arnaldo Forlani of Italy (Talking Points at Attachment 2)

/Prime Minister Margaret Thatcher of the United Kingdom (Talking Points at Attachment 3)

Prime Minister Valery Giscard d'Estaing of France (Talking Points at Attachment 4)

- You will receive a call from Chancellor Helmut Schmidt 2. at 5:00 p.m. our time (NOTE: Schmidt will have just completed meeting former President Carter in Frankfurt (flying down from Bonn for this purpose). (Talking Points at Attachment 5)
- A call will be placed on your behalf to Prime Minister 3. Suzuki Metween 7:00 p.m. and 7:30 p.m. (8:00 a.m. to 8:30 a.m. in the morning Tokyo time). (Talking Points at Attachment 6)

The other call -- to President Jose Lopez Portillo of Mexico -will be made later in the week due to the fact that he will not be in Mexico City this afternoon.

CANADA - PRIME MINISTER PIERRE TRUDEAU

- -- I look forward to getting to know you, and to working with you on the difficult problems both our nations face.
- -- Our countries share an historic friendship. Given our interdependence today in trade, defense, energy, environment and other areas, it is essential that we consult closely on bilateral and world issues.
- -- I attach great importance to close and productive relations between the U.S. and Canada. Cooperation between our countries will be a high priority for my Administration.
- -- I know our representatives are in touch concerning an early visit by me to Canada. I look forward to that meeting.
- -- (IF APPROPRIATE) Now that our American hostages are on their way home, I want you to know how much we appreciate everything you and your government have done, and the support of the Canadian people.

ITALY - PRIME MINISTER ARNALDO FORLANI

- -- I am calling you this first full day in office to tell you that my Administration intends to consult closely and regularly with friends such as Italy.
- -- This is more than a symbolic gesture. This is a commitment to a constructive and cooperative relationship between our two countries as we together face the challenging years ahead.
- -- Because of our common heritage and shared values the people of our two great nations are very close. It is our responsibility to see that the relationship between our two governments is similarly close and cordial. I want to assure you that I intend to do my part in the years ahead.
- -- (IF APPROPRIATE) Now that our American hostages are on their way home, I want you to know how much we appreciate everything you and your government have done, and the support of the Italian people.

MEG. MASIFYFOR

UNITED KINGDOM - PRIME MINISTER MARGARET THATCHER

- -- As I take office, I wanted to call you to emphasize the importance I attach to the relationship between our two countries. More personally, I want you to know how much I appreciate your message of congratulations.
- -- I hope to work closely with you to continue and to expand our cooperation which is so fundamental to the security of free peoples everywhere.
- -- Nancy and I are especially looking forward to welcoming you to Washington next month. (The Prime Minister will make an official visit to Washington, February 25-28.)
- -- I will want to hear your thoughts on international issues as well as some of the economic problems we face together.
- -- (IF APPROPRIATE) Now that our American hostages are on their way home, I want you to know how much we appreciate everything you and your government have done, and the support of the British people.

FRANCE - PRESIDENT VALERY GISCARD D'ESTAING

- -- I hope this will be the first of many such telephone conversations between us.
- -- I firmly believe the relationship between France and the United States is vital for both countries. Moreover, a close and cooperative relationship between our two countries is of central importance to the security of the Western world.
- -- I am delighted that the Franco-American relationship is prospering, and I pledge myself to a constant effort to improve it further during my years as President.
- -- Although I believe frequent telephone conversations are useful -- even indispensable -- they are not an adequate substitute for regular face-to-face conversations. I therefore look forward to an early opportunity to meet and talk with you.
- -- In the interim, I will welcome the opportunity presented by your Foreign Minister's visit next month to open the dialogue between us (Foreign Minister François-Poncet will pay an official visit February 21-23).
- -- (IF APPROPRIATE) Now that our American hostages are on their way home, I want you to know how much we appreciate everything you and your government have done, and the support of the French people.

FEDERAL REPUBLIC OF GERMANY - CHANCELLOR HELMUT SCHMIDT

- -- As I assume office, I want to express my intention to work closely with you on the issues we jointly face, including the strategic challenges and the difficulties in the world economic situation.
- -- Building upon the close ties between our governments and peoples, I am certain that we will meet these challenges.
- -- Al Haig has told me of Foreign Minister Genscher's tentative plans for a visit in March. I will look forward to meeting with him.
- -- I am confident of our future and look forward to close and friendly cooperation with you and with the Federal Republic.
- -- (IF APPROPRIATE) Now that our American hostages are on their way home, I want you to know how much we appreciate everything you and your government have done, and the support of the German people.

JAPAN - PRIME MINISTER SUZUKI

- -- Tell Prime Minister Suzuki that you and your Administration look forward with pleasure to working with him and with his Government.
- -- Express the view that the alliance between Japan and the United States is the cornerstone of our policy in Asia and your intention to work to strengthen it across the board.
- -- Tell Prime Minister Suzuki that Japan's support during the Iranian hostage crisis, taken at some risk, was greatly appreciated.
- -- Note that problems are bound to arise in a relationship such as ours, but these can be solved between friends.
- -- Assure Prime Minister Suzuki of our intention to consult closely with his Government on all matters of mutual interest.
- -- Express your hope that it will be possible to meet personally as soon as possible.


SUGGESTED REMARKS -- INAUGURAL COMMITTEE RECEPTION -- JANUARY 21, 1981

But on a more personal level -- for Nancy and me -- there are some other very special people whose spirit has made the past few days the very best of our lives.


