I. PURPOSE

To solidify Congressman Pursell's support for the Conable-Hance II tax bill and to ask for his help with Northeast-Midwest Republicans.

II. BACKGROUND

Carl Pursell has been very active in the Northeast-Midwest Coalition. Consequently, he has been out-front on behalf of those who are concerned about the adverse impact that the President's economic package might have on the older, industrialized regions of the country.

Pursell is very aware of the objections raised by many Northeast-Midwest Republicans concerning the oil provisions that were added to the Conable-Hance II bill. He can be very helpful with that group of Republicans that have been uncomfortable with many aspects of the President's program.

This meeting will provide an opportunity for the President to strongly reassure Pursell that he is committed to this nation's economic recovery and that the urban areas of the Northeast and Midwest are the key to any sustained economic turnaround.

SUGGESTED TALKING POINTS FOR MEETING WITH CONGRESSMAN CARL PURSELL (R-MICH)

- -- Acknowledge his work on behalf of the Northeast-Midwest Coalition.
- -- Emphasize that Conable-Hance II provides the kind of tax relief that is absolutely essential to the economic health of all parts of this nation.
- -- Recognize that some Members of Congress have expressed concern about the oil provisions that were added to the bipartisan tax bill. Stress that the energy provisions added to Conable-Hance II are better tax policy and better energy policy than contained in the Ways and Means Committee bill.
- -- Point out that several provisions in Conable-Hance II are targeted specifically to the concerns of Northeast-Midwest Republicans, i.e., Research and Development credit, energy credit for woodburning stoves, target jobs credit, mass transit industrial development bonds, etc.
- -- Assure Pursell that you are committed to helping the ailing cities of the Northeast and Midwest, and that once your economic package is passed you will target Administration programs to deal with some of the specific problems of that region of the country.
- -- Point out that the Democrats are playing politics as usual, and to be successful you need the solid support of all Republicans on the tax bill, especially the support and leadership of Carl Pursell.

I. PURPOSE

To solicit support for the Conable-Hance bipartisan proposal.

II. BACKGROUND

This group of Democratic Congressmen was selected from among those who either are supporting the original Conable-Hance bipartisan tax proposal, leaning in favor, or undecided. The Democratic leadership of the House has been wooing these Members heavily; and the Democratic Party apparatus has been applying heavy constituent pressures in a number of their Districts.

With the completion of the Ways and Means Committee mark-up and the announcement, on July 24, 1981, of Conable-Hance II, there is now a very clear choice between the two proposals. This meeting will provide the opportunity for the President to firm up support and to try to convince the leaning and undecided to become supporters.

ATTACHMENT A

SUGGESTED TALKING POINTS FOR MEETING WITH SELECTED DEMOCRATIC MEMBERS OF THE HOUSE OF REPRESENTATIVES

- -- Point out that the fundamental difference between the two tax proposals is that the bipartisan plan offers real tax reduction, while the Ways and Means plan allows taxes to continue to increase on the working people of this country.
- -- Stress that the Conable-Hance bipartisan proposal is a permanent tax cut. The Democratic leadership is only offering another make-believe tax cut that dissolves into a huge tax increase.
- -- Emphasize that the bipartisan effort has developed a bill that is best for the country. It provides the kind of tax relief that is absolutely essential to the economic health of this nation.
- -- Note that the driving motive behind the Democratic leadership's bill was, "What can we put together to beat Ronald
 Reagan?". It is merely the same policies of the past which
 promised working people tax cuts which they never saw.

- -- The Ways and Means bill is holding the people's tax cut hostage to future economic events. They give big business a long-term tax break, but won't give individuals a three-year tax cut. We have to provide the certainty and incentives that will help all Americans.
- -- Ask them a simple question...Are they for reducing taxes or increasing them? Stress that you have fought for your economic program because you believe in it -- and you need their help and their vote on the tax bill.

Dan Daniel - D

Virginia, represents the 4th District that includes Portsmouth, Chesapeake, and Suffolk. Daniel was first elected in 1972 and is a member of the Conservative Democratic Forum. He is a member of the Armed Services Committee.

Has voted 100% in favor of the Administration's budget and reconciliation proposals.

<u>Supports the Conable-Hance</u> bipartisan tax package.

Jack Brinkley - D

Columbus, Georgia, west central part of state, 3rd District, 8th term. Fifth ranking Democrat on the Armed Services Committee and Chairman of the Military Installations and Facilities Subcommittee. Third ranking Democrat on the Veterans' Affairs Committee.

Advocate for increased defense spending. District includes Fort Benning, Georgia. Has been a fiscal conservative.

Brinkley voted for final passage of both the budget and reconciliation proposals, but did not support any procedural votes needed by the Administration.

He is undecided about the tax proposals.

Roy Dyson - D

Great Mills, Maryland, 1st District (Eastern Shore), 1st term. Serves on Armed Services Committee. Succeeded Bob Bauman and is influenced heavily by the possibility of a 1982 Bauman-Dyson encounter.

Constituency very supportive of Reagan economic plan. Strong defense influence in District because of defense installations and retired military.

Dyson voted for final passage of both the budget and reconciliation proposals, but did not support any procedural votes needed by the Administration.

He is undecided about the tax proposals.

Bill Nichols - D

Represents the 3rd District of Alabama that extends from the cotton growing black belt in the southern part of the state to the red clay hills of the north. In the south there is Tuskegee, home of Booker T. Washington's Tuskegee Institute, and in the north there is an industrial city, Anniston, and Ft. McClellan. Nichols is serving his 8th term and is on the Armed Services Committee. He is chairman of the Military Personnel and Compensation subcommittee. He is a member of the Conservative Democratic Forum.

Nichols voted totally in favor of the Administration's budget and reconciliation proposals.

He is undecided on the tax bill.

Bob Stump - D

Represents the 3rd District of Arizona (western Arizona), 3rd term. Serves on the Armed Services Committee, the Veterans' Affairs Committee and the Permanent Select Committee on Intelligence. Is a member of the Conservative Democratic Forum.

Voted 100% in favor of the Administration's budget and reconciliation proposals.

Supports the Conable-Hance bipartisan tax package.

Bill Boner

Democrat, Nashville, Tennessee, 5th District (Nashville plus two northern Tennessee counties), 2nd term. Serves on Public Works and Transportation and Veterans' Affairs Committees.


Boner has not voted for the Administration position on any previous vote on the economic package. However, he is undecided about his vote on the tax bill.

Bo Ginn

Democrat. Millen, Georgia (southeast part of the state, including Savannah), 1st District, 5th term. Serves on the Appropriations Committee. Chairman of the Appropriations Subcommittee on Military Construction. Member of the House Conservative Democratic Forum.

Ginn is <u>UNDECIDED</u> on the tax bill vote. He has only voted with the Administration once and is under considerable pressure from the Democratic leadership. However, he has indicated an interest in comparing both of the revised packages prior to voting.

Ginn is seriously considering running for Governor in 1982.

I. PURPOSE

To meet with the new Member of Congress from Mississippi and to encourage his support for the Administration's programs.

II. BACKGROUND

Dowdy was narrowly elected to fill the vacancy created by the resignation of Republican Jon Hinson. Montgomery was a strong supporter of Dowdy against the Republican candidate. Dowdy is a potential "boll weevil" voter who could be as supportive of the President as Sonny Montgomery has been.

Dowdy will be under pressure from the Democrat Party apparatus and liberal constituent groups. He is philosophically receptive to the President's economic package and this meeting will provide an opportunity to establish an ongoing working relationship.

Conable-Hance II contains several provisions that appeal to Dowdy's constituents. Montgomery supports our tax bill and this meeting will provide an opportunity to solicit Dowdy's support.

SUGGESTED TALKING POINTS FOR MEETING WITH CONGRESSMAN WAYNE DOWDY (D-MISS) AND CONGRESSMAN G.V. "SONNY" MONTGOMERY (D-MISS)

- -- Congratulate him on his election victory, recognizing that it was a tough and strongly partisan campaign.
- -- Point out that you have been working closely with members of both parties trying to do what is best for all of the country.
- -- Stress that Sonny Montgomery has been an invaluable ally in your efforts to get your economic package through the Congress.
- -- Emphasize that the Conable-Hance bipartisan proposal is a permanent tax cut. The Democrat leadership is only offering another make believe tax cut that dissolves into a huge tax increase.
- -- Stress that the bipartisan effort has developed a bill that is best for the country and best for Dowdy's Congressional District. It provides the certainty and incentives that will help all Americans.
