I. PURPOSE

To extend a Happy Birthday to Senator John C. Stennis of Mississippi on his 80th birthday.

II. BACKGROUND

Senator Stennis is one of the most highly regarded members of the Senate, where he has served since 1947 -- almost thirty-five years. He was chairman of the Senate Armed Services Committee for the twelve years prior to last January and is an influential member of the Senate Appropriations Committee.

In early 1973, he was shot by a robber outside his home in Washington and has experienced a complete recovery. When you were wounded last March, he expressed a special concern for you, referring to his own experience. When your recovery became apparent, he joked that the two of you should show each other your scars recalling that President Johnson showed the White House Press Corps his scar after undergoing surgery.

Senator Stennis surprised observers of Mississippi politics and of the Senate when he announced recently that he would seek reelection to another term at the age of 81. It has been said that Senator Stennis might not have stood for reelection in 1976, if it had not been for his strong interest in the completion of the Tennessee Tombigbee Waterway. This project has become a near obsession with him and the project is frequently under attack in Congress.

His wife, to whom he refers as "Miss Coy", is confined to a nursing home in Mississippi and he frequently seems concerned about her.

TALKING POINTS FOR MEETING WITH SENATOR STENNIS

- Extend to him a Happy Birthday.
- Ask about his wife in Mississippi.
- Exchange comments about your common experience with gunshot wounds.
- Mention that you are aware he has served in the Senate longer than any other current Senator and provided sound advice on National Security for your Republican predecessors like Eisenhower, Nixon, and Ford. Tell him you are anxious to always take advantage of his advice and counsel and encourage him to communicate with you whenever he wishes.
- Mention that now that the tax bill and budget cuts are almost out of the way, it will be necessary to turn to some difficult issues involving defense and national security and you are counting on his support.

SUGGESTED TALKING POINTS FOR THE PRESIDENT
FOR BRIEFING WITH
STATE AND LOCAL OFFICIALS
August 3, 1981

- It's a great pleasure to have a group of fellow Westerners here in the White House and I want to extend my warmest greetings to you.

- I know how supportive many of you have been of my Economic Recovery Program and I want to thank you for that.

- The groundswell of support from the people for my economic package last week was one of the most inspiring events I can remember. The White House and Congressional offices were flooded with phone calls and telegrams that helped to turn the tide.

- I hope you are able to sense from the briefings you are receiving this morning that during the first six months of this Administration we have been engaging in a quiet federalist revolution to restore power and authority to state and local governments.

- The economic recovery package is the first stage of this effort to revitalize federalism.

- The budget cuts reflect a reordering of federal priorities so that our national budget reflects truly national needs.

- The tax cut package is designed to enhance the after-tax, after-inflation rewards of work, saving, investment, and productivity. Your states, counties, and municipalities need healthy economies to provide jobs and produce wealth. The tax cuts are crucial to generating a vibrant economic base for you as we seek to return revenue sources, as well as spending authority, to state and local governments.

- The block grant program -- while we didn't get everything from the Congress that we wanted -- will begin to give state and local officials the authority and resources to run programs which never should have been federal business in the first place. We are confident that you are every bit as caring, compassionate, and competent as the bureaucracy in Washington, D.C. Moreover, you are closer to the people and better aware of their needs.

-- The regulatory relief effort -- chaired so ably by the Vice President -- is designed to remove the regulatory manacles which have restricted the flexibility of state and local governments. The Regulatory Relief Task Force has already taken over 100 actions to relieve the burden of federal regulations; 34 of those actions have been directed at state and local governments.

-- Finally, to help chart our course in this area, I have established a Federalism Advisory Committee, chaired by Paul Laxalt, who was a county official, Lieutenant Governor, and Governor, before becoming a United States Senator from Nevada. This committee will be an action and results-oriented group, and I plan for it to move aggressively in the effort to return power and authority to state and local governments.

-- As a former Governor, I recognize the tremendous talent in the state legislatures, county seats, and city halls. This Administration seeks a genuine working partnership with state and local elected officials and we hope you will join us in the effort to restore a proper constitutional balance among all levels of government.
