

PURPOSE: To present Young American Medals for Bravery and Service to nine young people who have been recognized for outstanding acts of public service or exceptional courage between the years 1975-1979.

BACKGROUND: The awards program, set up by a statute enacted by Congress in 1950, honors American boys and girls eighteen years old or under, judged to have exhibited exceptional courage or to have engaged in outstanding acts of public service. The Department of Justice administers the program, receiving nominations from the nation's governors. The selection committee is headed by Director William Webster, Federal Bureau of Investigation. BRIEF REMARKS: PRESENTATION OF YOUNG AMERICAN MEDALS FOR BRAVERY & FREEDOM, SEPTEMBER 11, 1981

The nine young men and women here with me today come to the White House already citizen heros, to be honored by their Government and their people for their courage, character and service.

Darryl Gregory and Wade Cornick raced into flames to save a woman from her burning home. David and Robert Christie risked their lives to rescue others from a wrecked automobile minutes before it exploded. Donna Slack saved three small children from the violence of a tornado. Carmen Maria Hernandez Rodriguez helped create and sustain the civic organizations that care for the needy in her community. Jerome Dale entered a burning building to save two small children caught in a fire. Tim Hoover became a key part of his local ambulance service. And Joel Peterson crawled on his stomach over the thin ice of the Eau Claire River to rescue a friend who had fallen through to the water below.

These young men and women have grown up all across this country: in Wisconsin, Indiana, Virginia and Kansas; in Illinois, Arkansas, Maryland and Puerto Rico. They are both the product and the hope of the greatest land on earth. How can we doubt our future when our young people are of such mind and heart? Today, we can renew our faith in ourselves and our country, for these nine individuals come from the same mold as our own children, and the children of our neighbors.

The true test of civilization, it has been said, is not the census, or the size of cities, or the crops -- but the kind of people the country turns out. Ours is a country born of heros. Now, in the first decade of our third century, tried by all the challenges those years could hold, our moral fiber is stronger still. These nine Americans are proof of that fiber and that strength.

As they leave today, I would like to challenge these young Americans to apply their daring to the tests of our daily, national life. Everyday living can be the most courageous feat of all. Thoreau told us that if we advance confidently in the direction of our dreams, endeavoring to live the lives we have imagined, we will meet with a success unexpected in common hours. But first we must summon the courage to try.

We Americans are an uncommon people with an uncommon destiny. We have astounded the world as the Nation that can, if it will, accomplish anything. But now a new generation is preparing to lead us, and it will be their dreams that we will chase. Today as we glimpse the heroic imaginings those dreams must be, the rest of us must prepare to do whatever it takes to make them come true.

It is now my honor and privilege to present the Young

American Medals for Bravery and Service to nine of our citizens

who make me, and all Americans, very proud.

MEETING WITH SENATOR ROBERT PACKWOOD (R-OREGON)

#### I. PURPOSE

You have requested this meeting with Senator Packwood to discuss the proposed sale of an air defense enhancement package (AWACS) for Saudi Arabia.

#### II. BACKGROUND

Senator Packwood is ringleader of the opposition to the proposed AWACS sale. On June 24, he sent a letter to the President asking him not to recommend the proposed sale. That letter was co-signed by 54 Senators (bi-partisan).

Currently, Senator Packwood and 11 other Senators (bi-partisan) are circulating a formal resolution of disapproval of the AWACS sale. Packwood has solicited the co-sponsorship of 43 Senators (at least 14 Republicans) and had planned to introduce it today. He has indicated that he will hold off introduction until after this meeting with the President.

Packwood cites the following as his reasons for objecting to the sale:

- 1. We are selling our most sophisticated airborne surveillance system to a potentially unstable nation which could compromise our own technology.
- The Saudis have not been helpful in the Camp David peace process, they continue to support the PLO, and regard Israel as their number one enemy.
- 3. We are violating our previous assurances that the Saudi F-15s would not be enhanced.
- 4. We cannot rely on Saudi assurances.
- 5. Real issue: sale jeopardizes our national security and further destabilizes the Middle East.

Packwood also serves as Chairman of the Republican Senatorial Committee which draws a good deal of financial support from Jewish contributors.

Packwood has not had an Administration briefing on this issue.

## SUGGESTED TALKING POINTS FOR MEETING WITH SENATOR ROBERT PACKWOOD (R-OREGON)

- -- Discuss the importance of this sale in terms of our national security -- which is your primary responsibility as President of the United States. You might address some of Packwood's specific concerns (see background -- Dick Allen could help with this).
- -- Point out that you are also a staunch ally of Israel and discuss the benefits of this sale in terms of regional security in the Middle East. Go into your recent meetings with Prime Minister Begin.
- -- While you respect Packwood's right to disagree with your proposal, express some concern that he has never come to us for briefing on this issue. The whole purpose of this informal notification period is to allow a consultation between Congress and the Administration to see whether any refinements can or should be made prior to formal notification. By pressuring members to act now, Packwood is denying you the opportunity to be heard by his colleagues.
- Republican seats in the next election. This is particularly damaging in view of his position with the Senatorial Campaign Committee. No one has worked harder than you have to get Republicans elected. Express strong disagreement with him on this point and resentment that he should make this inference. Point out that he could actually exacerbate problems for Republican candidates by pressuring them to oppose their Administration on this

-- Encourage Packwood to allow a more reasonable and thorough debate on this issue.
