Your Meeting with His Beatitude Anthony Peter Khoraiche, Lebanon Maronite Catholic Patriarch of Antioch and all the East -- Wednesday, September 16 -- 10:30 a.m.

-- The Oval Office

This is a courtesy call by a religious leader. The Patriarch, however, is likely to mention political issues, such as the US commitment to Lebanon's sovereignty, the need to effect a Syrian withdrawal from Lebanon, and the armed Palestinian presence in Lebanon.

Since President Sarkis of Lebanon has just declined State's invitation to make an unofficial visit to the US, a meeting of the Patriarch with you becomes an important vehicle to reassert our commitment to a unified Lebanon.

There is a false rumor circulating within the Christian community of Lebanon that the US is considering sacrificing Lebanon to Syria and to the Palestinians in an overall settlement of the Arab-Israeli conflict.

The Patriarch in the past has been the subject of criticism among Phalange militants for what they consider as lukewarm support of the Maronite (Catholic) political cause and excessive tolerance of other faiths and factions. Thus, the Patriarch's even-handed image makes him a good candidate to receive your expression of support for a unified Lebanon.

SUGGESTED TALKING POINTS FOR MEETING WITH HIS BEATITUDE ANTHONY PETER KHORAICHE OF LEBANON

- -- Your Beatitude, it is a distinct pleasure to welcome to the White House the leader of the largest group of Christians in Lebanon and in the Middle East.
- -- Meeting with you provides me with an opportunity to express our concern for the well-being of all the people of Lebanon and especially Lebanon's Christian communities.
- -- As Patriarch, you not only tend to the spiritual needs of the Lebanese people, but you also play a very important role in the preservation of Lebanon's independence and territorial integrity. Your Beatitude, you are a symbol of a sovereign Lebanon, a sovereignty that America is working to preserve.
- -- Your concern with <u>all</u> the people of Lebanon has helped preserve the spirit of the Lebanese people in a difficult time.
- -- My sincere thanks to you Cardinal Cooke for helping to arrange the Patriarch's visit to the United States.



II. BACKGROUND: The Boys Clubs of America's National Boy-of-the-Year Program has been sponsored for 35 years by the Reader's Digest Foundation. Over 1,000 local Boys Clubs conduct programs to choose a Boy-of-the-Year. The candidates are chosen on the basis of service to home, school, place of worship, community and Boys Club. In most instances, local winners are then entered into a state-wide Boy-of-the-Year competition. State Boys-of-the-Year are usually installed by the Governor. The state winners then compete in one of five regional programs, and the five regional winners and their local club directors are brought to Washington for final judging. One of these young men is chosen annually as the National Boy-of-the-Year and he represents a million Boys Club youth.

Beginning with President Eisenhower and every President since, the National Boy-of-the-Year has been installed at the White House by the President. This year marks the 75th Anniversary of the Boys Clubs of America, giving this year's program even greater significance.

THE PRESIDENT'S COMMISSION ON EXECUTIVE EXCHANGE SWEARING IN SEPTEMBER 16, 1981

Good morning. A President has many unique opportunities and one of them is meeting and thanking those who are doing things which make this a better country. And that is why I am here today.

Looking around this room I see the faces of individuals who already have enormous responsibilities. Yet by being here you are saying that you are willing to take on a little extra if it will help. The Commission on Executive Exchange is something that will pay dividends for years to come by improving the understanding between the prime movers of the public and private sector.

This Commission was established in the final year of the Johnson Administration. Even then there was a growing alienation between Government and business; executive exchange was seen as a method of dealing with the problem.

Since then numerous executives have gone through the program, gaining insights that have been invaluable in overcoming the complexities of a mixed economy.

This program offers career Government executives a chance to see what it's like on the other side of the line. This is vitally important in keeping our economic system functioning and the country prospering. Today, those in Government have such enormous powers that, even with the

best of intentions, they can create havoc for their private sector counterparts.

I've always felt that the best thing Government can do for the businessman is get out of his way. Admittedly, that is getting more difficult to do. But programs like this permit those in Government to know when it's better to act and when it's better to stand aside.

On the other hand, there are those in private companies who do not fully appreciate the legal responsibilities of Government executives. Understanding the other guy's job can't help but make the system flow more smoothly.

As members of this Commission, your main task will be finding the dedicated and highly motivated men and women who will participate in this executive exchange. I can guarantee you cooperation from the Government side. On the other hand, this program has involved corporations with long-term vision, businesses that know what investment in the future really means.

Today, it gives me a great deal of pleasure to announce that James E. Burke, Chairman and Chief Executive Officer of Johnson and Johnson, will be serving as Chairman of the Commission. We are looking forward to working closely with him to see this commission is a success.

In closing I want each of you to know how much we appreciate the time you are putting into this effort. This is one of those tasks which requires a little extra


involvement -- the sort of thing that makes the difference between being a resident of the country and being a good citizen.

The luncheon participants represent a broad cross section of Hispanic business and civic leaders, as well as your key Hispanic appointees and supporters. The audience will be very friendly towards you.

HISPANIC LUNCHEON -- SEPTEMBER 16, 1981

Buenas tardes. As a Californian it is a special pleasure for me to welcome you to the White House. All of us from the West have a special place in our hearts for the Hispanic culture. It is so much a part of our tradition in the Southwest that moving here to Washington was a bit of culture shock.

I understand that whenever there is Federal business to be done in any of the Southwestern States there is fierce competition among my staff to get the assignment. It has something to do with enchiladas and refried beans -- and the lack of them in Washington, D.C.

Seriously, being from the West has given me a deep appreciation for the Hispanic culture, including its music, its food and the qualities of character it engenders, especially the sense of personal honor and integrity.

In the past election I talked about five important values: family, neighborhood, work, peace, and freedom.

Campaigning in Hispanic areas, I never felt more comfortable about these values.

During the last two decades, when our traditions and values were under attack as never before, the Hispanic Americans held firm to their beliefs like a solid rock amidst a stormy sea. They demonstrated a commitment to family, a reverence for God, as well as the pride and self-

respect that comes from hard work. Today, all of us are rediscovering those values, but the Hispanic community never lost them.

And this dedication is beginning to bear fruit. Progress made by Hispanics can be described as nothing less than phenomenal. After years of adversity and discrimination, there is no doubt that Hispanics are taking their rightful place in American society.

In my own Administration, they are playing an invaluable role. Eighty Hispanics have already received appointments at all levels; 18 of them to major positions. And across this land in the private sector, Hispanic Americans are making their way into positions of influence and leadership. All of this is a tremendous source of pride for a people that have worked so hard to overcome the obstacles before them.

A most admirable quality of Hispanics is the sense of honor and duty that is rooted so firmly in their culture. Few others can claim the patriotism demonstrated by these citizens. Consistent with this, they have received awards for heroism and bravery far in excess to their portion of the population. Two of my first ceremonial functions as President were, interestingly enough, directly related to the heroism of Hispanic Americans.

First, I was honored to welcome back the hostages from Iran. Two of the Marines had been especially heroic -- both

of them were Hispanic Americans. One of them, Jimmy Lopez, is remembered not only for risking his life to help several embassy employees escape, but also for his spirited defiance in captivity. He wrote on his cell wall, in Spanish, "Viva la roja, blanca y azul." His devotion will not be forgotten.

Then on February 24 I was honored to pay tribute to another brave man: Master Sergeant Roy Benavidez. His heroism in Vietnam earned him his country's highest award, the Congressional Medal of Honor. I am proud to have had the opportunity to present it to him.

The proclamation we celebrate today talks about the strength Hispanic people give to this country. All of this is based on the strength of character of which I spoke of earlier. Recognizing this, I am proud to have proclaimed this National Hispanic Heritage Week. Doing so, I hope all Americans will reflect on how lucky we are to have such a wonderful people as part of our country and part of ourselves.

6:15 p.m. Guests begin to arrive the East Gate, and Social Aides lead them to the Lower Cross Hall, up the Grand Staircase, and into the East Room where they prepare for the receiving line.

6:45 p.m. THE PRESIDENT AND MRS. REAGAN proceed to the State Floor via the elevator, cross the Cross Hall into the Red Room, and proceed through the south door into the Blue Room to take position for the receiving line.

As soon as THE PRESIDENT AND MRS. REAGAN are in position, Social Aides begin to lead the guests through the south door into the Green Room and on through the south door into the Blue Room to meet THE PRESIDENT AND MRS. REAGAN.

*As guests come off of the receiving line, Social Aides lead them to the buffet area in the tent on the South Lawn via the Red Room and down the outer staircase. Guests can serve themselves to the buffet or dance as soon as they arrive in the tent.

7:45 p.m. At the termination of the receiving line, THE PRESIDENT AND MRS. REAGAN proceed from the Blue Room to the Cross Hall and down to the Ground Floor via the elevator. They then proceed to the tent on the South Lawn via the Diplomatic Reception Room and dance on the dance floor in the middle of the tent.

8:00 p.m. THE PRESIDENT AND MRS. REAGAN depart the tent from the north entrance, proceed directly to the Diplomatic Reception Room and into the Family Residence via the elevator.

8:45 p.m. All guests depart.

*NOTE:

In the event of rain, guests coming off of the receiving line will proceed from the north door of the Red Room, into the Cross Hall, across the Main Foyer, down the Grand Staircase, and out the Diplomatic Reception Room into the tent on the South Lawn.

BRIEF REMARKS: SENATORIAL TRUST RECEPTION SEPTEMBER 16, 1981

Welcome to the White House. You who have done so much to bring this Administration into being and whose efforts made a Republican Senate possible -- you are very welcome, indeed.

Last year at this time only dreamers spoke of those things, but we were not afraid to dream. We had a vision we still share with most Americans -- a vision of an America guided again by her founding principles.

It has been said that those who dream by night only wake in the morning to find it illusion. But then there are dreamers such as you -- dreamers of the day. The saying goes that such dreamers are dangerous, for they may act their dreams with open eyes, and make them come true.

Our dreams rebuilt a disheartened minority to a dynamic force; they reopened our Party to ideas and energies that are bringing historic change; they are leading this Nation back to the path of glory she had lost, and our dreams -- dreams we share with a growing majority of Americans -- will cause men and women of all nations to once again speak of the United States of America as the greatest land on earth.

There are those who have resisted us from the beginning, who are afraid of the changes we must make to renew our country. They were silenced by the people as test after test -- in November and in the crucial votes this summer -- the people did not waver in their support.

But suddenly we hear the critics again, attacking our programs before they have begun. They are saying nothing new. Those who doubt today have never believed. Those who now call for a retreat from our principles have never embraced them.

Let me assure you: I remain as committed today as I ever have been to cutting the budget, cutting our taxes, reducing regulations and ensuring a stable, consistent growth in our money supply. We will balance the budget and we will continue to make all adjustments necessary to hold that course. As I told some of you yesterday, I will not hesitate to use the veto to block any budget-busting effort. There will be no retreat.

These programs will work. But we must remember they reverse decades of mistaken economic policy. We have a new beginning, but it is the beginning of a long and difficult path to recovery.

As we prepare for another election year, let us remember that we have this chance for recovery because the people demanded it. They share our dream and have entrusted us to keep it alive.

We must find men and women who share our dedication and encourage them to join us. We must broaden our coalition by enlivening our ideas and redoubling our efforts. We have relied on your help in the past -- we are counting on it for the future. I have no doubt of your commitment.


