4:45 p.m. Guests arrive Southwest Gate and proceed to Diplomatic Reception Room. Guests are taken by the elevator to the third floor where they proceed, with the help of security agents, to view the rooms which are open.

They then descend the back (eastern) small staircase to the second floor where they view the designated areas and then proceed down the Grand Staircase to the Grand Foyer and into either the East Room or State Dining Room for refreshments.

Rex Scouten and Peter McCoy will organize tour of second and third floors.

5:00 p.m. Guests begin to enter East Room and State Dining Room for refreshments.

5:45 p.m. At this time, no more guests will be added to the line for the tour. Any guests arriving may go directly up the Grand Staircase to either the East Room or the State Dining Room.

6:05 p.m. Social Adies begin to lead guests from the State Dining Room and the Color Rooms into the East Room to prepare for the entrance of THE PRESIDENT AND MRS. REAGAN.

6:15 p.m. THE PRESIDENT AND MRS. REAGAN arrive on the State Floor and proceed into the East Room. They are announced and proceed to the platform on the east wall.

Dr. Payne, Chairman of the White House Historical Association, will make remarks and presentation of a citation to MRS. REAGAN.

MRS. REAGAN will make thank-you remarks. THE PRESIDENT AND MRS. REAGAN will then mix and mingle briefly with the guests.

6:30 p.m. THE PRESIDENT AND MRS. REAGAN depart the East Room and proceed to the Residence via the elevator.

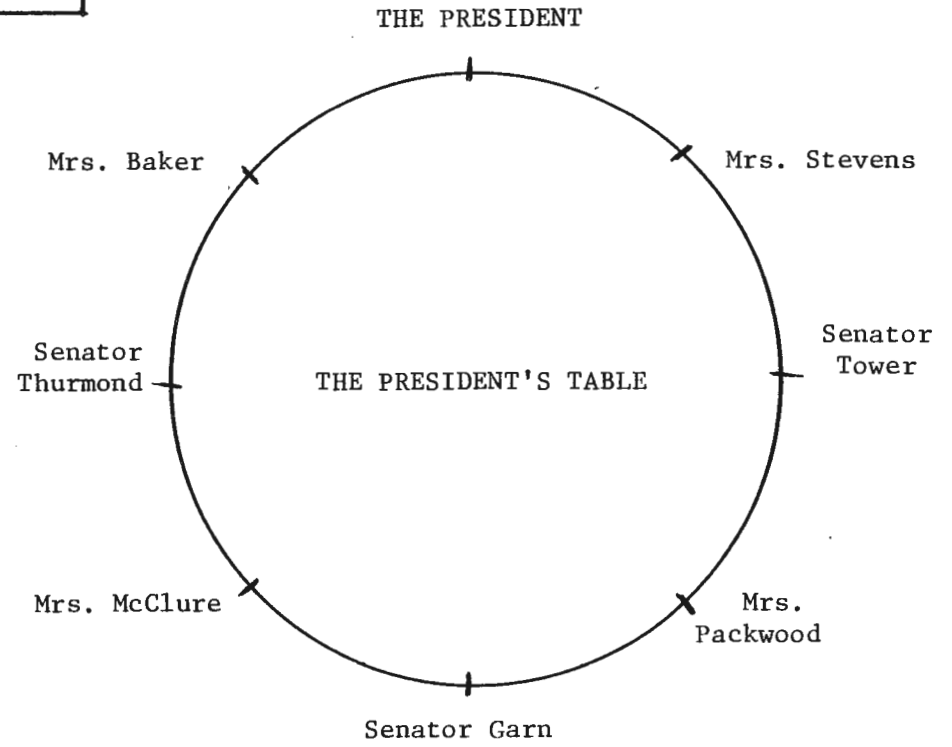
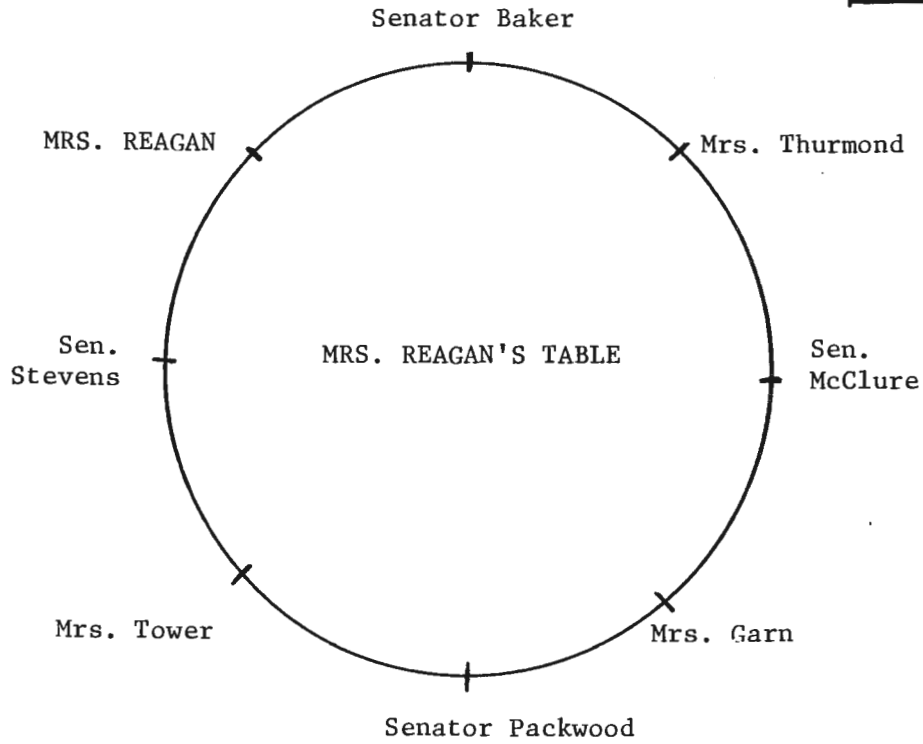

I. PURPOSE

To respond to a request from Senator Rudy Boschwitz for you to meet with this group to discuss your decision not to address out-year policy in the second budget resolution and not to deal with entitlements and revenue enhancement this year.

II. BACKGROUND

Last Thursday at the GOP leadership meeting in the Cabinet Room, you informed the leadership including Senator Domenici that with regard to the second budget resolution, you recommend that out-year decisions on entitlements and revenue enhancement be handled in the budget message next year and that there should be no attempt to deal with these issues now. In spite of this recommendation, ten of twelve Republicans on the Budget Committee voted to move ahead immediately with tax increases and entitlement program cuts. All Democrats and Senators Kassebaum and Quayle sided with your position and the attempt was rejected.

Senator Boschwitz has called to request an opportunity to appeal this decision. Senator Boschwitz has been constantly assured that you work through the leadership on issues like this, but the meeting was agreed to as a courtesy to him and the other Senators who requested it.

TALKING POINTS FOR MEETING WITH
SENATE GOP BUDGET COMMITTEE MEMBERS

NOVEMBER 18, 1981

- o I am always ready to hear and discuss your concerns on important issues like this, but I must make one point clear from the start: on policy issues and legislative strategy, I must work through the Senate leadership -- Howard Baker and the Committee Chairmen, in this case, Pete Domenici.

It would be impractical and counter-productive for all of us, for me and members of my staff, to operate on an ad hoc basis.

- o On the Second Budget Resolution we had extensive consultations with Pete, Howard and other members of the Senate leadership. As you know, the result of these conversations was three-fold.
 - o First, on the spending issue we were quite close. The \$40 billion in entitlement savings and \$33 billion in discretionary program savings in the Domenici mark were on target.
 - o Second, on revenue increases I indicated that under no circumstances could I accept a tax increase in FY 82. I also indicated that revenue increases for the out-years should be reserved for later consideration, and only as part of a legislative compromise to achieve further spending cuts.
 - o Finally, after much weighing of the pros and cons we concluded that now was not the proper time to address the out-year deficit and budget issues. I pledged that my January budget message would deal with this issue in full.
- o I know that some of you believe a different course is desirable, and I respect that. But given the limited time remaining, I must stand firmly behind our decision of last week not to proceed on the out-year budget issues at this time.



- I. PURPOSE To receive a Thanksgiving turkey from the President and Executive Vice President of the National Turkey Federation.
- II. BACKGROUND The National Turkey Federation is the only national trade association representing the turkey industry in the United States. Members of NTF produce and market 96 percent of the nation's turkey crop.

This is the 34th presentation of a Thanksgiving turkey to the Nation's First Family by the NTF. The presentation will be made by NTF President Hugh McClain of Mountain Home, Arkansas.

In March 1981, the NTF formally endorsed your program for economic recovery.

BACKGROUND/SUGGESTED TALKING POINTS
FOR MEETING WITH
NATIONAL TURKEY FEDERATION REPRESENTATIVES

Note: Since no remarks are required, what is provided as background is for your personal information only.

- You addressed the National Turkey Federation convention in San Diego in 1979 (Town & Country Hotel). At that event, you sat next to Mr. Lew Walts, the NTF's Executive Vice President. Mr. Walts (and his wife Frankie) will attend today's presentation.
- The NTF was previously headquartered in Mt. Morris, Illinois, near your hometown of Dixon (They are currently located in Reston, Virginia).
- In addition to the live turkey, there will be two thirty-pound dressed turkeys on either side of the table. They will be wrapped in foil and inscribed "Happy Holidays, Mr. President."
- During his presentation remarks, Mr. McClain will say a few words about the turkey industry and will probably note that the NTF supports your Program for Economic Recovery.
