I. PURPOSE

To notify Congressional agricultural leaders of the policy announcement on agricultural trade to be made by the President during his appearance at the White House briefing for agricultural editors on Monday, March 22, 1982; and to discuss related policy matters raised by Congressional participants.

II. BACKGROUND

Beginning with the grain embargo which was imposed by the previous Administration, agricultural issues have had continued visibility since January 20, 1981. The public debate about conditions in the agricultural sector of the economy reached a peak last December during final Congressional consideration of the 1981 Farm Bill.

Certain factors and events since that time again have focused public attention on Administration activities and policies on the so-called farm front: (1) two letters, signed by a total of approximately forty House Members, requesting a meeting with the President on "the economic crisis faced by our nation's farmers and avenues by which we might avert an economic disaster"; (2) a question raised in the President's most recent press conference on the status of the Congressional meeting request mentioned in item 1 above; (3) a letter to the President, signed by House Agriculture Committee Republicans, conveying "concerns... (and) suggestions for possible remedies that may at least diminish some of the current problems in the farm sector"; (4) the recent controversy over Commodity Credit Corporation assistance to Poland and other Eastern European countries; (5) the President's participation in a recent Cabinet Council meeting on agricultural trade policy; (6) the sensitivity accorded agricultural trade aspects of the Caribbean Basin Initiative within the Administration and on Capitol Hill; (7) revised estimates which

indicate an increase of approximately \$9 billion in the cost of farm price support programs during Fiscal Year 1982 and Fiscal Year 1983; (8) the designation of National Agriculture Day as March 18, 1982; and (9) the President's scheduled appearance on March 22, 1982 at a special White House briefing for agricultural editors.

This meeting has been scheduled in light of these factors. Although the primary focus is on agricultural trade policy, it is anticipated that other farm policy issues also will be discussed.

SUGGESTED TALKING POINTS FOR
MEETING WITH SELECTED MEMBERS
OF THE SENATE AND HOUSE OF REPRESENTATIVES
TO DISCUSS THE AGRICULTURAL TRADE ISSUE

- Acknowledge that this is a very difficult period for American agricultural producers--the third straight year of economic recession in the farm sector due to a vicious cost/price squeeze, high interest rates and uncertain markets.

- Note that, as symbolized by the recent supplemental requests of some \$9 billion for commodity supports this year and next, this Administration will not turn its back on the nation's farmers in their time of special need.

- State that, long-term, the Economic Recovery Program-- to reduce the government's claim on our national resources and end its interference with the marketplace-- will benefit the agricultural sector as much as any other area of the domestic economy. While there remains much to be done, very important progress has been made to reduce inflation and interest rates during the past year.

- Recognize that the Federal Government also has an important role to play in partnership with the farm community in such areas as research, market development and basic commodity supports.

- Indicate that the Administration's long-term policy on farm exports will be announced later in the day which will ensure that there can be no confusion among our producers or our overseas trading partners on at least three essential priorities:
 - o That no restrictions will be imposed on the exportation of farm products because of rising domestic prices.
 - o That farm exports will not be used as an instrument of foreign policy except in the most extreme situations and as part of a total embargo.
 - o That world markets must be freed of trade barriers and unfair trade practices.


- Mention that Agriculture Secretary Block has some comments to make, and then you both look forward to hearing what this group of distinguished Congressional leaders has to say.

I. PURPOSE:

To issue a statement of reassurance to the agriculture community and display sensitivity to their concerns.

II. BACKGROUND:

American agriculture is facing one of its most serious situations in years. High interest rates, low commodity prices, and nervousness over possible trade sanctions against the Soviet Union and Eastern Europe have contributed to the anxiety in the agriculture sector.

Except for your videotaped message in January to the American Farm Bureau Convention, you have yet to address a major agriculture audience as President.

During the February 23 Cabinet Council meeting, there was general agreement that you should, at the earliest possible time, issue a public statement which re-affirms your basic agriculture policy and defines an agriculture export policy. This will help calm the concerns of farmers and let them know of your awareness of their difficult plight.

Following your speech, the audience will be briefed by Dave MacDonald of USTR on U.S. trade policy, Murray Weidenbaum on the budget and general economic policy, and Secretary Watt on land management and water use policies.

PURPOSE: To recognize and give support to National Poison
Prevention Week.

BACKGROUND: By your Proclamation, the week of March 21 is the
21st observance of National Poison Prevention Week (NPPW) spon-
sored by the CPSC and the NPPW Council. The NPPW Council is
made up of voluntary organizations, health and safety associa-
tions, industry, and government agencies. Accidental poisoning
has long been a major cause of deaths and injuries for children
under five. The 1970 Poison Prevention Packaging Act required
that many products be in child-resistant packages which has
been highly effective in reducing poisoning incidents. Since
1973, this Act has been administered by CPSC. Also effective
are the 600 poison control centers throughout the country pro-
viding poison prevention information and treatment services
and collecting poison prevention data. CPSC Chairman Nancy
Steorts is one of the Administration's highest level women
appointees.

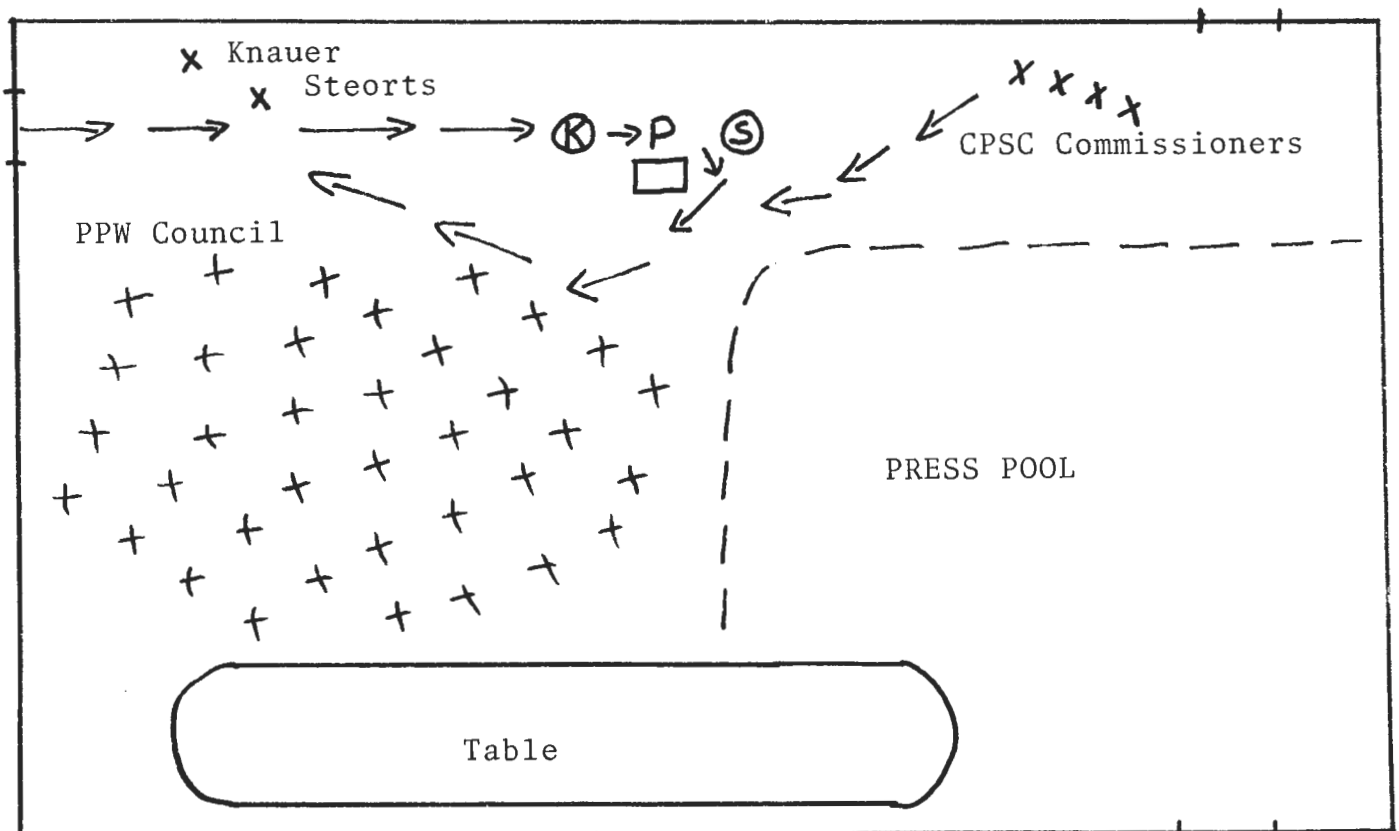

SUGGESTED TALKING POINTS FOR MEETING WITH
PRESIDENTIAL ADVISORY COMMISSION ON FEDERALISM

-- I want to thank you for all the time you have devoted to helping me on the federalism issue.

-- I remember the meeting which we had in this very room on December 15, 1981. Many of the suggestions which I received that day are reflected in the conceptual framework which I announced on January 26:

- That there must be a large, bold program, rather than -- in the words of Governor Snelling -- 'just a "piecemeal attack" on federalism.
- The need for a true sorting out of responsibilities among the various levels of government.
- I remember Pete Domenici talking about increasing revenue sharing dramatically. In a sense, the \$28 billion trust fund is a giant revenue sharing program to states and localities.
- The need for a pass-through of funds to local units of government. I guarantee to you that a mandatory pass-through will be a part of this package.

- The need for a match between revenues turned back and programs absorbed. This is a part of the proposal -- we will provide a dollar for dollar match of revenues for programs. And we will continue to structure the proposal so there are no winners or losers among the states.
- Finally, we have responded to the request that there be an adequate transition by not making the program fully effective until FY '91.

-- Paul, the timing of your meeting today is perfect. We have not nailed down the details of our proposal yet, but the issues have been sufficiently crystallized by now that your input can be very productive.

- I know there are some concerns about full state assumption of AFDC and food stamps, and we're willing to look at alternative swaps in the income maintenance area.
- We want your guidance on the pass-through.
- We're willing to look at other revenue sources in place of the windfall profits tax.

- We need your advice on the 43 programs to be turned back.

-- In short, we're eager to listen. This is the first opportunity I've had since January 26 to sit down with representatives of all levels of government at one time, and I look forward to hearing from you.

-- Paul, before we open up the discussion, I want to express my special thanks to you for your leadership of this important committee. I knew when I asked you to chair this committee you shared my strong feelings on the importance of returning power and authority to state and local government ... to the people. You've done a great job and I appreciate it.

-- Call on Senator Laxalt.
