John East Orrin Hatch James Quillen Arlan Stangeland REMARKS FOR NATIONAL DAY OF PRAYER OBSERVANCE MAY 6, 1982

What an inspiration it is for me to look out on you -Protestants, Catholics, members of the Jewish faith and others -gathered here at our National House to pay homage to the God in
whom we trust.

Many of you are leaders in your faith, others are active in your communities, your professions or are among our elected representatives, but all of us are here with a common purpose: to observe our National Day of Prayer.

Prayer has sustained our people in crisis, strengthened us in times of challenge and guided us through our daily lives since the first settlers came to this continent. Our forebears came not for gold but mainly in search of God and the freedom to worship Him in their own way. We have been a free people living under the law with faith in our maker and in our future.

I've said before that the most sublime picture in American history is of George Washington on his knees in the snow at Valley Forge. That image personifies a people who know that it is not enough to depend on our own courage and goodness -- we must also seek help from God -- our Father and preserver.

The French philosopher Alexis de Tocqueville, visiting

America 150 years ago, marvelled at Americans because they

understood that a free people must also be a religious people.

"Despotism," he wrote, "may be able to do without faith, but freedom cannot."

Today, prayer is still a powerful force in America, and our faith in God is a mighty source of strength. Our Pledge of Allegiance states we are "one Nation under God" and our currency bears the motto "In God We Trust." The morality and values such faith implies are deeply embedded in our National character. Our country embraces those principles by design and we abandon them at our peril.

Yet, in recent years, well-meaning Americans in the name of freedom have taken freedom away. For the sake of religious tolerance, they have forbidden religious practice in our public classrooms. The law of this land has effectively removed prayer from our classrooms.

How can we hope to retain our freedom through the generations if we fail to teach our young that our liberty springs from an abiding faith in our Creator? Thomas Jefferson, one of our Founding Fathers, said the "Almighty God . . . created the mind free," but current interpretation of our Constitution holds that the minds of our children cannot be free to pray to God in public schools.

No one will ever convince me that a moment of voluntary prayer will harm a child or threaten a school or State. But I think it can strengthen our faith in a Creator who, alone, has the power to bless America.

One of my favorite passages in the Bible is the promise God gives us in Second Chronicles: "If my people, which are called by my name, shall humble themselves, and pray, and seek my face, and turn from their wicked ways; then will I hear from heaven, and will forgive their sin, and will heal their land."

That promise is the hope of America and all our people.


Because of my faith in that promise I am particularly pleased to be able to tell you today that this Administration will soon submit to the United States Congress a proposal to amend our Constitution to allow our children to pray in school.

No one must ever be forced or coerced or pressured to take part in any religious exercise, but neither should the Government forbid religious practice. The amendment we will propose will restore the right to pray.

I thank you for coming today, and for the good work you do for our people, our country and our God every day of the year.

But I also hope I can count on your help in the days and months ahead as we work for passage of this amendment. Changing the Constitution is a mammoth task. It should never be easy. But, in this case, I believe we can restore a freedom our Constitution was always meant to protect.

Together let us take up the challenge to reawaken America's religious and moral heart, recognizing that a deep and abiding faith in God is the rock upon which this great Nation was founded. Thank you and may God bless you.
