The Urgent Supplemental has passed the House, is pending on the Senate floor and will likely be passed this evening. You are meeting at 3:30 this afternoon with Senators Lugar and Garn on the housing bailout portion of the Urgent Supplemental and the possibility of a veto.

The defense authorization is tentatively scheduled for the week of July 12th in the House. There is concern that there will be ample funding authorized for the MX program in this bill.

- Bailouts send the wrong signals to financial markets. Bail-outs for any one sector are likely to lead to bail-outs for others. They are, simply, budget-busters.

- Should I decide to veto the urgent supplemental because of the \$3 billion housing bail-out, I hope my veto will be sustained and that the Congress will act quickly to send me a clean bill containing only those items urgently needed to continue FY82 activities.

- Now let me turn to the third topic, the M-X program and the House's consideration, after recess with the Defense Authorization bill.

I. PURPOSE

To thank the participants for their work to date on tuition tax credits, announce that your legislation is being submitted, and encourage their active support for its enactment.

II. BACKGROUND

You will be submitting your tuition tax credit bill to the Congress the day of this meeting. The people gathered in the room are leaders of the private educational community, both religious and non-religious. All support tuition tax credits in general, and your bill in particular.

Prior to your arrival, they will have been briefed for approximately 45 minutes on the bill by representatives from the Office of Legislative Affairs and the Office of Policy Development.

I. PURPOSE/BACKGROUND

The Department of Transportation has been reviewing the Administration's maritime policy for the past several weeks. The policy questions have been and will continue to be presented in the Cabinet Council on Commerce and Trade. However, Transportation is at a crossroads from a strategic standpoint. We need to choose between continuing to subsidize the maritime industry, which Secretary Lewis will recommend, or steadily reducing the subsidies to the industry which will cause even more rapid deterioration of the industry.

Because of your support for the industry in the past and the need to make a strategic determination as to the most desirable way to proceed, this briefing session has been scheduled to apprise you of the considerations now under review. Secretary Lewis' presentation will include a discussion of the present situation in the maritime industry, the options for future action and the general consequences associated with the two principle paths: subsidizing the industry vs. no subsidies and international competition.

After hearing the discussion (and perhaps giving the matter some thought after the meeting), your options are:

1. Ask Transportation to present a full range of options at a future Cabinet Council meeting (one problem with this is that we have had sessions on this subject where the papers are quickly leaked);
2. Ask Transportation to present maritime subsidy options at an upcoming Cabinet

Council meeting (consistent with campaign statements and politically helpful this year);

3. Ask Transportation to consider only minor steps this year to help the industry and defer consideration of major subsidy questions until after the election (avoids confronting this constituency until after the election which would be wise if, in fact, we are not going to support some form of a significant subsidy package).

SUGGESTED TALKING POINTS FOR MEETING WITH
SENATOR RICHARD LUGAR AND SENATOR JAKE GARN

- Senator Lugar has requested this meeting to make his case for the housing stimulus in the urgent supplemental appropriations bill before you decide whether to veto it. Indicate that you understand Lugar has pursued this legislation because of concern over unemployment and high interest rates and that this is a concern which you also share. Suggest that Lugar proceed to make his case.

- After Senator Lugar has concluded, mention that the White House consistently has expressed its opposition to the Lugar housing stimulus bill and its counterpart in the House of Representatives. This opposition has been based on both philosophical and practical reasons.

- A specific housing stimulus program would create enormous pressure for similar assistance for other industry which would in turn significantly worsen current deficit problems. ✓

- Adding to the deficits will only add to financial market pressures and aggravate high interest rate levels -- the basic problems plaguing housing and other sensitive sectors. ✓

- There is substantial evidence that the market is already working to revive housing without enactment of an expensive housing stimulus bill. New housing permits and housing starts have been up substantially in recent months. ✓

- The Administration has acted to permit private pension funds to invest more in real estate, to create more flexible mortgage instruments and reduce burdensome HUD regulation which inhibit housing construction.

- At the conclusion of your visit thank Senator Lugar for discussing this issue personally with you and tell him that you appreciate his motivation in terms of providing more jobs and a strong housing industry. Tell Lugar that this will, indeed, be a difficult decision for you and that you appreciate having the benefit of his input.

REMARKS AT MEETING WITH ONE HUNDRED KEY G.C.P. CONGRESSIONAL
CANDIDATES, JUNE 22, 1982

Thank you very much. Well, we're delighted you could all come, and we have this chance to meet you. I feel a little like I'm seeing a premiere. Now I can say I've met the new superstars for the Congressional Class of 1983. We hope this will be just the first of many return visits to the White House.

I'm supposed to be brief and I will be. I can sum up most of what I want to say in about three thoughts: Go get 'em; you can do it; we're behind you all the way.

You will be hearing a lot of charges levelled against Republicans in the weeks ahead. Just remember something Abraham Lincoln once said: "Truth is generally the best vindication against slander."

To listen to many of our liberal friends complain about deficits, you might think someone else was planning to do the red-ink spending. To listen to them scream about 16½ percent interest rates, you might forget they were the ones who left us 21½ percent interest rates, and a trillion dollar debt. To listen to them cry for more compassion, you would never know they want to pick the pockets of the middle-class, with more and more taxes.

Well, if I may quote Honest Abe one more time: You can fool all of the people some of the time. You can fool some of the

people all of the time. But you cannot fool all the people, all the time, and we will not let them be fooled in November.

If you go beyond the labels and propaganda, if you ask Americans to spell out what they want from this Government, their answers are clear and precise: They want inflation and interest rates brought down and kept down; they want the growth in spending and taxes cut; and they want our defenses built up, strong enough to deter aggression and protect the free world.

You know something: that just happens to be our program for America, and we not only believe in it, we're proud of the progress we've made so far.

If there's anything wrong with our program, it's not that we've gone too far. It's that we haven't gone far enough. We've only begun to cut the growth in spending and taxes. We need, and we're asking the Congress to pass, a constitutional amendment requiring a balanced Federal budget.

Now our opponents are insisting the present recession was caused by our program, which has been on the books less than 9 months. May I just point out -- we had the recession before we got the program. Yes, unemployment is too high, but tragically, unemployment is always a lagging indicator. It begins to improve after recovery is already underway.

I think it's significant that the number of Americans who are employed exceeds 100 million. Also, for the last 6 months inflation has been running at an annualized rate of only

2.3 percent, and just 2 years ago people said that could never be done in so short a time. This drop in inflation means over \$1,000 in increased purchasing power for an average family of four with a fixed income of \$15,000. We might see inflation bump up for a month or two, but the trend remains downward.

When the special pleaders start campaigning against our budget cuts as penalizing the poor, when they assail our tax program as favoring the rich, that defense spending is too high, here are a few points to remember. Twenty years ago, during John F. Kennedy's Camelot, spending for human needs was 29 percent of his budget. Defense spending was 46 percent of his budget. In our proposed budget for '83 the social needs, the human needs total 51 percent of the budget and defense spending is only 29 percent.

President Kennedy's tax cut program was greatly beneficial to the country. It was phased in over 2 years and gave 36 percent of the relief to corporations and 64 percent to individuals. Our program is phased in over 3 years and gives corporations 20 percent of the total and individuals 80 percent. And it's the middle-income taxpayers who will get the biggest share of our tax cut.

The problems we inherited can't be cured overnight. But they can and will be cured with more good people like yourselves in the Congress. As I said, we're with you all the way. And now I think I'd better get down from here so I can shake your hands.
