THE PRESIDENT'S SUGGESTED DEPARTURE STATEMENT
FOLLOWING MEETING WITH DR. ROBERTO SUAZO CORDOVA, PRESIDENT OF HONDURAS
July 14, 1982

I am pleased to welcome President Suazo of Honduras to the White House. Honduras is a good and valued friend and partner of the United States.

President Suazo's leadership has returned Honduras to democracy, and his government has embarked on a prompt and courageous effort to return the country to economic health.

Our meeting is very much in keeping with my policy of working closely with our democratic friends in this hemisphere.

President Suazo and I had a good discussion about the situation in his country and elsewhere in Central America.

Honduras has completed a transition to democratic government under difficult circumstances. The bright prospects this brings for the Honduran people should not become the victim of either difficult economic conditions or the aggression of those who oppose freedom.

I told President Suazo of our shock on learning of the recent terrorist attacks against power stations in Honduran territory which cut off vital electricity to hospitals, water and other essential facilities. The purpose was to make innocent people suffer and they did. Ten, I am told, died in emergency rooms in hospitals when power failed. But these

terrorists will not succeed in intimidating a brave people or the leaders they have freely chosen. When faced with threats of this kind the people of Honduras should be able to rely on their friends for help, and they can count on us. The United States will provide assistance so that Hondurans can defend themselves from aggression.

President Suazo has been a strong voice for peace and democracy in Central America. He has put forward a plan to reduce tensions between states by agreement on the reduction of arms and the number of foreign advisors, and by international supervision of borders, airfields and ports so each country can be free of the fear of aggression from its neighbors. It is a concrete plan for peace, and we fully support it.

At President Suazo's inauguration the Presidents of Costa Rica, El Salvador and Honduras met as members of the Central American Democratic Community and committed themselves to strengthen democracy, promote economic development, and cooperate in mutual defense against outside intervention.

In their most recent meeting in San Salvador these democracies again called on Nicaragua to end its support for insurgency and terrorism in their countries and join in a regional peace agreement based on respect for non-intervention.

We share those goals.

President Suazo also has explained frankly the seriously depressed economy of his country and the austerity measures

he has adopted. The record low prices for sugar have devastated this major source of earnings and employment. The proposals before our Congress for the Caribbean Basin would substantially increase our economic assistance to Honduras in this fiscal year. It is for people in real need. I told President Suazo that I was sure the Congress would respond with strong bipartisan support for a program that is obviously in the interest of both the U.S. and Honduras.

President Suazo, I am told, will be speaking to members of the Congress on the Caribbean Basin Initiative. I am pleased he will do this as another democratic leader of the region--President Monge of Costa Rica--did last month. It is vital that the Congress understand that our program serves not only this country's broad interests in the region, but that it is also supported by this country's democratic friends in Central America and the Caribbean.

Mr. President, I hope you return to Honduras confident that the United States--its people and its government-- remains a reliable friend and a good neighbor.

That, Mr. President, is my personal pledge to you.

### MEETING WITH REPUBLICAN CONGRESSIONAL LEADERSHIP

### I. PURPOSE

To review briefly the Lebanese situation and to discuss with the Republican leaders 4 major foreign policy/national security items: CBI, arms control, security assistance and the MX.

### II. BACKGROUND

This meeting provides an opportunity for the President to urge the Leadership to have the Congress act swiftly and favorably on the Caribbean Basin Initiative. With the Congress having just returned from recess, several committees will be scheduling markups and hearings on the various components of the CBI.

In addition, an unsatisfactory resolution has been reported by the House Foreign Affairs Committee and will be acted upon soon by the full House. A substitute resolution, developed by NSC and the State Department in coordination with the House Republican leadership, will be introduced and pushed by the Administration.

On security assistance, strong Republican support---although difficult to achieve---is essential to passage. The leadership needs reassurance by the President that this program is of strategic importance.

Finally, the defense authorization is tentatively scheduled for late July in the House. There is concern that there will be ample funding authorized for the MX program in this bill.

# INTRODUCTORY TALKING POINTS

- --- Appreciate the change to meet with all of you today to review several foreign policy legislative items.
- --- But I first want to take a moment to review the crisis in Lebanon.

### TALKING POINTS ON LEBANON

- --- Key to crisis is departure of PLO leadership and fighters from Lebanon.
- --- I have decided in principle that, if asked, U.S. would contribute a military contingent for peacekeeping force.
- --- Assure you of three things:
  - Commitment is key to getting any agreement
  - No more than thirty days
  - Ironclad assurances against firing on U.S.
- --- Mindful of the War Powers Resolution, but cannot be certain about circumstances of troe introduction: thus have made no decisions concerning particulars of congressional notification.
- --- Now let me turn to the Caribbean Basin Initiative.

### TALKING POINTS ON CARIBBEAN BASIN INITIATIVE

- --- Want to mention another matter of special significance which I hope the Congress will act upon swiftly and favorably---the Caribbean Basin Initiative.
- --- The CBI legislation defines the economic portion of our overall strategy toward the Caribbean and complements the political and security dimensions of our policy.
- enhance stability on our border than millions of dollars of militar assistance, and I want to emphasize that the economic aid we are providing is 7 times the military aid. In the long run, it will save us the much larger amounts of military expense we will ultimate have to spend to defend this area if undervelopment continues to attract subversion and terrorism.
- --- Let me also emphasize that for the first time America is not just giving aid. We are tying this aid together in a package with trade and investment incentives.
- --- Finally, the leaders of the Caribbean countries have all expressed support and have staked political capital on this program. If we let them down, if we fail to support the struggling democracies in this area we will have only ourselves to blame.

### TALKING POINTS ON SECURITY ASSISTANCE

- --- FY82 Supplemental and FY82 Security Assistance bill are no giveaways---they are key to national security objectives.
- --- Republican support for security assistance is critical, since we may not have liberal support.
- --- FY82 supplemental compensates for serious shortfalls in last December's appropriation.
- --- FY83 request essential for Middle East peace; deter further inroads by Soviets elsewhere.
- --- Cuts in defense budget request make security assistance especially important.
- --- I pledge the full support of the White House to help get the Security Assistance measures passed.
- --- Finally, let me mention MX.

### TALKING POINTS - MX

House Foreign Affairs meeting

For your information: According to Tom Enders, Assistant Secretary of State for Inter-American Affairs, you need to know that a bipartisan deal on CBI aid is emerging in the Committee which would (a) keep the \$350 million: (b) reduce the El Salvador total from \$128 to \$100 million; and (3) reallocate the difference to Guatemala (our first overture to the new government there).

One key to broad support has been the idea of allocating \$20 million of the Salvadoran total to compensation for land reform. Senator Helms, who has opposed U.S. involvement in compensation, now will not oppose it, if (as is clear) it will help pass CBI and sustain the effort in Central America.

## SUGGESTED TALKING POINTS

- I know the full Foreign Affairs Committee will be having an important markup tomorrow on the CBI. I wanted this opportunity to indicate my strong interest in this proposal and seek your help.
- -- U.S. foreign policy in this hemisphere has a special significance for me. When I announced my candidacy for this office, I indicated that I would be working to achieve new dimensions in America's relations with its neighbors in this hemisphere.
- -- My CBI program is part of this larger initiative. It focuses on the long neglected fourth border of this country, the region of small and larger countries that border on the Caribbean.
- The CBI legislation defines the economic portion of our overall strategy toward this region. It complements the political and security dimensions of our policy and shows that America is not only concerned with military threats and power in this area but understands that the source of discontent in this area is ultimately poverty and underdevelopment.
- It is this underdevelopment that Nicaragua, Cuba and the Soviet Union feed on. We will never defeat this menace

on our own border until we help these people realize their aspirations for a better life.

Let me emphasize that for the first time America is not just giving aid. We are tying this aid together in a package with trade and investment to enable this region to learn about and to exploit the magic of the market-place. America is promoting the kind of development that we know works -- private capital, trade, self-sustaining aid and more appropriate domestic policies to encourage savings and control investment. I think you can support this type of development policy among your constituents.

Specifically, I recognize that our aid proposal for El Salvador is controversial. However, the proposed aid allocation for El Salvador was based upon a rigorous, economic projection of the problem. Every dollar of the \$128 million requested for El Salvador is fully justified.

These funds are not for guns, but to help people earn their daily bread. Much of the productive base in El Salvador (and many other countries) is idle or badly used because there's not enough foreign exchange to import spare parts and raw materials. These funds will help put people back to work.

El Salvador receives less assistance per capita than

several other basin countries inspite of the fact it

has suffered a substantially more severe economic

decline and receives less assistance from other donors.

- I understand that a bipartisan compromise on the allocation of the \$350 million is now emerging.

The fate of all of Central America is closely linked with developments in El Salvador. If the situation deteriorates still further in El Salvador, all of Central America will find it more difficult to obtain ordinary credits in world capital markets. Political stability will be at risk throughout the region.

expressed support and have staked political capital on this program. If we let them down, if we fail to support the struggling democracies in this area and their number is currently growing, we will have only ourselves to blame when dictators and hostile forces take control of this region.

President Suazo Cordova of Honduras and I have just
met for an hour. His country is threatened by economic
downtown and subversion. He is staking his country's
future on the CBI.

- This effort to promote development will enhance stability. It will cost much less than we will have to spend to defend this area if underdevelopment continues to attract subversion and terrorism.
- I urge strong bipartisan support for CBI, at the requested level, in your Committee's deliberations.
- I would now like to call on Tom Enders for a few comments.
