PRESIDENTIAL REMARKS: ANNOUNCEMENT OF NATIONAL HEALTH FAIR PROGRAM
AUGUST 5, 1982

Well, thank you very much and welcome to the White House.

It does my spirit good to be among so many people who have the faith and goodwill to move mountains -- and believe me, you are doing that.

I think the effort you have heard about today is an example of public/private partnership at its best. I understand that last March, after Secretary Schweiker and Congressman Gore kicked off this campaign, over 500,000 people received free health care education and screening services. This is the type of private sector initiative that Bill Verity and members of the Task Force on Private Sector Initiatives have been bringing to my attention all year.

We want to congratulate the National Health Screening
Council for Voluntary Organizations for serving as a catalyst.
Our Administration deeply appreciates organizations like yours
trailblazing new private sector initiatives.

Congratulations also go to the media for providing 132 hours of television promotion and 31,000 inches of newspaper coverage.

Now please don't think I'm not grateful, because whenever I hear something positive, I give thanks. But after that fine start, we

just hope you won't drop the ball; we want to challenge you to do even more.

I'm here to tell you all that we like your style. We like the way you have put together groups of people at the grass roots to offer free health care and health education services at no cost to the taxpayer. It is estimated that every business dollar of support you raise generates an average of \$40 of services to communities. That's not bad.

Secretary Bell and Secretary Schweiker have assured me today that they will join the Health Fair effort, working with you as partners, providing health care promotion services wherever possible.

When the people of this country are encouraged to use their own initiative, together they can accomplish great things. I think we will see the proof of this in the 1984 Summer Olympic games. I've felt for a long time that the work of the Los Angeles Olympic Organizing Committee (L.A.O.O.C.) isn't good work. It's great work because of the dedication and the selflessness of the people on the Committee, and the generosity of millions of Americans. You know, these are the first games in history that will be put on totally by the private sector — and the LAOOC tells me that they will be depending on volunteers and community groups. In fact, over 1200 volunteers are working right now on citizen committees — and that number is expected to swell to 10,000 by 1984. It's not Government dollars, but

voluntary efforts that keep America participating in a tradition that goes back thousands of years.

This is our American spirit; and with help from the media, from business, from volunteer organizations, and the Government, I know that this year your Health Fair will serve many more people than in the past -- hopefully, we can even save some lives. I understand you heard about this kind of example just before I arrived.

I wish I could thank each of you personally for getting involved, but let me just say again how grateful we are for your initiative, and how important it is to build on your accomplishments. Dr. Brensike (Bren-zick-ee) tells me that Governor Thompson in Illinois has taken a strong leadership position to promote this partnership at the statewide level. I hope many other States will join in.

I. PURPOSE

To indicate a strong interest in the House/Senate tax bill conference negotiation, to solicit ideas from Republicans on Ways and Means, and to ask for assistance in passing the conference report.

II. BACKGROUND

The House/Senate Conference Committee is meeting to consider the revenue increases and spending reductions mandated by the reconciliation provision of the Budget Resolution. Congressmen Conable (R-New York), Archer (R-Texas) and Duncan (R-Tennessee) are the House Republican conferees. There is substantial resistance to the Senate tax bill from House Republicans and a majority of Republicans on the House Ways and Means Committee. The natural reaction against tax increases has been aggravated by the expeditious procedure of going directly to conference. Only five of the 12 Republicans on the Ways and Means Committee voted to send the bill directly to conference -- several argued that going to conference was unconstitutional because revenue bills must originate in the House.

Republicans on the Committee are also unhappy because they feel that they have had little or no say on the substance of the bill.

Several of the Ways and Means Committee members have suggested that they will not support any tax increase until the House enacts the spending reductions called for in the budget reconciliation instructions. 80% of the spending reductions are also in the conference with the revenue provisions.

This meeting will provide an opportunity for these Republicans to express their thoughts as to what modifications might be made in conference. If we are going to get a sufficient number of Republicans to vote for the tax conference, we will need the support and/or acquience of the Ways and Means Republicans.

Talking Points for Ways & Means

- The Senate has passed a bill which improves the fairness of the tax system and preserves the incentives necessary for economic recovery. The bill also includes the spending reductions mandated by the Budget Resolution. I know that we can improve this bill in conference, but I want to make it clear that I support this bill and hope you will support the conference report.
- -- The bill will reduce projected budget deficits while maintaining the integrity of my economic recovery program. It preserves the individual tax rate reduction and indexing provisions enacted last year.
- -- Rather than raising taxes on working people, the bill focuses on the elimination of unintended abuses, the removal of obsolete incentives, and improvements in taxpayer compliance.
- -- More than three-fourths of the increased tax revenues come from increased taxpayer compliance and the closing of tax loopholes.
- -- I know that some of you were unhappy about sending this bill directly to conference. Some of you have already said that you couldn't vote for any tax bill, but we need your help and your ideas on how we might inprove this bill in conference.

- -- Nobody likes to raise taxes, but failure to adopt this bill will result in an additional \$100 billion in deficits over the next three years. This could jeopardize the success we are now having with interest rates, and weaken the anticipated economic recovery.
- -- We worked together to pass the First Budget Resolution which included spending cuts and revenue increases. We need to work together to pass this conference report which implements those cuts. At a time when the economy is starting to move -- when interests rates are starting to decline -- the worst possible signal would be for us to walk away from passage of this conference report.

House Republicans are very reluctant to support a tax bill. Only 44 Republicans voted to send the Senate passed bill to conference and that unexpected procedure aggravated the House Republican Members at large because they had been generally excluded from any substantive legislative input.

In addition to special interest opposition, certain conservative Republicans have mobilized opposition to any tax hike. Other Republicans have indicated that they will not support any tax increase until the House enacts the spending reductions called for in the budget reconciliation instructions.

80 percent of the reconciliation spending reductions are also in the conference with the tax bill. If the conferees meet the reconciliation targets, passage of the conference report could reduce the deficit approximately \$115 billion over the next three years. However, Republican Members are very nervous about the political consequences of raising taxes, and need to be reassured that the Administration has no intention of raising taxes to pay for more spending programs.

Northeastern Republicans have been reluctant supporters of many of the Administration's budget proposals - especially cuts in discretionary and social spending.

Many of them have been very disturbed by the perceived bias against their region and view the Administration's defense priorities as a political liability.

We will need to gain substantial support from this group for the revenue bill. This meeting will give them an opportunity to air their views and to get a better understanding of the need for passage of the conference report.
