I. Purpose

Robert Thompson, on your staff, is leaving the White House in the next few weeks. He appreciates the opportunity to have his family meet you and have their picture taken with you.

II. Background

Bob Thompson traveled with George Bush during the Presidential campaign. During the first year of your Administration, he was the Vice President's Executive Assistant for Congressional Relations. In February of this year he took the position of Special Assistant to the President for Legislative Affairs on your staff.

After two years of service in your Administration, he will be returning to the private sector. He will be moving back to his home town, Tulsa, Oklahoma. Although he regrets leaving, Bob, as a father of four children (all under the age of 10), recognizes the need to spend more time with his family.

Guests begin to arrive the SouthWest Gate, Diplomatic Reception Room. They are led up the elevator and into the Red Room for refreshments.

12:15 p.m.

THE PRESIDENT arrives the State Floor via the elevator and proceeds into the Red Room and joins his guests.

12:25 p.m.

THE PRESIDENT leads his guests from the Red Room into the State Dining Room via the north door to be seated for luncheon.

Luncheon is served.

1:00 p.m.

THE PRESIDENT makes brief remarks, to be covered by the press. At the conclusion of his remarks, a birthday cake is brought in for Justice Rehnquist.

The press departs to set up in the Blue Room; dessert is served in the State Dining Room.

INCLUDES THE PRESIDENT

1:20 p.m.

At the conclusion of dessert and coffee, THE PRESIDENT leads the guests from the State Dining Room to the Blue Room via the Cross Hall. They all take their places for the official photograph in front of the west wall. (Press will be pre-positioned at the east wall.)

NOTE: White House staff guests who will not be included in the official photograph may hold in the Red Room or depart as they wish.

Following the photograph, THE PRESIDENT and his guests are led through the south door of the Blue Room into the Red Room; THE PRESIDENT continues directly to the elevator via the Cross Hall to depart.

The guests hold briefly in the Red Room to allow the press to depart the State Floor, then they may all depart via the Grand Staircase.

I. PURPOSE

To strengthen the Administration's relationship with the Court by renewing the tradition of formally acknowledging the opening of the Court Term on the first Monday in October.

II. BACKGROUND

Historically, the Supreme Court Justices visited the President each year to formally advise him that its Term was about to convene. The original purpose was to let him know that all of the Justices had survived their journeys back to Washington, but it later became a traditional, formal occasion. In recent Administrations, since Eisenhower, the custom has been neglected or only observed sporadically.

PRESIDENTIAL REMARKS: LUNCHEON FOR SUPREME COURT JUSTICES
FRIDAY, OCTOBER 1, 1982

Mr. Chief Justice and Associate Justices, thank you for joining me at this luncheon marking the start of October term, 1982, of the Supreme Court. This house is honored by your presence, and I am honored to be your host.

My lawyers have warned me that one has to be extra careful not to exceed time limits in front of the Supreme Court, so I will try to be brief.

I'm told that in the early days of our history it was the practice of the Justices to come to the White House to advise the President that they were about to commence a new term of the Court. The purpose in those days was, of course, to let the President know that they had survived the rigors of horseback travel! This has since become primarily a traditional visit, only sporadically observed. I am pleased we can now renew this special tradition.

Americans have grown used to the role of the Court in our constitutional system -- and perhaps we take for granted things that other persons in other times would find extraordinary. Certainly, I think that the Supreme Court of the United States is the only group of men -- and now men and women -- in history that has exercised such significant authority over such a long period of time, without having -- or needing -- its own battalions to enforce its decisions. I think it is a healthy reflection of the

fact that the vast majority of our citizens respect and abide by the decisions of the judiciary as a matter of course.

This is not to say, of course, that we will always agree on the important issues that are presented to you for decision. The Court itself is frequently of more than one mind about such matters; and it is neither surprising nor disturbing that our citizens may at times side with the dissenters. It is even rumored that Presidents sometimes disagree with particular Supreme Court decisions.

It is inevitable that the Court's decisions become the focus of popular attention and debate -- and certainly our Founding Fathers expected nothing different. But about one point, at least, there can be no disagreement whatever. The Supreme Court must continue to demonstrate the independence and integrity that have always been its hallmarks. You, as members of the Court, are the principal guardians of those traditions, and of the rights and freedoms of all Americans.

On behalf of all our people, I would just like to say "thank you" for the distinguished service you have given to our country. I would especially like to thank you for your dedication to the ideal that is carved above your doorway -- "Equal Justice Under Law." May God grant each of you a rich measure of his grace and wisdom as you face the challenges of this new term.

Now, if you will indulge me a bit further, there is actually another occasion worthy of special note today. Today is the birthday of Justice William Rehnquist. I've never been one to comment on the ages of public officials, but Mr. Chief Justice,

if it won't violate any principle of separation of powers, I'd like to extend my personal birthday good wishes and congratulations to Justice Rehnquist.
