I. PURPOSE

To allow certain members of the public to observe the Presidential signing of S. 2036, the Job Training Partnership Act, and to increase public attention to this event.

II. BACKGROUND

At the Administration's initiative, Congress has passed the Job Training Partnership Act (S. 2036). This legislation repeals and replaces the former CETA program, and assures that seventy percent of every federal dollar which goes to job training will actually be spent on training and not administration. The Job Training Act emphasizes private sector involvement in job training programs, and encourages development of beneficial training programs rather than public sector jobs and welfare payments.

This is the major jobs legislation passed by the 97th Congress. In view of the current unemployment statistics, this ceremony will be helpful in focusing public attention on positive efforts the Administration is making to put Americans to work.



PRESIDENTIAL REMARKS: SIGNING OF JOB TRAINING PARTNERSHIP ACT
WEDNESDAY, OCTOBER 13, 1982

Well, hello and welcome to all of you. It's wonderful to see you here and join with you in this important step forward for America.

When our Administration arrived in Washington 2 years ago, this country was in the grips of not one, but four severe problems: double-digit inflation, record-high interest rates -- they had just hit 21½ percent -- the worst tax burden in peacetime history, and high unemployment.

With support from the American people, we put in place a program designed to cure this raging economic disease which had been ignored for too many years. Today, little more than a year has passed since our program went on the books. But we have already made solid progress against three of the four problems we inherited: we've reduced high inflation, high interest rates and taxation. But unemployment -- always the lagging indicator -- remains far too high. Clearly, our most urgent priority today is to create lasting, private sector jobs. I pledge that I will not rest until every American who wants a job can find a job.

Unemployment is a tragedy for all Americans in every region, every city and every line of work. We are dependent on one another not only for prosperity, but for survival. We need the strength of every back and the power of every mind to lift our Nation from the economic swamp to higher ground. We must not waste the energy of one citizen who wants to work.

All of us are moved by the plight of millions of our people who cannot find jobs, who must provide for their families yet cannot earn a paycheck. Perhaps the cruelest trap of all has caught legions of our youth. As they stand on the threshold of the American dream, far too many find the door of opportunity slammed in their faces. Unemployment among our young people is averaging 20 percent, and among minority youth 40 percent -- more than four times the national rate. Two out of every five people out of work are between the ages of 16 and 24.

We continue to push for enterprise zones in our inner cities -- a program to attract new businesses and jobs to areas of highest unemployment. I think it's tragic that this enterprise zone proposal has been bottled up so long in committee by the leadership of the House.

I remember what it was like to be 21 and looking for work in 1932. I know how it feels when your future has been mortgaged by the generation before you -- and that's a tragic mistake we must never allow our leaders to make again. Today's young people must never be held hostage to the mistakes of the past.

The only way to avoid making those mistakes again is to learn from them. It's estimated, for example, that more than 20 million American workers now rely on skills that won't be needed within 20 years. The government has trained thousands more in skills that already aren't needed in their communities. Still others have been steered into make-work government programs with no future.

We've got to do better, especially for our young people.

That's why I am proud today to sign into law the Job Training Partnership Act -- a program that looks to the future instead of the past. This is not another make-work, dead-end bureaucratic boondoggle. This program will train more than 1 million or more Americans every year in skills they can market where they live. It will make a difference on Main Street America. It will provide help, bring hope, encourage self-reliance and personal initiative.

Here's how it will work. State and local government officials, business and labor leaders, and other members of the private sector will plan area programs in Private Industry Councils.

Local people will decide at the grassroots level what opportunities are available in their communities and then match real jobs with needed skills.

And here's something else that makes this program different from so many past failures. At least 70 percent of program funds will go to actual job training; we're eliminating the bureaucratic and administrative waste that has marked so many so-called jobs bills in the past.

There's another reason for confidence in this measure. It's based on a tried and tested concept. The young people with me today have already benefitted from local programs very similar to the one we're about to enact nationwide. Emanuel Clark from Richmond learned clerical skills and found a job in a law firm because of the New Horizon Training Program in his area. Bienvenido Martinez, an immigrant from the Dominican Republic,

received on-the-job training sponsored by the Washington, D.C. Private Industry Council, and now works part-time as a computer operator while attending college. These are just two examples of the opportunity this approach holds for millions of Americans.

Long-time workers who have lost their jobs because of new technology, women who can't find work because their homemaking skills aren't marketable, young people who aren't hired because they have no experience -- all will be helped by this program. Let me just add a special word of thanks to Senators Hatch and Quayle, and Congressmen Jim Jeffords and John Ehrlenborn for their leadership in getting this legislation passed.

Now, if you young folks will gather around, it is with great pleasure that I sign into law the Job Training Partnership Act.
