HOME BUILDERS

It is a real pleasure to have this chance to speak with you once again as you open your annual convention this year. You are building our country out of recession and into recovery, and I want to thank you for holding on -- for your grit and determination during a very difficult time, and for your faith in our country.

As you are well aware, the dream of homeownership in America had turned into a nightmare -- not suddenly, not overnight, but after a decade or more of economic abuse. After years of fiscal blundering in Washington -- after big Government policies of the past brought our national economy to the brink of disaster -- homeownership became an impossible dream for too many of our people. But with your support we've slowly been turning things around. As I said last October when I proclaimed National Housing Week, these are days of new hope for housing.

We have begun to tame the inflation monster, that had raged out of control with back to back years in the double digits. Interest rates were once out of sight and first homes were out of reach for the average American family. But, in just two years, the inflation rate has been cut by nearly two-thirds to 4.6 percent. The prime rate has been cut nearly in half to 11½ percent; a \$50,000 mortgage costs \$200 less now than at peak rates before; and the housing market is recovering.

Your dedication to the principles of economic responsibility helped to pass important legislation in the Congress, making this recovery possible. Together, we were able to garner enough bipartisan support to pass most of our economic recovery package and necessary tax reforms. I hope I can continue to count on your support as we face even greater challenges in the days and months ahead.

I would like to specially thank your president, Fred Napolitano, for his leadership and advice, and your president-elect, Harry Pryde. Peter Herder has also been of invaluable help in his role as a member of the Housing Commission.

As we begin this new year of hope and opportunity, let us continue to work together to solve our problems. We can transform these days of hope for housing into an era of prosperity for all America.

PRESIDENTIAL TAPING: LOS ANGELES OLYMPIC ORGANIZING COMMITTEE  
MONDAY, JANUARY 10, 1983

It is a great pleasure for me to welcome you, delegates and guests, to this meeting of the International Olympic Committee and the National Olympic Committees.

We Americans are honored that Los Angeles is hosting the Olympic Games -- this international forum where athletes from all over the world meet in friendly competition. As I told International Olympic Committee president Samaranch [SAHM-a-ronsh] and Los Angeles Olympic Organizing Committee president Peter Ueberroth [YOU-ber-roth], I'm looking forward to the opening of the 1984 Games, and I want to assure all of you that the Olympic Charter will be respected. Mike Deaver of my staff is keeping me up to date on your progress and will be working with you to insure the success of the games.

I am confident that the Los Angeles Olympic Organizing Committee and the people of Southern California will provide a high level of excellence in facilities, transportation, and, most of all, hospitality. As a former resident, I know you can count on Southern Californians to be helpful and friendly during your present visit and again when you return in 1984. We Americans are a people who love sports, appreciate competition, and enjoy making new friends. As a city populated by a myriad of cultures, Los Angeles, California, USA, is amply suited to host this gathering of the world's best athletes.

Los Angeles, of course, is already part of the Olympic tradition. Much has changed since the city of the angels first hosted the Games in 1932. Only 37 countries participated then; there will be many more in 1984. In 1932, there were just six women's events in athletics; in 1984, there will be 17 including, for the first time, the marathon.

The modern Olympic movement has come long way since it was first conceived by a young Frenchman, Baron Pierre de Coubertin [koo-bear-TENH]. The dream became a reality in 1896, and his clear vision has seen the Games through periods of war, political strife, and change. Coubertin's words still ring true -- a constant reminder of the spirit of the Olympics: "The important thing in the Olympic Games," he said, "is not to win but to take part, just as the most important thing in life is not the triumph but the struggle. The essential thing is not to have conquered but to have fought well."

Once again, on behalf of the people of the United States, welcome to Los Angeles, and I look forward to seeing you in 1984.
