SUBJECT: STATE AND LOCAL OFFICIALS INVOLVED IN YOUR
VISIT TO PITTSBURGH, TUESDAY APRIL 5, 1983

I. Governor Richard "Dick" Thornburgh (R-Pennsylvania) has been a steadfast supporter of your economic recovery program and the New Federalism initiative. His public support has been extremely helpful with the national media.

He has recently been elected to the National Governors' Association Executive Committee. In addition, NGA has recommended him for the Republican gubernatorial position on the Advisory Commission on Intergovernmental Relations.

The recession and the continuing problem of the auto and steel industries has caused Pennsylvania to accumulate a deficit in excess of \$2 billion to the Federal Treasury for Unemployment Insurance Compensation. The recently passed Social Security legislation included reforms which would require Pennsylvania and other states to move toward solvency. The Governor presently has a reform package in draft and is seeking the cooperation and support of business and labor.

The Governor is concerned about the recent announcement by U.S. Steel of their intention to import British steel. The Governor has stated he does not intend to interfere with this private sector decision but he notes that steel workers are upset.

The Governor's FY 84 budget proposal is before the Pennsylvania legislature. This proposal seeks to cover a projected \$265 million deficit by holding the line on expenditures and increasing the application of the state's sales tax. The Governor has not proposed an increase in the personal income tax. This budget proposal has met with significant criticism from Democrats in the State Legislature.

- II. Mayor Richard "Dick" Caliguiri of Pittsburgh, PA, is a liberal Democrat who has been moderate in any criticism of the Administration or the President.

Caliguiri is an active member of the Boards of Directors of both the U.S. Conference of Mayors and the National League of Cities.

Mayor Caliguiri attended a meeting on the state of America's cities with you and six other Mayors in the Oval Office on September 5, 1982. Caliguiri made a presentation on urban infrastructure.

One of the most pressing problems facing the Mayor and the City of Pittsburgh is the decay of the city's infrastructure, specifically the repair and maintenance of the 120 city-owned bridges. Currently, 48 percent of the bridges in Pittsburgh need work and are scheduled for repair over the next six years. The cost of these repairs is estimated at \$55.8 million.

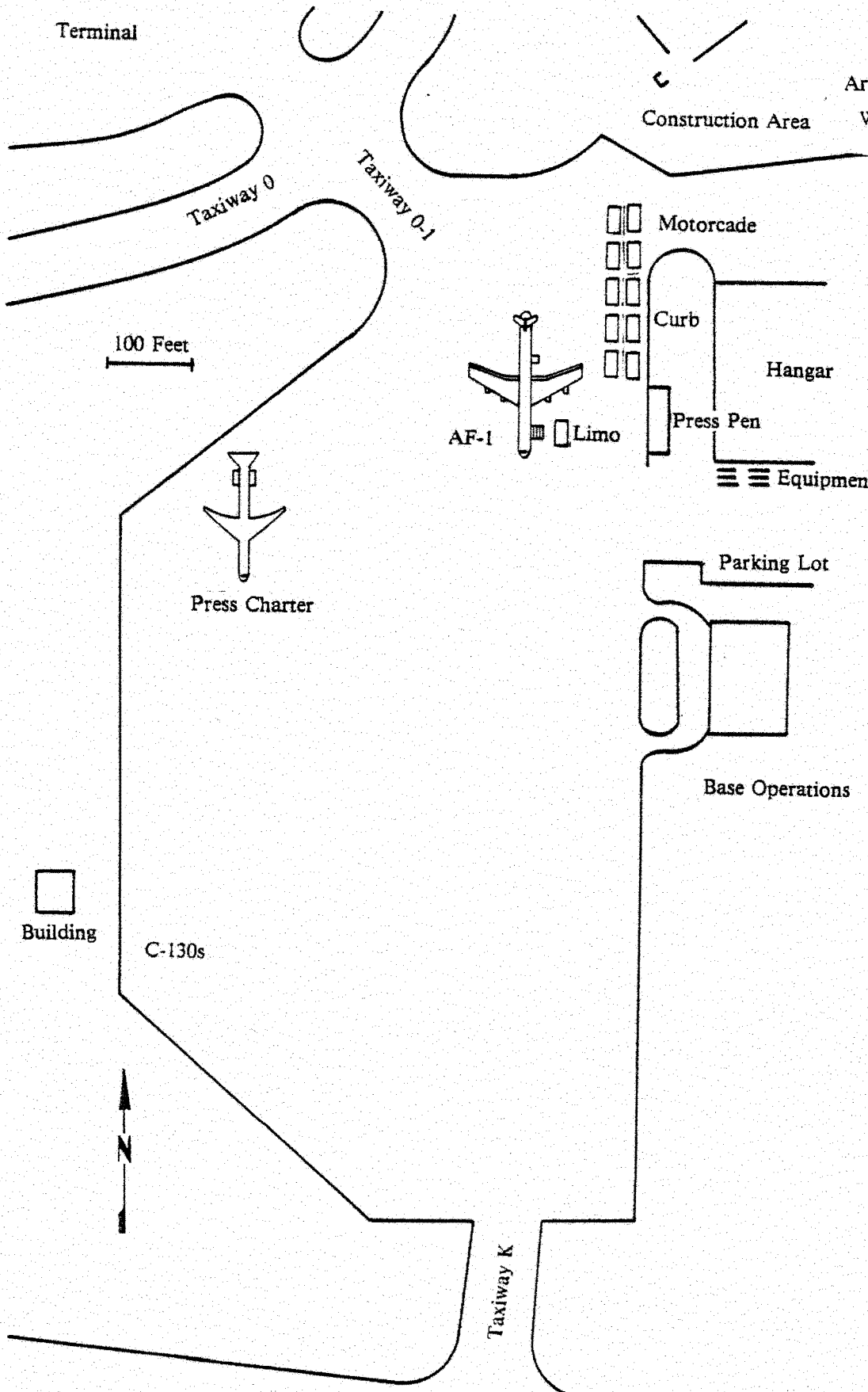

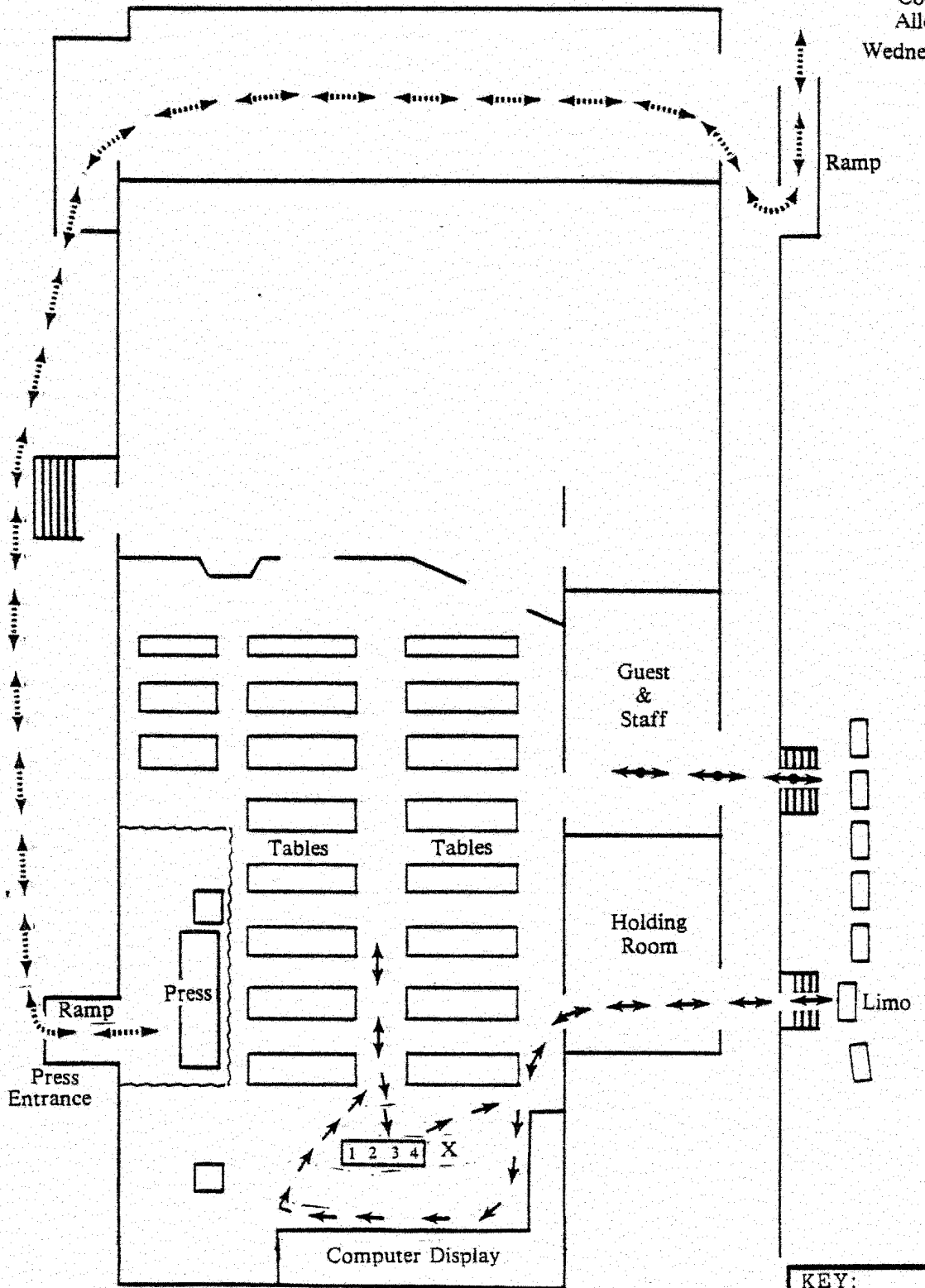

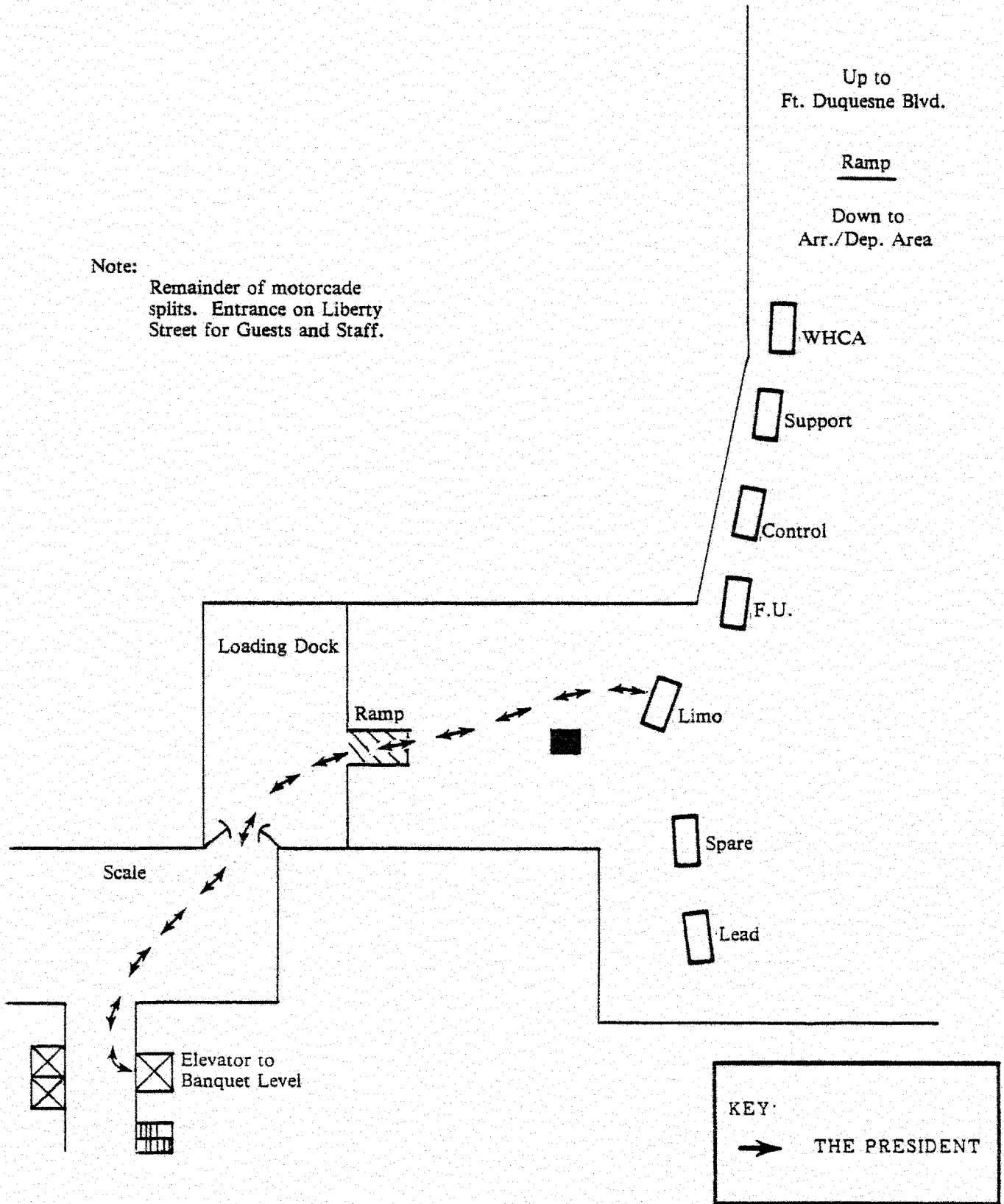

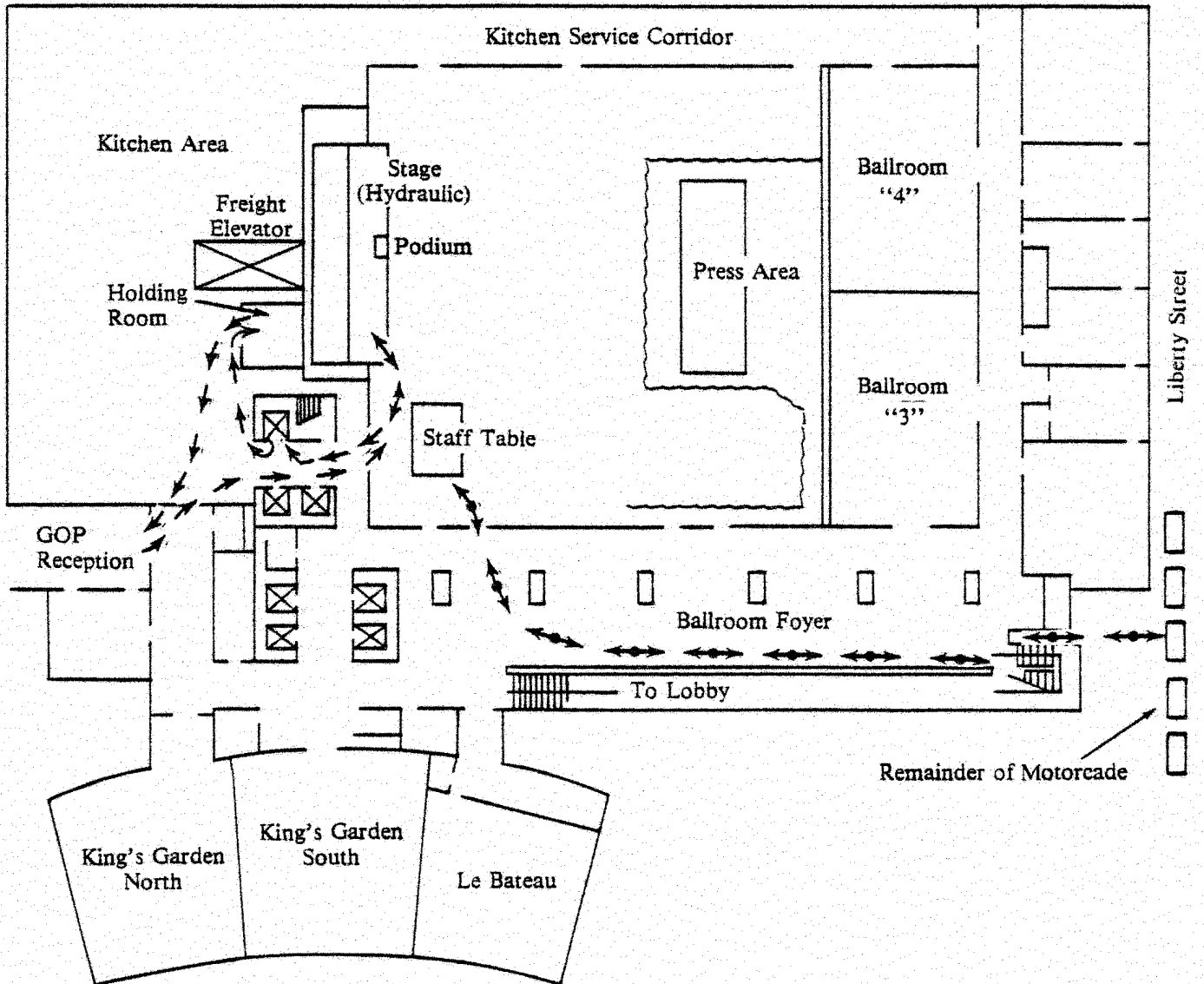
