PRESIDENTIAL REMARKS: LUNCHEON WITH PRESIDENT'S ROUNDTABLE ON CAPITAL FORMATION FRIDAY, JUNE 10, 1983

- -- Well, I'm delighted to welcome you to the White House.

 And may I say I'm honored to be with some of the best and brightest minds in the country in the area of capital formation.
- -- You know the challenge we face. Our highest priority is to get America back on the cutting edge of growth.

 I think incentives for greater savings and investment are the key to restoring strong growth and our industrial competitiveness.
- -- Our Administration has tried to substantially improve
 the rate of capital formation in the country. Taken
 together, our personal tax rate reductions, the new
 incentives for IRAs and Keogh accounts, the accelerated
 cost recovery system, and the enhancement of the
 investment tax credit add up, I believe, to a powerful
 collection of new incentives.
- -- Regulations have been cut back; inflation and interest rates have been knocked down from their painfully high levels. And now I think we're beginning to see the payoff with a stronger stock market and record levels of new business incorporations.
- -- Unfortunately, the prospect of large federal budget deficits over the next several years is hurting capital

- formation. We are trying hard to get those outyear deficits down.

PRESIDENTIAL TAPING: GIVE AN OFFICER A LIFE JACKET FRIDAY, JUNE 10, 1983

Thank you for this opportunity to speak with you tonight. I consider it a privilege and a duty to make this appeal on behalf of the gallant men and women risking their lives every day as members of the District of Columbia Police Force. Since I moved to this city I have come to know and work with many of them, and I respect them a great deal. As a matter of fact, I owe them my life.

That day in late March, 1981, when a confused young man fired at me outside the Washington Hilton Hotel, he also wounded three others. One was my good friend and press secretary Jim Brady, who is the honorary chairman tonight. Another was Thomas Delahanty, a D.C. policeman assigned to the protection detail that day. None of us was wearing a protective vest, and now we realize we all should have been. By the grace of God we all survived.

Thank goodness Tom is alright today, but I don't think it is fair to ask him and his brave colleagues to serve as our front line defense against crime when often they are neither armed nor protected as well as the criminals they are trying to control. Like most cities in America today, the District of Columbia is struggling to meet public needs on a limited budget. The city cannot afford to provide every officer with a life jacket, but law-abiding citizens cannot afford any less. That's why it is so heartening to see this all-star benefit Bill DeVries organized

with your support. District residents, as well as people in nearby Maryland and Virginia, have sent in their dimes and dollars. Local businesses, radio and television stations, civic and political leaders, members of our Super Bowl championship football team, some of the stars of Hill Street Blues and others have rallied behind the cause.

This is a classic and inspiring example of the American volunteer spirit at its best, our public and private sectors working together for the benefit of all our people. That kind of cooperation improves the quality of all our lives.

On behalf of American families everywhere, I would like to thank our police men and women for their individual courage in performance of their often thankless job. Someone once said that a hero isn't braver than anyone else. He's just braver 5 minutes longer. We must do everything in our power to bolster every bit of courage for good that we can. But right now, the bad guys have protective jackets and the good guys don't. Let us find a way to provide our police with the protective jackets they need to do their job.

Together we are working toward the day when men and women on the side of law and order are filled with confidence, and only the criminals are afraid. This benefit tonight brings us an important step closer. In the meantime, I would like to leave you with the words of Sergeant Esterhaus, "Let's be careful out there."

PRESIDENTIAL TAPING: NATIONAL CONFECTIONERS ASSOCIATION CONVENTION FRIDAY, JUNE 10, 1983

It is a pleasure to be able to speak with you today as you celebrate the 100th anniversary of the National Confectioners' Association. I only wish I could be there with you in person. As the man who brought jelly beans to the Oval Office, I know I would find a meeting of candy makers an unmitigated delight. But more seriously, I know you and your industry contribute significantly to our economy and the American way of life -- providing employment for nearly 70,000 people and stimulating more than 200,000 other jobs in related endeavers. You also contribute more than \$10 billion to our Gross National Product. It is because you are such hardworking and successful business men and women, entrepreneurs and capitalists, that I want to speak to you today.

Your association exemplifies what free enterprise in this country is all about. Many of the surnames represented in your group are well-known to the American public -- and they are all synonymous with great tasting confections. There are few industries in our country that can still claim such family traditions and commitment. To those second and third generation confectioners in the Conrad Hilton today I extend my sincere congratulations on your accomplishments.

This Administration came to office vowing to renew America.

As you know, by that time our economy was rapidly sliding into recession. Inflation, which had been in double digits for

2 years, had just reached a peak of 12½ percent. Interest rates had hit 21½ percent -- the highest rates since the Civil War.

Many small business men and women couldn't afford to borrow to fill their inventories. They were being strangled in a jungle of regulations and red tape and incentives were being snuffed out by suffocating levels of taxation.

In the last 2½ years, I think the record shows that we have begun to turn things around. Inflation has plummeted. Over the past year, CPI inflation has dipped to 3.9 percent and to only a 0.8 percent annual rate over the last 6 months. Interest rates are less than half what they were -- now down to about 10½ percent -- and we can get them lower still. Our painful rate of unemployment has also begun to inch downward, and the leading economic indicators have been signalling growth and renewed prosperity for the last 10 months. We have begun what I believe will be a healthy and sustained recovery.

There is still much to be done, and we will need your continued help to ensure our country stays on the road to economic health. We must convince the Congress to get Government spending under control. We are all concerned about deficits, but some people in Washington don't seem to understand where deficits come from. You know from running your businesses that what you spend must not exceed what you take in. I need your help in explaining that to the Congress. And while you're at it, I wish you'd also make clear that you think the Government is already taking in plenty. The best way to lick big deficits is discipline in the spending category — not higher taxes.

We also came to office vowing to rebuild America's defenses and, although we've made progress in that area as well, it hasn't been enough yet to make up for a decade of decline. This is one of our toughest battles, but the recent bipartisan support of the MX missile was an important step in the right direction.

The next few months will be critical for many of our programs, and I hope I can count on your support. The American people have waited too long and gone through too much for their leaders to weaken now. We must continue our struggle to return responsible economic policy, common sense and basic values to American government. If we do, we will free our people to create a new era of growth that will bring greater opportunity and prosperity to all our people. With your continued help and support, I know we can do it.

Thank you very much, and congratulations on your 100th anniversary.

PURPOSE:

To provide the President with an excellent forum to address the Jewish community on his commitment to the security of the State of Israel, as well as provide the President with the occasion to discuss his defense programs, Central American policies, as well as his domestic

agenda.

BACKGROUND:

The Anti-Defamation League of B'nai B'rith is a well established and highly regarded organization, both within and without the Jewish community. The 70th anniversary is expected to draw 1,000 attendees. The audience should be a fairly sophisticated audience.

At 3:00 p.m., Ambassador Samuel Lewis, U.S. Ambassador to Israel, is scheduled to address the convention. The President's call would come just as Ambassador Lewis is beginning to speak.

TOPICS OF DISCUSSION:

- 1. I am sorry that I could not personally be with you during your 70th annual convention. I know that Ambassador Sam Lewis is there and will be talking with you in greater detail on the U.S. policies in the Middle East.
- 2. I want to take this opportunity to state that I am personally committed to the security of the State of Israel.
- 3. I am very pleased with the recent efforts of George Shultz in working out the Israeli-Lebanon withdrawal agreement.
- 4. The bold initiative undertaken by Israel and Lebanon in this agreement is another step in achieving peace between Israel and her Arab neighbors.
- 5. Only through peace will Israel be able to achieve real security.

- 6. We are going to continue our efforts of working towards the goal of the withdrawal of all foreign forces, Syrian, PLO, as well as Israeli. As you are aware, we are undertaking serious diplomatic efforts towards that goal.
- 7. I am very concerned over the Soviet build-up in Syria and I pledge that I committed to maintaining Israel's qualitative edge in the military balance of power. In addition to the Israel-Lebanon withdrawal agreement, we are continuing our efforts to expanding the peace process by encouraging other Arab nations to recognize and negotiate with Israel. We are hopeful that there will be progress in that area.
- 8. The same forces, the Soviet Union, Libya, and the PLO, which are destablizing the Middle East, are also destablizing Central America, and I hope that you will all support this nation's efforts to combat the destablization of Central America
- ADL, on its 70th anniversary deserves the recognition as the champion of human rights. For the past seven decades, you have worked so that each member of our society has an even chance to succeed. The ADL has been an energetic ally of those who wish to eliminate inequality from our society. The quest for racial equality has been one main area in this battle. The Anti-Defamation League has stood by the principle that people should be judged on the basis of their individual worth, rather than on the basis on the basis of their ethnic or racial group to which they belong. As you embark on your next seventy years and beyond, you not only have the thanks of the American people for a job well done, but our best wishes for the future as well. May we continue to be allies in the human rights struggles that lie ahead.

Well hello and good afternoon to you all. I'm sorry I could not personally be with you during your 70th annual convention.

But let me assure you, my message will be the same.

ADL has justly earned the recognition as a champion of human rights. For seven decades, you have worked to ensure that all members of our society, no matter what their race, religion or background, have an equal opportunity to succeed. And I know you believe that all people, no matter where they live, have the right to freedom of religion. This is not a right that is any government's to give or to take away. It is our right from birth because we are all children of God.

We believe it is our duty to defend freedom -- not just here at home, but everywhere people are persecuted for their beliefs. I was very disturbed that a Soviet spokesman said earlier this week the majority of Jews who want to be reunited with their families in Israel have left the Soviet Union. This official said that the portion of the 1.8 million Russian Jews who still want to leave have, and I quote, "fallen victim to Zionist propaganda, which brainwashes them."

As you know, the National Conference on Soviet Jewry estimates that, by late 1979, at least 300,000 Jews had asked relatives abroad to send invitations needed for emigration. This was before the Soviets began blocking these invitations. But in 1975, the Soviet Government signed the final act of the Helsinki

Agreement. The Soviets pledged to deal in a positive and humanitarian spirit with the applications of persons who wish to be reunited with their families.

So let us stand together, speak the truth and tell the Soviets: stop persecuting innocent people; let Israel's children go -- or face the world's condemnation for making a mockery of an historic agreement signed by 35 nations.

I'm delighted that Sam Lewis, our Ambassador to Israel, is with you today. He will be talking with you in greater detail about U.S. policies in the Middle East.

We're very pleased with the recent efforts of Secretary
Shultz in working out the Israeli-Lebanon withdrawal agreement.
This bold initiative by Israel and Lebanon is one more step
toward a more stable Middle East. Our ultimate goal remains
peace between Israel and all her Arab neighbors. Only through
peace can Israel achieve real security. But Israel cannot make
peace alone. Other Arab states must formally recognize that
Israel does exist and that she has a right to exist.

We will continue our diplomatic efforts to seek the withdrawal from Lebanon of all foreign forces -- Syrian and PLO as well as Israeli.

But we are very concerned about the Soviet build-up in Syria. I want you to know, we are committed to maintaining Israel's qualitative edge in the military balance of power. I have personally followed Israel's heroic struggle for survival ever since the founding of the state of Israel, 35 years ago. As long as I am President, the United States will be a rock of

support. We will not waver in our commitment to protect Israel's security.

It's no coincidence that the same forces which are destabilizing the Middle East -- the Soviet Union, Libya and the PLO -- are also working hand in glove with Cuba, to destabilize Central America. I urge you to support this Nation's efforts to help our friends in Central America. The question is not, who has the most perfect democracy; the question is, who is trying to build democracy, and who is determined to destroy it. Many nations, including the United States, which once condoned slavery, have evolved into better democracies over time. But nations which fall into the clutches of totalitarianism do not become free and democratic again. And freedom cannot be lost in one nation without being diminished everywhere.

Again, as you embark on your next 70 years, you have the thanks of all Americans for a job well done, and our best wishes for the future. May we continue to be allies; may God bless you, and may He be with us in all our human rights struggles ahead.
