- I believe that communication is important and we must make our programs and our efforts known to the Hispanic community at the local level.

- Education - Re-establishing quality education with emphasis on basic skills.
- Central American Policy - National security aspect and economic impact.

I. PURPOSE

To increase public awareness of the bicentennial anniversary of the signing of the Treaty of Paris (the Definitive Treaty of Peace).

II. BACKGROUND

H.J.Res. 321 proclaims September 3, 1983, a national day of celebration of the 200th anniversary of the signing of the Treaty of Paris. The Treaty officially granted independence to the original thirteen colonies of the United States from England thereby concluding the Revolutionary War.

The Definitive Treaty of Peace was signed in Paris on September 3, 1783, by American Peace Commissioners John Adams, Benjamin Franklin, and John Jay. On the same day, another peace treaty was signed by the American ally in the war, France, and Great Britain and Spain.

The President serves as the Honorary Chairman of the National Committee for the Bicentennial of the Treaty of Paris.

A number of States and locales, such as Annapolis, Maryland, the location where the Treaty was ratified by the Congress of the Confederation on January 14, 1784, have planned appropriate ceremonies to commemorate the anniversary.

PRESIDENTIAL REMARKS: SIGNING CEREMONY FOR H.J. RES. 321
200TH ANNIVERSARY OF TREATY OF PARIS
THURSDAY, AUGUST 11, 1983

We are gathered here today for the public signing of legislation which proclaims September 3, 1983, a national day of celebration, marking the 200th anniversary of the signing of the Treaty of Paris. What the United States will observe on September 3rd is much more than the anniversary of a distant diplomatic agreement. In a real sense, the Treaty of Paris marked the moment when America officially joined the family of nations.

A long and grueling war for independence had already been fought. Risking their lives, their fortunes, and their sacred honor, our ancestors had earned their freedom in the grim privation of Valley Forge and on far-flung battlefields throughout the 13 original colonies. It had been a hard struggle, fought against what was then the mightiest empire on Earth. Without the courage of our people and their dedication to freedom -- and without the help of France, our oldest ally -- we could not have prevailed.

But on September 3, 1783, 8 years of heroic sacrifice met their just reward. The Treaty of Paris officially recognized the independence of those 13 infant States, born of pioneer strength and a vision of freedom, and opened a great new chapter in the history of the world. If July 4, 1776, is the day when the American people, represented by the Continental Congress, declared their independence, September 3, 1783, is the day when

our independence became an accomplished, recognized fact -- the true birth of a Nation forged in freedom and dedicated to a noble ideal that still inspires men and women everywhere.

It is a special tribute to the great venture that is America that in the past 200 years, as our country has grown from strength to strength, drawing on our native dynamism and the ancient ideals of western civilization, democracy has taken root in so many other parts of the world. Just 6 years after the signing of the Treaty of Paris, France began writing its own proud chapter in the history of liberty. Our English cousins, too, continued to evolve and expand their free parliamentary institutions. Perhaps the greatest tribute of all is the fact that, today, all the signatory nations of the Paris Treaty are themselves democracies -- staunch friends and allies of the United States sharing our dedication to peace and freedom.

So this bicentennial is not just a great event for America -- it is a time of celebration and rededication for all peoples who cherish our ideals and who have contributed to them here and around the world.

I am particularly glad that we can share this moment with the representatives of [foreign attendees -- England, France, Spain, etc.]. I also want to add a special word of thanks to [appropriate Members of Congress] who have done so much to make this celebration possible. Thank you for sharing this memorable moment with us here at the White House.

And now, to borrow a phrase, I am going to put my "John Hancock" on this historic piece of legislation.

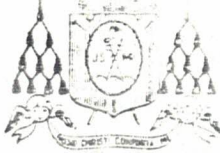

THURSDAY, AUGUST 11, 1983

Good evening. Tonight I want to thank you for your participation in the voluntary agencies and programs that are helping to make America a more healthy, prosperous and compassionate society.

Last year, in the face of hard economic times, Americans gave -- and gave generously -- even when it was hard to give. United Way campaigns raised more than one billion, seven hundred eighty million dollars -- a 6 percent increase. And because inflation was held to 3.9 percent, that giving measured the first increase above inflation that United Way campaigns have experienced in many years. The voluntary sector is doing more than ever.

Yes, America's voluntary system of neighbor helping neighbor is working. We saw the proof this year when many parts of the country were struck by natural disasters. When storms battered our West coast and floods engulfed our Southern States -- through voluntary agencies we responded to the needs of people. It seems that when the storms are the worst, the compassion and the caring -- the reaching out to help one another -- are at their best.

It's easy to see the voluntary spirit at work facing the physical disasters, but it's not so easy to see how it works combatting the quiet problems that destroy families, tragedies like drug abuse and alcoholism, or mental illness. Yet, that

same voluntary spirit is there to meet our health and welfare needs. If we didn't have a United Way, we'd have to create it.

Earlier this year, working with the Congress, I signed legislation to make available one hundred million dollars for emergency food and shelter for the needy. Those funds are already at work helping the people who need them most. The direct service agencies that United Way supports were in place. The funds were administered quickly, responding to local needs on a targeted basis: thirty-one million additional meals for the hungry and 2.2 million additional nights of lodging for the homeless are some of the results.

Our way of life, and our tradition of neighbor helping neighbor, are only possible because of our unique American system -- a precious freedom that ensures individual voluntary action, people freely working together to help each other.

I place great reliance on that voluntary spirit because I believe it brings forth the best in our national character. Out of our voluntary ranks, we always seem to find the leadership and the commitment that gives our system the vitality to crack the toughest problems -- to find answers and solutions no matter how dark the storm.

Americans have always been a giving people. As a matter of public policy, we should encourage them.

I have always believed that everyone who gives to help others should receive a tax benefit. Now, taxpayers who use the short form to file their income tax returns are able to take a deduction for a portion of their contribution. So I urge you to

exercise your individual charitable responsibility and receive that deduction. When everyone gives, everyone benefits.

We have the resources; we have the capacity to care. But we must put our faith in the basic idea of what United Way stands for. It isn't just another good cause or charitable appeal. It's a voluntary, problem-solving process in each of our local communities -- finding new ways to reach out, through traditional agencies and new programs, to deliver help to people who need it. It also offers an opportunity to experiment -- to find better ways to solve problems in the community.

So, I ask you to give, not for myself, or for the countless agencies and individuals that make up the United Way, but for the people that we can help when we work together. The challenge is no greater than the resources we hold within our grasp.

So many families and individuals need our help, and many cannot even ask. For example, I'd like you to meet Ginny . . .

. . . Her tiny legs are bound to braces. She pushes herself around with a walker. She has a life of therapy and pain before her. She'll never be like other children, but she's never stopped trying.

And we must never stop trying. We have come a long way and I see a new horizon -- a new day of prosperity and well-being for all of our people. We have truly just begun. We can know an era of service to mankind that will be unmatched in man's long trek from the shadows of poverty and ignorance to the bright sunshine of a new era that is dawning in America -- and the United Way can help lead the way.
