The American GI Forum is the oldest and one of the two largest Hispanic organizations in the U.S. It is a veterans group concerned with all issues of importance to Hispanics. I.PURPOSE: To give your personal support to the National Narcotics Border Interdiction System which you directed Vice President Bush to establish. Also to heighten awareness of the problems created by the smuggling of narcotics into the country. Politically, the visit will emphasize your commitment to the war on drugs and crime in general.

II.BACKGROUND: The National Narcotics Border Interdiction System (NNBIS) was created in March of this year by Presidential announcement, organized in the spring, and began operations in mid-June. It maximizes law enforcement effectiveness by drawing on national intelligence capabilities and military assistance to support the law enforcement elements. NNBIS coordinates activity; it does not direct agency actions.

The NNBIS Southwest Border Region extends from Brownsville, Texas on the Gulf of Mexico along the U.S./Mexico land border to the Colorado River (California/Arizona border). The Regional Center is in El Paso.

The El Paso Intelligence Center (EPIC) was created in 1974 as a clearinghouse of intelligence on drug smuggling, alien smuggling, and weapons trafficking. EPIC is staffed by nine Federal law enforcement agencies and maintains a data base on criminal activity which can be queried by law enforcement elements for tactical purposes, while providing strategic information to agencies for planning purposes.

## Suggested Talking Points for Meeting with NNBIS/EPIC

- -- Nation pleased with law enforcement personnel -- known for outstanding dedication to duty, self sacrifice, professionalism.
- -- Embarked on new coordinated effort to stop drugs -- NNBIS is opportunity to show criminals we are strong in resolve to stop their dirty business which is detriment to society -- all people are victims of greedy individuals who smuggle and peddle drugs since 40 to 60 percent of all crime is drug related.
- -- This region off to great start -- seized a ton of marijuana, 530 pounds of cocaine, and other substances -- also pleased with peripheral efforts, such as location of marijuana fields in Arizona last week -- special operations with DOD forces will pay benefits in future as we improve methods.
- -- NNBIS has been in operation for only two months, results impressive -- almost 1 million pounds of marijuana seized and destroyed -- 4500 pounds of cocaine -- 35 pounds of heroin -- other substances.
- -- EPIC holds important key to national effort to stamp out drug smuggling -- as enforcement improves, organizations will go underground. EPIC efforts will expose them to enforcement action -- improvements in intelligence which will be forthcoming thanks to Vice President Bush's focus will give you better tools to work with.
- -- Nation expects a lot -- confident you will deliver -- personally proud of you and your efforts -- keep the pressure on the smugglers -- lets keep the trend going until we stamp out problem.
