I. PURPOSE

To show support for State Senator Jim Bunning's gubernatorial bid on November 8. This is billed as a salute to President and Mrs. Reagan and is Jim Bunning's major fundraising effort.

II. BACKGROUND

The President will meet with approximately 100 people, who have paid \$3,000 per person, during the reception/photo session with the Bunning Coaching Staff. After ten minutes of meet and greet, the President will proceed to the Ballroom with Jim and Mary Bunning where approximately 1500 people, who paid \$250 per couple, are gathered for a buffet luncheon.

Jim Bunning is a native Kentuckian, 51 years old. He has nine children and seven grandchildren. His major league baseball career, spanning seventeen years, includes such honors as being the only player in major league history to win 100 games in both leagues; 9th in all-time strikeouts in major leagues; 1st player ever to pitch a no-hitter in both leagues; only player ever named chairman of the Major League Pension Fund; and he formed the first players union along with Robin Roberts and Harvey Keunn (pronounced Keen).

Jim Bunning is a businessman (stock broker) and players agent for eight major league players. He was first elected as a member of the Ft. Thomas City Council. In 1979 he won his current State Senate seat where he became Senate minority leader in his Freshman term. Senator Bunning is running for Governor against incumbent Lt. Gov. Martha Lane Collins.

Attached is biographical information on the Members of Congress who will be joining the President for his trip to Louisville, Kentucky.

Accompanying the President on Air Force I to Louisville will be Congressman Hal Rogers and Congressman Gene Snyder. Mrs. Shirley Rogers will be joining in the Presidential motorcade at the airport and traveling with the Presidential party throughout the day. No members will be returning on Air Force I to Washington.

CONGRESSMAN HAL ROGERS

(Republican-Kentucky)

Hal Rogers is a Sophomore Republican from Kentucky's Fifth District (southeastern part of state). He serves on the House Appropriations Committee.

Hal has been a strong supporter of most Administration-backed legislative initiatives. However, at various times he has expressed concern over Administration policies relating to agriculture. Hal did not support the Caribbean Basin Initiative earlier this year, for example, because he did not feel that there were adequate safeguards for domestic tobacco growers.

Hal has met with the President and attended numerous White House events. This will be his first trip on Air Force I since initially being elected to Congress in 1980.

CONGRESSMAN GENE SNYDER

(Republican - Kentucky)

Gene Snyder is an eighth-term Republican from Kentucky's Fourth District (northwestern edge of State including the area surrounding Louisville). He is the ranking Republican Member of the House Committee on Public Works and Transportation, and he is the second ranking Republican on the House Merchant Marine and Fisheries Committee.

Gene has been a consistent supporter of Administration-backed legislative initiatives, particularly with respect to defense and aggregate economic policy issues. In his leadership position on the Public Works Committee, he was particularly helpful last year during consideration of the omnibus highway bill (H.R. 6211).

Gene has attended numerous White House events and has met with the President. This will be his first trip on Air Force I during this Administration.

STATE POLITICAL BACKGROUND

- Democrats have controlled most of the state's political power since the Civil War.
- Kentuckians have voted Republican in 5 of 9 presidential elections since 1948.
- Republicans won virtually every U.S. Senate election between 1940 and the late 1960s.
- Kentucky has a 7% black population, but race relations have never really been at issue. In 1968, George Wallace received only 18% of the Kentucky vote compared to 34% in Tennessee.
- Kentucky is known for its thoroughbred horses, coal, bourbon whiskey, bluegrass and tourism.
- In the early years of the nation, Kentucky was the Golden West and its Henry Clay was one of America's greatest statesmen.
- Abraham Lincoln was born in 1809 on Sinking Springs farm on the Nolin River in Kentucky. Within a year, Jefferson Davis was born on a frontier farm in the Pennyroyal section of Kentucky.
- The Civil War caused deep splits in the state's society and politics, as Kentucky's legislature voted to align with the Union but thousands joined confederate units. Originally the state tried to remain neutral.
- Registered Democrats outnumber Republicans by a 2-1 margin in Kentucky.
- Kentucky has attracted less industry than either Mississippi or Arkansas.
- Kentucky's population grew 13.7% in the 1970s.

- Kentucky's per capita income in 1980 was only \$7,613 -- 46th among the states and down from 41st in the 1970s.
- The National Federation of Republican Women's biennial convention will be held in Louisville, October 6-8th.
- Louisville, more than a century past its days as a brawling frontier riverfront town, is now a comfortable, low-key city, generally a follower rather than a leader among America's urban centers.
- In its social history, Louisville has faced South. Its public places were not fully desegregated until after World War II. In recent years, court-ordered busing has been a major problem, especially in blue-collar neighborhoods in the South End and in neighboring Shively. The right-to-life movement is strong within the conservative Catholic constituency.
- In the late 1970s, Louisville had a reputation as "the strike capital of the world", as industrialists closed plants and few new ones opened.
- During the 1970s, the Louisville metropolitan area grew only 4.5% to 906,240. Louisville itself lost 17.5% of its population dropping to 298,451.
- Louisville has a proud literary and intellectual history, rooted in the 19th century and enhanced by the broad-minded and intelligent Germans who settled in the 1840s. The University of Louisville, formed in antebellum days, was the first municipally owned university in the United States.
- Louisville is the home of Churchill Downs where the Kentucky Derby is annually run.
- Louisville casts 57% of the vote in the 3rd Congressional District which is represented by six term Democrat Ron Mazzoli.

1984 PRESIDENTIAL RACE

- Kentucky will send 37 delegates to the 1984 Republican National Convention compared to 27 in 1980.
- President Reagan carried Kentucky with 49% of the popular vote and Jefferson County (Louisville) by a 48.4%-47.9% vote margin.

- Kentucky will choose delegates for both 1984 conventions through a caucus system.
 - Republicans: Precinct caucuses will be held March 10, followed by county conventions on March 17, congressional district conventions on May 10-12, and the state convention on May 12.
 - Democrats: Precinct caucuses will be held on March 17, followed by county conventions on March 31, and congressional district conventions on April 14. The State Executive Committee will select some delegates.
- On July 15, 1983, four top Kentucky Republican women held a news conference in support of Reagan's record on women's issues -- Mary A. Whittle, president of the Kentucky Federation of Republican Women; State Chairwoman Liz Thomas; National Committeewoman Nelda L. Barton; state Representative Pat Freibert.
- Democratic presidential activity has been limited in Kentucky. None of the 6 major candidates had made any public appearances in the state. Hollings is the only Democrat candidate running to receive a contribution from within the state. He received \$2,500 from the Public Policy Action PAC of Louisville.
- Paul Patton, former Kentucky Democratic chairman stated in a July 16 National Journal article that Glenn is the leading candidate at this time because the Democrats are looking for someone who is electable, who can beat Reagan. Patton added that he believed that Glenn is the only Democrat that could carry Kentucky.

 - 1977-79, elected to the Fort Thomas City Council.
 - 1979-present, elected to a four-year term in the state Senate in 1979 and was elected Minority Leader in 1983.

STATE POLITICAL SUMMARY

U.S. SENATE:

- Democrat Senator Walter Huddleston was last elected in 1978 with 61% of the vote over Republican Louis Guenther.
- Republican Jefferson County Judge Mitch McConnell has raised over \$500,000 to oppose incumbent Democrat Senator Walter "Dee" Huddleston. McConnell will be one of the the best prepared U.S. Senate candidates and is expected to have \$1 million in the bank by the end of the year. The National Republican Senatorial Committee has contributed \$15,000 to McConnell's campaign. Last Spring, McConnell and Bunning amicably settled a longstanding feud. He now serves on Bunning's finance committee and is doing an excellent job raising funds.

1983 GOVERNOR ELECTIONS:

- Governor John Y. Brown:
 - Incumbent Governor John Y. Brown, who was unable by law to seek a second term, may have been the biggest loser in the primary elections - he endorsed third place finisher Stumbo.
 - Brown's prestige was damaged because he was unable to lift Stumbo from the rear of the pack to the nomination.
 - Brown, who underwent triple-bypass heart surgery on June 25 then suffered respiratory complications, returned home on July 25 to resume his duties as governor.
 - Lt. Governor Collins received some unfavorable publicity when it was unclear whether she was assuming the duties as Acting Governor during Brown's absence.
 - Governor Brown has been in the newspapers this summer regarding the fact that he has lost \$1.3 million of his own money while gambling in Las Vegas.
 - During the primaries Governor Brown was critical of Lt. Governor Collins leadership experience.

- Republican: - Jim Bunning
 - State Senate GOP leader and former Detroit Tiger and Philadelphia Phillies pitcher Jim Bunning ran virtually unopposed as he won 85% of the vote over lawyer Lester Burns and newspaper publisher Donald Wiggins in the GOP gubernatorial primary.
 - State Senator Eugene "Gene" Stuart is running with Bunning for Lt. Governor, although he must be elected in his own right.
 - Bunning's name identification has been steadily climbing since the primary and is now over 60%.
 - Bunning has called for a \$1.5 million campaign spending limit.
 - If elected Bunning would become the first GOP governor since 1967 when Republican Louie Nunn was elected.
 - The major issues in the races are jobs, utilities and education.
 - Some disgruntled Republicans led by primary loser Wiggins have succeeded in getting a third slate on the November ballot for Nicholas McCubbin as the Citizens United Party candidate. One reason for their effort was their being upset about the pre-primary endorsement by the state and national Republican party organizations.
 - Bunning has received the endorsement of the Kentucky Right-to-Life PAC.
 - Bunning was Reagan's 1980 Greater Cincinnati campaign chairman.
 - Bunning has stated that he will accept no campaign contributions from utilities.
 - The main issue in the campaign is the question of leadership and who can best govern the state.
 - Bunning is giving strong support to multi-county banking. This has been a major issue and major financial disagreement between Bunning and Collins, who had formerly been against it but now says she's "open-minded" towards it.
 - Recent polling data was not as hopeful as expected.

- Former Kentucky Republican state chairman Lee Nunn, has announced that he is not supporting Bunning for governor.
 - Nunn's refusal to back Bunning stems from a long running feud with state chairman Liz Thomas and northern Kentucky's Congressman Gene Snyder. Liz Thomas also runs Snyder's northern Kentucky congressional office.
 - Former Republican Governor Louie Nunn, the brother of Lee Nunn, has announced that he will back Bunning's bid for governor.

- Debates:

- A scheduled debate sponsored by the Kentucky Association of Broadcasters was cancelled when Democrat Collins failed to accept the invitation. Bunning, however, took advantage of the television time offered to both candidates and appeared on Kentucky Educational Television in the Lexington area on Wednesday, September 14.
- A tentative debate between Bunning and Collins by the Kentucky Education Television will be held on October 12. Nicholas McCubbin's candidacy has created some difficulties in the scheduling of these debates.

- Democrat: Martha Layne Collins

- Democrat Lt. Governor Martha Layne Collins (a former schoolteacher) was a narrow 34.7%-34% winner over Louisville mayor Harvey Sloane and Dr. Grady Stumbo, who received 31% of the vote in the Democrat gubernatorial primary.
- Sloane has formally endorsed Collins' gubernatorial candidacy.
- A post-primary survey shows Collins with a higher than expected favorable rating despite her bitter primary fight.
- The Collins campaign released a July poll by the Washington firm of William Hamilton & Staff which shows the lieutenant governor with a better than 2 to 1 lead.
- The poll was taken prior to Bunning's extensive media advertising campaign and showed Collins leading Bunning at that time by a 62%-26% margin.
- Some key Stumbo and Sloane backers, as expected, have joined the Bunning campaign.
- Collins did better than expected in the primary election in conservative Democrat areas that would not generally be expected to support a woman candidate.
- Lt. Governor Collins is not expected to receive overwhelming support of feminists (who backed Sloane in the primary) due to her weak support of ERA and opposition to abortion except in cases of rape or incest.
- Teamsters Joint Council 94 (Louisville, Lexington, Paducah), representing over 30,000 workers, has endorsed Collins.
- Media has been critical of Collins this summer for her lack of access to the media.
- Both candidates, Stumbo and Sloane, that Collins defeated in the Democratic primary have endorsed Collins in statewide radio commercials that began on September 2. Democratic U.S. Senators Wendell Ford and Walter "Dee" Huddleston, are also featured in radio spots endorsing Collins.
- The state AFL-CIO and the United Mine Workers of Kentucky Coal Miners have endorsed Collins.
- Collins received criticism for not taking charge while acting governor during Governor Brown's illness this summer.

U.S. HOUSE OF REPRESENTATIVES:

Kentucky Congressional Delegation: 3 Republicans
4 Democrats

All incumbents easily won re-election.

Key 1982 Congressional Elections:

3rd C.D. Louisville area

Incumbent Democrat Romano Mazzoli handily won a seventh term in beating Republican Carl Brown by a 67%-32% margin.

4th C.D. North - Covington, Newport

Incumbent Republican Gene Snyder won a tenth term over Democratic state Representative Terry Mann by a 54%-45% margin.

6th C.D. North central - Lexington

Incumbent Republican Larry Hopkins won a third term in defeating Democrat Don Mills by a 57%-41% margin.

7th C.D. East - Ashland

Incumbent Democrat Carl Perkins, dean of the Kentucky congressional delegation, was elected to an 18th term over Republican Tom Hamby by a 79%-29% margin. This district is the most loyally Democratic in the state. Perkins has not won there since 1962 with less than 60%.

There were no legislative races in 1982. This year, the senate seats from odd numbered districts are up for election.

STATE PARTY UPDATE

- The Kentucky Republican Party will be electing a new state chairman in January, 1984.
- On August 13, the Kentucky Republican Party held their annual picnic and all Republican candidates and office holders attended.

- 1983-1984 Kentucky Republican Party goals:
 - 1983, to elect a Republican governor.
 - 1983, to gain at least 2 seats in the state Senate, hopefully 4.
 - to complete the 1984 financial and political plans (implementation to begin November 9, 1983)
 - to shore-up and strengthen the party organization especially at the precinct level by recruiting and training strong party supporters as precinct captains.
 - to organize a series of political training programs emphasizing such tasks and ballot security, get-out-the-vote, voter and absentee ballot registration. The first program was held two weeks ago.
 - to register 550,000-600,000 voters by the 1984 elections.
