I. PURPOSE

To respond to a request from Senator Garn for a meeting with members of the credit union leadership.

II. BACKGROUND

In late July, the House and Senate passed H.J. Res. 139 which designates the week of June 24, 1984 as Federal Credit Union Week in recognition of the 50th anniversary of enactment of the Federal Credit Union Act. Shortly after enactment of this resolution, Senator Garn wrote to you requesting an opportunity to bring members of the leadership of credit unions to the White House for a brief meeting.

Accompanying Senator Garn will be representatives from the National Association of Federal Credit Unions and representatives from the Credit Union National Association.

Presently, there are approximately 11,400 federal credit unions throughout the United States representing more than 26 million members.

I. PURPOSE

To respond to a request from Senator Howell Heflin for a photo opportunity with Mrs. June Collier.

II. BACKGROUND

Mrs. June Collier, a resident of Montgomery, Alabama, is President and CEO of National Industries, a manufacturing concern which produces parts for the automobile and aerospace industries. Mrs. Collier has been appointed by Secretary Baldrige as a member of the Industrial Policy Advisory Committee. She is also a founding member of the Committee of Two-Hundred, a group of women business leaders. Mrs. Collier and her husband, Ben, are active politically, and although they have been bipartisan in their support of political candidates, they are predominantly Republican and have been active in Republican activities in Alabama.

Mrs. Collier has a strong interest in women's issues -- not from the ERA point of view, but more from that of a woman involved in the business community. Senator Heflin had originally requested an opportunity for her to discuss women's interests with you. Heflin thinks Mrs. Collier would agree with many of your ideas and could be helpful to you in the Southeast. We explained this was not possible, and have arranged for Mrs. Collier to meet with a member of your staff on Tuesday, October 25. In the meantime, Heflin asked for a photo opportunity with Mrs. Collier and her husband, Ben.

Senator Heflin has been a strong supporter of your programs in the Senate, and has been particularly helpful on the MX issue.

I. PURPOSE

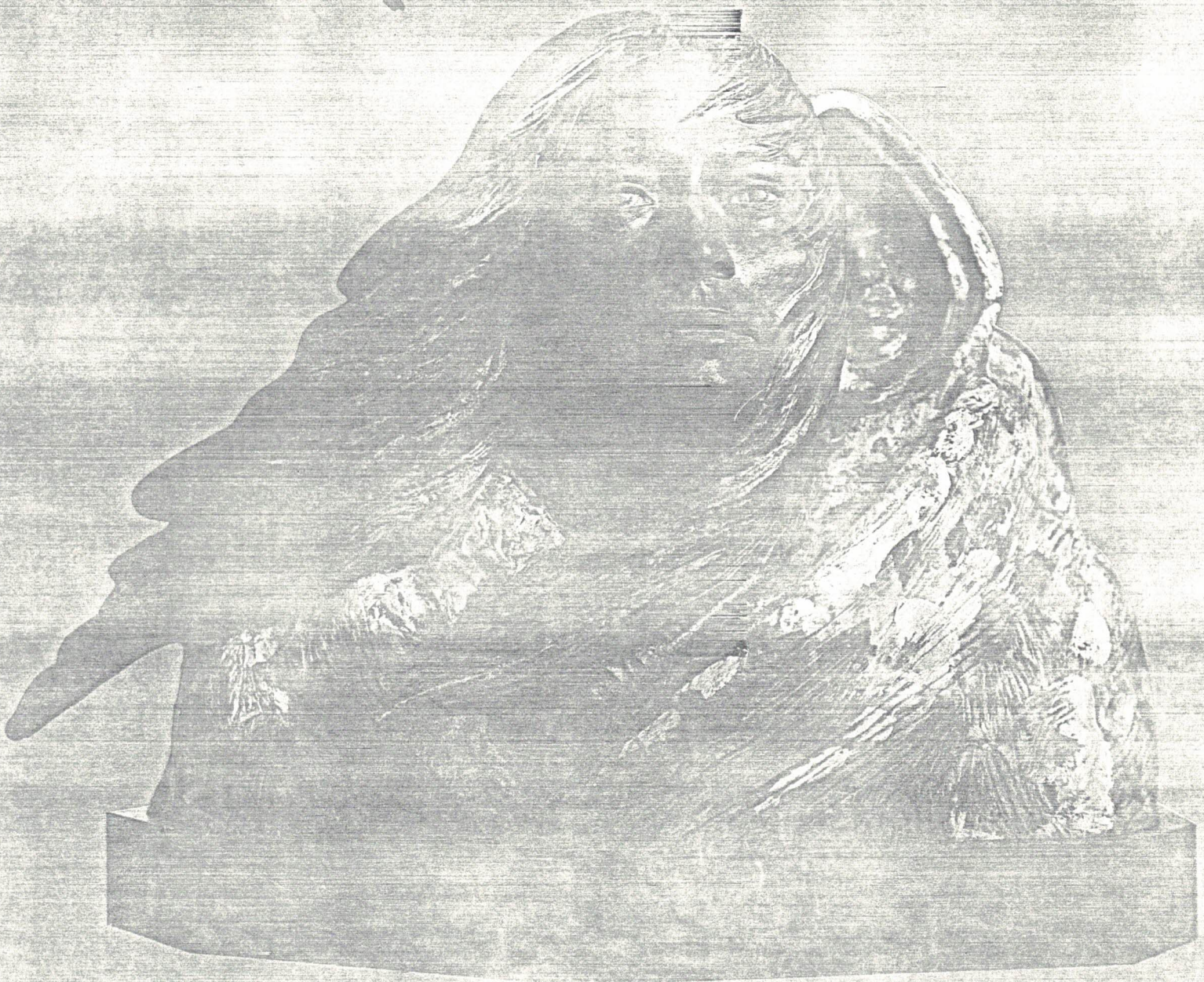

GIFT OF HISTORICAL MATERIALS
OF
CHARLES LIEN
TO THE
RONALD REAGAN PRESIDENTIAL LIBRARY

1. In accordance with the provision of Chapter 21 of Title 44, United States Code, and subject to the terms, conditions, and restrictions hereinafter set forth, I, Charles Lien (hereinafter referred to as "the Donor"), hereby give, donate and convey to the United States of America, for eventual deposit in the Ronald Reagan Presidential Library, the bronze sculpture, "Safe and Sound" (hereinafter referred to as "the Sculpture").

2. Title to the Sculpture shall pass to the United States of America upon delivery to the Archivist of the United States or his delegate (hereinafter referred to as "the Archivist").

3. Following delivery, the Sculpture shall be maintained by the United States of America and eventually deposited in the future Ronald Reagan Presidential Library, administered by the National Archives and Records Service of the General Services Administration in accordance with the applicable provisions of Chapter 21 of Title 44, United States Code, and provided that at any time after the delivery the Donor shall be permitted freely to examine the Sculpture during the regular working hours of the depository where it is presented.

4. In accordance with existing law and regulation, the Archivist may dispose of the Sculpture provided that prior to any such disposal reasonable efforts are made to notify the Donor and offer return of the Sculpture.

5. The Archivist may enter into agreements for the temporary deposit of the Materials under his custody and control in a depository administered by the National Archives and Records Service of the General Services Administration or other qualified depository.

6. In the event that the Donor may from time to time hereafter give, donate, and convey to the United States of America, for deposit in the Ronald Reagan Presidential Library, other historical materials, title to such historical materials shall pass to the United States of America upon delivery to

the Archivist, and all of the foregoing provisions of this instrument of gift shall be applicable to such historical materials. A description of the historical materials so donated and delivered shall be prepared and attached hereto.

I. PURPOSE

To provide an opportunity for you to recognize the achievement of Bill Morgan upon the completion of his cross-country walk.

II. BACKGROUND

On September 19, 1983, members of the Idaho Delegation (Senators McClure and Symms and Congressmen Hansen and Craig) wrote to you requesting White House recognition of their blind constituent, Bill Morgan. Because Bill Morgan was planning on completing his walk in Virginia, Senator Warner has also written asking you to meet with Morgan. For the past year-and-a-half, Mr. Morgan has been walking across the United States with the assistance of his white cane and guide dog. The purpose of this journey has been to focus attention on the abilities of the nonsighted and to prove that a blind person can accomplish such a feat.

Representatives of the National Federation of the Blind met Mr. Morgan at the conclusion of his walk in Baltimore on September 29. This group and the Idaho Commission for the Blind have also requested that Mr. Morgan be honored with a White House ceremony. Also, on September 6, 1983 you signed a proclamation which proclaimed October 15, 1983 of this year as National White Cane Safety Day, something which has been done for the past 19 years.

Nancy Risque

I. PURPOSE

To announce your policy decisions and views to the Republican women Members of Congress, Senate Finance Committee Chairman Bob Dole and House Ways and Means Ranking Member Barber Conable, on pending tax initiatives that would assist women in their efforts to achieve economic equality and to review briefly Administration positions and status of other initiatives aimed at economic self-sufficiency and security.

II. BACKGROUND

In March, several Republican women Members of Congress met with you to voice their concerns about, and some solutions to, the "gender gap."

You and/or your staff have held a series of meetings with the Members to discuss many of their recommended solutions that were contained in pending legislation. These include:

- Child support enforcement reform. After consultation with these Members you approved an expanded Administration bill in July. It was introduced by Barber Conable, Marge Roukema, and others in the House and by Bob Dole, Nancy Kassebaum, Paula Hawkins, and others in the Senate. This legislation is being marked up in the House. The Senate has held one hearing, and Dole will conduct others next year.

- Pension equity reform. You supported, and Treasury testified in favor of, several provisions in Senator Dole's pension reform bill, S. 19, and in the Women's Economic Equity Act, S. 888. You also forwarded a comprehensive Administration pension reform package to the House in September. All the Republican women, Barber Conable, and Labor Committee Ranking Member John Erlenborn cosponsored this legislation. Bob Dole, with many other Republicans and Democrats on both jurisdictional committees (Finance and Labor & Human Resources) introduced a clean bill that will be marked up this week. Dole is pushing very hard to achieve this legislation as soon as is possible. Your staff is lending its support to this effort.
- Non-pension tax items. There are several initiatives in this category you have considered. The major ones are:
 - Spousal IRAs -- extending to non-working spouses an IRA tax deduction equal to working spouses and changing current restrictions governing the treatment of taxable alimony for IRA deductions;
 - Child/dependent care tax credits -- would restructure the credits so that more benefits would be available for those with lower incomes and less benefits would be available for those with higher incomes; and
 - Tax treatment of unmarried heads of households -- would change the current zero bracket amount to either the same for joint returns or to an amount halfway between amounts allowed on single returns and joint returns.

Thank you, Nancy. And let me thank all the volunteers and organizations involved in this wonderful effort to save our young people, and of course I include Nancy in this for her work.

After she returns from her drug abuse trips around the country, she always brings back the most heart-wrenching stories of children lost to drugs. Yet, more and more, she also brings stories of hope and confidence that they can be saved. And that is why we have gathered here and why citizens all over the Nation will gather on two evenings in November.

Drugs are a great danger to our children. The battle is desperate. But America's answer can begin tonight. You now have our invitation to be part of it on November 2nd. On behalf of this Nation's young people, I urge you to accept. Good night and God bless you all.
