I. PURPOSE

To greet and answer questions of newly recruited regional leaders of Citizens for America who have been brought to the White House for a day of briefing and discussion of conservative issues.

II. BACKGROUND

These new volunteers will be trying to produce a bi-partisan grass roots organization designed to promote support for Conservative causes at the Congressional district level through local media, local opinion molders, and individual Congressmen.

The President has met with Jack Hume and with Lew Lehrman to encourage continued formation of this group, and to offer them his support.

- "Citizens for America" organization meeting
(Lew Lehrman, Chairman)

Good morning, ladies and gentlemen, Welcome to Washington and to your White House.

I am so pleased that you have agreed to join Lew Lehrman and his crew in undertaking this ambitious, bi-partisan effort to take the conservative message out into grass roots America. It is high time.

That message is too serious, and far too urgent to be left to the mass media for conveyance, or to the liberal interpretation of the majority of the individual members of Congress.

The people of America must be told, and the Congress made to understand, that conservatism is alive, well, and is the wave of the future.

That is why this effort is conceived as, and must remain, purely non-partisan. By-passing the media and directly informing the people and their legislators at the grass roots level is a formidable challenge. But your strength and talent, combined with Lew Lehrman's leadership, will go a long way toward making an important difference in the way society views its responsibilities, and how it responds to its future challenges.

Now, Im sure this morning's briefings, and this afternoon's schedule, have suggested some questions you might like to ask. Who will be first?

(Ed Meese will signal the end of the session by announcing either "One more questions," or "That is all we have time for.")

Depart, saying "Thanks again for your help. Good luck, God bless."

(Additional talking points if needed, and for use if Q & A session is not appropriate):

-- You have my heartfelt thanks for all you've been doing for us, and more importantly, for America.

-- In less than three years, we've begun to turn our country around. Yes, we're still wrestling with enormous problems. But I'm firmly convinced America is stronger and our freedom more secure today than it was.

-- We have an economic program designed to put people back to work and keep inflation and interest rates low: it's called economic recovery.

-- Since last December the number of people with jobs increased 2.7 million.

-- Economic growth in the second quarter surges to 9.7 percent. (7.9 in the 3rd quarter)

-- When we arrived, inflation was in double-digits. We've knocked it down to 2.6 for the last year, and 3.2 percent for the last ten months.

-- The prime rate was 21 1/2 percent. Today it's down to 11%.

-- Tax rates have been cut, productivity is growing, and America is leading the way to a worldwide recovery.

-- We're taking long-overdue steps to keep Social Security sound, reduce crime and improve education.

-- And America no longer speaks with an uncertain voice overseas. We're providing leadership to defend the freedom of the West and preserve the peace.

-- Thanks to bipartisan support, the M-X Peacekeeper program is moving forward.

-- This will give us the leverage we need to pursue real, mutual and verifiable, strategic arms reductions.

-- America still faces a mountain of obstacles. But for the first time in a long time, we're making real headway toward stronger growth, more opportunity, stable prices and safety and security for our families.

I. PURPOSE:

To thank these leaders for their hard work, and discuss future actions in light of the Senate tabling of the Tuition Tax Credit Bill -- particularly the long-term prospects for passage.

II. BACKGROUND:

The Tuition Tax Credit Coalition has met with the President on two previous occasions, June 22, 1983 and September 16, 1983. They have pledged their support for the bill our staff hammered out with them, and recommended that the legislation be attached to a major House-passed revenue bill.

On November 16, the Senate tabled consideration of the legislation. The vote was 59 to 38, with Senator Baker among those voting to table.

For some time, frustration has been high among tuition tax credit leaders. They appreciate the President's efforts, but they need assurance of continued support.

TALKING POINTS

TUITION TAX CREDITS

- Although we did not achieve victory, I am pleased that we got an up-or-down vote on tuition tax credits in the Senate.
- I was especially pleased because the various groups represented here today showed unity of purpose and a determination to work together.
- I view the Senate vote as the first step in a long term effort to get tuition tax credits through the Congress, and I am firmly committed to this goal.
- The vote indicated, however, that a lot of work still needs to be done by all of us before a winning vote can occur in the Senate.
- I have some thoughts as to what we should do next, but the main reason I have asked you to this meeting is to get your suggestions. Before I get your views, here are my thoughts.
- This IS a long-term effort and winning will require constant attention by all of us in this coalition, at every level of government and in the private sector.

- First, candidates for office must be made aware that tuition tax credits is not just another issue that came and went. You have the capability of making this issue come alive in every race.

- At the federal level, I and my staff will do everything we can to encourage and increase support in both the Senate and House for this issue. I will continue to speak out on the merits of our initiative and it will be clear to all that it remains a priority for me and for many American families across this nation.

- At the state level, supporters of tuition tax credits should take the Supreme Court's decision in the Minnesota case this year as a green light for action. The Court has opened the door for a range of State tuition tax plans that may have been stalled by fear that they would not survive Supreme Court review.

- At the local level, tuition tax credits are simply one more aspect of our overall push for parental control of education.

- We will continue our efforts to affirm that education is the primary right and responsibility of the parents and that government is here to serve the choices they make for the education of their children.

- I look forward to working with you to make this principle a reality for all students and parents.

- Those are my thoughts. Now, I want to get the benefit of your suggestions and comments.

If the President is asked to request a time-certain for another vote in the Senate, we recommend that his response follow along these lines:

- If it looks like we are making progress, then I will certainly consider pursuing another vote in the Senate.
