I. PURPOSE

To drop by a meeting of the President's Export Council and to show appreciation for the valuable work that the Council is performing.

II. BACKGROUND

The President's Export Council (PEC) is a national advisory committee on trade. It was established in 1973. You appointed the twenty-eight, private-sector members of the PEC, who serve on a voluntary basis. In addition, three congressmen, three senators and the heads of seven federal agencies are members.

Although you participated with PEC Chairman Paul Lyet (pronounced Lee-ay) last spring at an awards ceremony for exporters (President's E-Award), you have not met with the PEC since September 1981 at their swearing-in ceremony. The PEC is convening in the White House today for its semi-annual meeting.

The PEC has sent you forty letters that included recommendations on different trade policy and export promotion issues. The PEC has also held conferences with labor organizations, state legislators, and service industry executives to promote export expansion. Although not all of the PEC's recommendations have been in accord with Administration policy, you are meeting the group today to show your support and appreciation for their work.

III. PARTICIPANTS

Anna Chennault, Vice Chairman of the PEC and President of TAC International will be presiding over the meeting in the absence of Chairman J. Paul Lyet. A list of other Council members is attached.

IV. PRESS PLAN

A White House photographer will be present.

V. SEQUENCE OF EVENTS:

The meeting will begin at 9:00 a.m. in the Cabinet Room with greetings by Craig Fuller. You and Mr. Meese will enter at 9:55 A.M. You are scheduled to depart at 10:00 A.M. The members will then proceed to their all-day business meeting in the Indian Treaty Room.



SUGGESTED TALKING POINTS FOR MEETING WITH  
THE PRESIDENT'S EXPORT COUNCIL

- I am grateful to you all for the time you have contributed toward the cause of export expansion and in support of my Administration's efforts in the trade arena.

- I have asked Craig Fuller to establish a liaison here in the White House to work with you.
- With your help we can assist businesses, farmers, and workers of the country to meet the challenge of international competition. We must all work together toward the goal of free and fair trade worldwide.

PURPOSE: To congratulate him on being awarded the Winston Cup, the highest trophy and honor awarded by the National Association of Stock Car Auto Racing (NASCAR).

BACKGROUND: NASCAR has been the premier stock car racing series since 1949, holding 30 races a year nationwide, one of which is the Daytona 500. The Winston Cup is awarded annually to the individual with the highest point base acquired during the year's series of races.

Bobby Allison and his championship racing crew are receiving the prestigious Winston Cup at a Banquet at the Waldorf Astoria. The ceremony will be heard live over the Motor Racing Radio Network to 250 radio stations nationwide, in addition to approximately 1000 people in attendance at the banquet.

Bobby began his stock car racing career 22 years ago. It includes a total of 79 victories, 6 of which were this year.

Attached is biographical information on the Members of Congress participating in the President's trip to Indianapolis. Congressmen Dan Burton and Dan Coats will be traveling on Air Force I from Washington, D.C. to Indianapolis. Senators Lugar and Quayle will greet the President in Indianapolis and travel in the Limo with the President to the Convention Center. For the return trip, the President will be joined on Air Force I by Senators Quayle and Hatch and Congressmen Dan Coats and Ron Packard.

CONGRESSMAN DAN COATS  
(Republican - Indiana)

Dan Coats is a sophomore Republican from Indiana's Fourth District (northeastern corner of state, including Fort Wayne). He is a member of the House Energy and Commerce Committee, and the House Select Committee on Children, Youth and Families.

Coats consistently has supported Administration-backed legislative initiatives in the 97th and 98th Congresses. Most recently, he has devoted substantial efforts on the natural gas issue and has received some constituent criticism in this regard.

Coats has met with the President and attended White House events on numerous occasions.

CONGRESSMAN RON PACKARD  
(Republican - California)

Ron Packard is a freshman Republican from California's Forty-Third District (north San Diego area). He is a member of the House Public Works Committee and the House Education and Labor Committee.

Packard has been a consistent supporter of Administration-backed legislative initiatives in the 98th Congress. He has been particularly active in the area of education, and he will be participating in a panel the same day the President addresses the Commission on Excellence in Education.

Ron has met with the President and attended White House events on a number of occasions.

CONGRESSMAN DAN BURTON  
(Republican - Indiana)

Dan Burton is a freshman Republican from Indiana's Sixth District (Indianapolis suburbs and adjacent counties to the north and east). He serves on the House Government Operations Committee, the House Veterans Affairs Committee, and the House Select Committee on Children, Youth and Families. Dan also serves as freshman class representative to the House Republican Whip organization.

Burton has been a strong and consistent supporter of Administration-backed legislative initiatives in the 98th Congress. He has been particularly vocal in behalf of a strong national defense and deficit reduction efforts predicated on spending restraint.

Dan has attended White House events and has met with the President on a number of occasions.



SENATOR ORRIN HATCH (R-UTAH)

Orrin Hatch was born on March 22, 1934 in Pittsburgh, Pennsylvania. He worked his way through undergraduate and law school, and received a Bachelor of Science degree in history and philosophy from Brigham Young University in 1959. He was awarded a full honors scholarship to the University of Pittsburgh Law School. He earned the Juris Doctor degree in 1962. Following graduation, he practiced law in Pittsburgh, and in 1969, Senator Hatch returned to Utah and became the senior partner in the Salt Lake City firm of Hatch and Plumb.

Senator Hatch is married to the former Elaine Hansen of Newton, Utah. They have six children: Brent, Marcia, Scott, Kimberly, Alysa, and Jesse.

Senator Hatch was elected to the Senate in 1976 and is seeking re-election this fall. In the Senate, Hatch is Chairman of the Labor and Human Resources Committee, and also serves on the Budget and Judiciary Committees. In addition, he is a member of the Select Committee on Small Business.

Senator Hatch was the floor leader on the balanced budget constitutional amendment which was adopted in the Senate earlier this year. As Chairman of the Labor Committee, the Senator has championed your nominations to the Legal Services Committee, and has promised to get them reported out of Committee early next year. He also expended more time than anyone else, as a Member of the Judiciary Committee, on behalf of your nominations to the Civil Rights Commission. Senator Hatch gained considerable attention early in his Senate career as a key leader of the successful filibuster against the labor law reform legislation.

SENATOR RICHARD G. LUGAR (R-INDIANA)

Senator Richard G. Lugar was born on April 4, 1932 in Indianapolis, Indiana. He received his B.A. degree from Denison University and was a Rhodes Scholar at Pembroke College, Oxford, England where he received a B.A., M.A. He served in the U.S. Navy from 1957-1960, during which time he served as an intelligence briefer to the Naval Chief of Staff. Senator Lugar is a businessman and farmer. He has managed both a family stock and grain farm and a firm which manufactures food production equipment. Senator Lugar was elected to the Indianapolis School Board in 1964 and was elected Mayor in 1968 and reelected in 1972. During that time he served as president of the National League of Cities.

Senator Lugar was elected to the Senate in 1976, and reelected in 1982. He is a member of the Senate Agriculture Committee where he chairs the General Legislation Subcommittee, the Senate Select Committee on Intelligence where he chairs the Subcommittee on Analysis and Production, and the Senate Foreign Relations Committee where he chairs the European Subcommittee. In the Foreign Relations Committee, Senator Lugar was active in the extensive Committee debate on SALT II and has been particularly active in European and South American issues. He has been an articulate defender of Administration foreign policy.

Senator Lugar was elected by his Senate Republican colleagues to be the current Chairman of the Republican Senatorial Campaign Committee. An effective fund raiser in his own election campaigns, Lugar has succeeded in raising more money this year than in any previous year at the Senatorial Committee.

Senator Lugar is married to the former Charlene Smeltzer and they have four sons.

SENATOR DAN QUAYLE (R-INDIANA)

Dan Quayle was born in Indianapolis, Indiana on February 4, 1947. He received his bachelor's degree in political science from DePauw University in 1969 and earned his juris doctor from Indiana University School of Law in 1974.

Senator Quayle came to national prominence in 1976 when he upset an eight-term Democratic incumbent for the 4th Congressional District seat in the U.S. House of Representatives. He subsequently was re-elected to a second term in the House in 1978. Quayle was elected to the United States Senate in 1980. As a member of the Senate, he serves on the Armed Services, Budget, and Labor and Human Resources Committees. One of Quayle's major legislative interests as a member of the Labor and Human Resources Committee is job training, and you will recall that he was a key player in developing the Job Training Partnership Act last year.

Senator Quayle is married to the former Marilyn Tucker. They have three children: Tucker, Benjamin, and Corinne.

SUBJECT: INDIANA -- POLITICAL BRIEFING

### STATE POLITICAL BACKGROUND

- Indiana is probably more conservative and more Republican than any other major industrial state.
- Indiana has only chosen the Democratic presidential nominee once since 1936.
- Republicans have won 8 of 9 gubernatorial elections since 1945.
- Republicans controlled both U.S. Senate seats from 1945-1958, and since 1980.
- Indiana is the home of one of the most successful political machines of the 20th century, the state Republican organization.
- A May 1983, Market Opinion Research poll shows that Hoosiers reaching the voting age (the 18-24 age group) declare themselves to be Republicans at a rate almost double the national average - 39% statewide to 21% nationally.
- Indiana's state government has been remarkably free from scandal.
- Indiana is nicknamed the Hoosier state. The word Hoosier originated with the men working for Ohio Canal builder Samuel Hoosier in the 1820s, supposedly the hardest-working and most reliable laborers. The state adopted the term which took on the connotation of anyone of great virtue and virility.
- Indiana calls itself "the crossroads of America" for it sits astride the great east-west transportation routes, accessible to the Great Lakes and the Mississippi and Ohio River systems.
- Indiana is less urbanized and has a higher percentage of people living in rural areas than any other industrial state.
- Indiana is one of the country's most heavily unionized states ranking 6% higher than the national average.
- The September 1983 unemployment rate for Indiana was 8.9%.
- Indiana is the home of the American Legion and the birthplace of the John Birch Society.

INDIANAPOLIS

- Indianapolis is the state capital as well as the state's largest city with a population of 700,807.
- Indianapolis is the amateur sports capital of the world hosting championship tournaments in swimming, golf, track, field, judo, basketball, and figure skating. Indianapolis is the permanent home of the U.S. Clay Court Championships with a 13 acre, \$7 million complex; it has a \$21.5 million natatorium, (largest in the nation); a \$5.9 million track stadium with 20,000 seats; and a 5,000-seat velodrome for bicycle racing and speed skating.
- Indianapolis also boasts a \$77 million, 60,000-seat domed stadium which doubled the city's convention and exhibition space.
- Indianapolis is the home of the giant Eli Lilly pharmaceutical firm; the benefactor of the Lilly Endowment which poured millions into the city's community projects.
- Indianapolis was designated an All-American City in 1982.

1984 PRESIDENTIAL CAMPAIGN

- Indiana will send 52 delegates to the Republican National Convention in 1984 compared to 54 delegates in 1980.
- The district delegates to the Republican National Convention will be selected by district caucuses scheduled June 18; the at-large delegates will be chosen at the state convention on June 19, 1984.
- Indiana will cast 12 electoral votes.
- President Reagan carried the state with 56% of the popular vote, and Marion County (Indianapolis) with 53% of the vote.
- The presidential primary will be held on May 8, 1984.
- Two polls have been taken which indicate President Reagan's popularity is up in Indiana. A May poll was conducted by Market Opinion Research and a November 18 poll was conducted by the state party. A comparison of these two polls gives the following results:

STATE POLITICAL SUMMARY

## U.S. SENATE:

- Incumbent Republican Richard Lugar won re-election in 1982 to a second term by defeating Democrat Congressman Floyd Fithian with a 54%-46% vote margin. Senator Lugar is chairman of the Republican Senatorial Campaign Committee.
- Republican Dan Quayle defeated incumbent Democrat Birch Bayh by a 54%-46% vote margin in 1980.
- In state history, no Indiana Senator has ever won more than three full terms.

## GOVERNOR:

## Republican Candidates:

- Until recently the governorship was limited to one term. The first governor to take advantage of a constitutional change permitting two consecutive terms was Otis "Doc" Bowen (1973-1981). Robert D. Orr was his successor in 1982.
- In 1984, Republican Governor Robert Orr is expected to seek a second term. Republican State Chairman Gordon Durnil will be campaign manager of Orr's re-election campaign; with Don Cox serving as chairman. The campaign will be based in the Republican state headquarters.
- Orr succeeded popular Republican Governor Otis Bowen in 1980 by defeating Democrat John Hillenbrand by a 58%-42% vote margin.
- Governor Orr has the endorsement from all 92 Republican county chairmen.
- Governor Orr's re-election efforts are expected to cost more than \$2 million.
- Former state party chairman and former state treasurer John K. Snyder has announced he is a candidate for the Republican nomination for governor.
- Snyder criticizes Orr for the largest tax increase in the history of the state and for an increase in general fund spending of 28%.
- When Snyder first indicated he would run for governor, some political leaders questioned whether he would be able to obtain the necessary 500 signatures from each of the 10 congressional districts. Snyder says this will not be a problem.

- There have been some speculations that Snyder is opposing Orr because the governor failed to appoint him State Insurance Commissioner as he had promised. Snyder has denied these reports.
- Snyder's campaign is being headed by John Price, an attorney and former deputy treasurer under Snyder.
- Snyder has devised a most imaginative campaign weapon consisting of a series of cartoons featuring a dog named "Oliver P. Morton" conversing with a cardinal (the state bird). Governor Orr has a dog named Oliver P. Morton. Oliver (the dog) lambasts his "boss" for a tax hike, positions taken on utilities, state mental health problems, and the state economy, unemployment and road conditions.
- Snyder plans to raise at least \$100,000 for his campaign.

## Possible Democrat Candidates:

- The "frontrunner" for the Democratic nomination is state Senator Wayne Townsend of Hartford City. Townsend plans to stress mismanagement by the Orr administration as a major issue in his campaign. Townsend barely lost to John Hillenbrand in the 1980 primary in the gubernatorial campaign.
- Virginia Dill McCarty, an Indianapolis attorney, a former Deputy State Attorney General and former U.S. Attorney for southern Indiana, also plans to seek the Democratic nomination. U.S. Representative Andrew Jacobs is her campaign manager. McCarty has decided not to accept contributions from Political Action Committees (PACs) feeling that PACs wield too much influence in national and state politics.
- Winfield Moses, mayor of Fort Wayne.
- Pete Chalos, mayor of Terre Haute.

#### 1st C.D. Industrial Belt - Gary, Hammond

Democrat Katie Hall defeated Republican Thomas Krieger by a 57%-43% vote margin in 1982. She is the first black member of Congress from Indiana. This district traditionally guarantees a Democrat election to the House.

#### 2nd C.D. East Central - Muncie, Richmond

Incumbent Democrat Philip Sharp defeated Republican Ralph VanNatta by a 56%-44% vote margin.

Potential 1984 Republican candidates against Sharp are as follows:

- Ken MacKenzie, a Ball Corporation public affairs executive, finished second to Ralph VanNatta in the 1982 primary by a 40.5%-35.0% vote margin. MacKenzie formally announced on November 15 that he will make a second try at winning the GOP nomination. MacKenzie was endorsed in mid-May by the 2nd C.D. Republican Committee.
- William Frazier, a wealthy farmer and real estate broker; three-time general election loser to Sharp; primary loser in the 6th C.D. election in 1982; and state GOP chairman of the Conservative Caucus.



**3rd C.D. North Central - South Bend**

Incumbent Republican John Hiler won a second term by narrowly defeating Democrat state Representative Richard Bodine by a 51%-49% vote margin.

**4th C.D. Northeast - Fort Wayne**

Incumbent Republican Dan Coats defeated Roger Miller by a 64%-35% vote margin in 1982 to win a second term.

**5th C.D. North - Kokomo**

Republican Elwood Hillis defeated Democrat Allen Maxwell by a 61%-39% vote margin to win a seventh term. Hillis has built a nearly invulnerable position in Indiana.

**6th C.D. Northern Indianapolis; Anderson**

Republican Dan L. Burton defeated Democrat George Grabianowski by an impressive 65%-35% vote margin in 1982. This district is solid GOP territory.

**7th C.D. West Central - Terre Haute; Lafayette**

Republican John T. Myers defeated Democrat Stephen S. Bonney by a 62%-38% vote margin to win a ninth term. Myers is a 12 year veteran of the Appropriations Committee and senior Republican on the Energy and Water Subcommittee.

**8th C.D. Southwest - Evansville**

Two-term Republican Joel Deckard was defeated by Democrat Bloomington Mayor Francis McCloskey by a 52%-48% vote margin.

**9th C.D. Southeast - Bloomington; New Albany**

Incumbent Democrat Lee H. Hamilton soundly defeated Republican Floyd Coates by a 67%-32% vote margin to win a tenth term. He is a 20-year veteran on the House Foreign Affairs Committee and is chairman of the Europe and Middle East Subcommittee.

**10th C.D. Indianapolis**

Incumbent Democrat Andrew Jacobs, Jr. defeated Republican Michael Carroll by a 67%-33% vote margin in 1982. Jacobs is a member of the House Ways and Means Committee and is chairman of the Ways and Means Health Subcommittee.

**STATE LEGISLATURE:**

Republicans lost seats in both houses of the legislature but retained overall control. Six seats were lost in the state Senate and three seats in the state House. The current party lineup is:

State House:	57 Republicans	43 Democrats
State Senate:	32 Republicans	18 Democrats

**INDIANAPOLIS MAYORAL RACE**

- Indianapolis last elected a Democrat mayor 20 years ago.
- On May 3rd, Indianapolis voters chose Democrat John Sullivan, an attorney, to challenge two-term incumbent Republican Mayor William Hudnut. Sullivan won in a five-way Democratic primary defeating black attorney Theodore Wilson by just over 2,000 votes. Hudnut garnered 43,525 votes in the primary although he was unopposed.
- In the November 8 election, Mayor Hudnut easily won a third term defeating John Sullivan by a 2-to-1 margin (70%-29%).
- Indiana voters defeated 24 of the 81 incumbent mayors seeking re-election on November 8. Democratic gains gave the Democrats a 72 to 43 edge in mayorships over the GOP, up from 62 to 53.
- Senator Lugar was mayor of Indianapolis from 1968-76.

**STATE PARTY UPDATE**

- The state party will be focusing on the following activities this year:
  - gearing up for the 1984 gubernatorial race;
  - co-ordinating fundraising appearances by Indiana's Republican elected officials;
  - continuing efforts to strengthen their already strong county organization network;
  - continuing to update computerized voter registration and demographic lists for 1984 elections;
  - continuing county/precinct level voter registration drives;
  - conducting 1984 regional training schools.
    - The upcoming training schedule is:
      - April 7-8... The state party will host its Congress of Counties weekend. A party training and support program is scheduled at this time for all district and county chairmen and vice-chairmen.

May 18-19... Following the primary on May 8, the party will host a two-day workshop for state legislative candidates.

May 24... There will be a workshop for all new county chairmen.

May thru July... The party also intends to sponsor twelve one-day training sessions for all local level candidates at twelve different locations in the state.

July thru September... Precinct workshops will be held emphasizing registration, polling, and get-out-the-vote techniques.
