I. PURPOSE

The U.S. Advisory Commission on Public Diplomacy will present their annual report to you.

II. BACKGROUND

The U.S. Advisory Commission on Public Diplomacy is an independent, bipartisan body created by Congress to conduct a continuing overview of the U.S. Information Agency. Its members are appointed by the President and confirmed by the Senate. The Commission reports its findings and recommendations to the Congress, the President, the Secretary of State, the Director of USIA, and the American people. The Commission is chaired by Dr. Edwin J. Feulner, Jr. (Rep.), President, The Heritage Foundation.

In the report, the Advisory Commission makes a number of specific recommendations intended to upgrade USIA and the Voice of America and to give the Director of USIA a greater role in foreign policy-making. The Commission has recommended that:

- A Presidential Directive be issued implementing a Congressional intent that the Director of USIA serve as a statutory advisor to the National Security Council and as the principal advisor to the President on foreign public opinion and the conduct of public diplomacy.
- A task force be created under the National Security Council to assess the problem of semantics in the international "war of words" and propose an institutionalized means to counter misleading terminology and increase the accuracy of international political discourse.



- USIA's capability to assess the probable reaction of foreign public opinion be utilized in the making of every major foreign policy proposal or policy options study.
- A special representative of the President with the rank of ambassador be appointed to coordinate U.S. Government negotiation of VOA transmitter site agreements.
- The U.S. do more to ensure that the VOA can deliver a strong, reliable signal worldwide.
- A higher priority be given to research and development on direct satellite broadcasting (DBS) technology.

The Commission also believes that placing Radio Marti -- a new service intended to broadcast news about Cuba to Cuba -- within the Voice of America is questionable public policy that sets a precedent of uncertain consequence. The Commission recommends that USIA take care to ensure that VOA's Charter is not compromised, that Radio Marti meets the highest standards of accuracy and objectivity, and that it not become the voice of any single segment of American society.

MEETING WITH SENATOR JOHN DANFORTH (R-MISSOURI)

DATE: Wednesday, January 18, 1984

I. PURPOSE

To hear Senator Danforth's report on his recent trip to Africa.

II. BACKGROUND

On December 15, 1983, you met with Senator John Danforth, at his request, to discuss his trip to Africa which began on January 4 and ended with his return to Washington this morning. Danforth's purpose for visiting Africa was to focus on the problem of malnutrition and starvation. He made a similar trip in 1979 to Cambodia. During the past two weeks, Danforth has visited Mauritania, Somalia, and Mozambique. These countries are suffering from severe drought, and Danforth had written you on this issue in November along with several of his Senate colleagues.

Danforth will report on the overall findings of his trip, and is expected to focus on hunger problems in Mozambique. As you will see from the attached cable which Danforth sent to Secretary Shultz, he intends to recommend additional assistance for Mozambique both for direct food assistance as well as logistical assistance to assure that these food products are delivered to the needy inhabitants of that area. Danforth intends to present a short slide presentation to demonstrate the problems in Mozambique. He has expressed the hope that you would take an affirmative position on his proposal today, but AID has some problems with parts of his proposal, and you should suggest to Danforth that you will consider his proposal, but give no firm commitment at this time. Initial estimates from our Embassy in Africa indicate that Danforth's program would cost approximately \$20 million to \$30 million.

The United States is currently providing up to 300,000 tons of food to Africa in response to their drought problems. In addition, during the time that Danforth was in Africa, we have announced an additional \$32 million in drought relief for Africa.

7. TIME IS OF THE ESSENCE. IT IS MY HOPE THAT, PENDING A FAVORABLE INDICATION FROM THE GPRM, THE WHEELS CAN BE TURNED IN WASHINGTON TO PERMIT THE PRESIDENT TO ANNOUNCE THIS HUMANITARIAN EFFORT IN THE NEXT SEVERAL DAYS. MOZAMBIQUE IS UNIQUE AMONG AFRICAN NATIONS BECAUSE DESPITE SEVERAL DONORS AND PVO'S HERE NO ORGANIZED COORDINATED EFFORT IS UNDERWAY TO DEAL WITH THIS HORRIBLE TRAGEDY.

MOREOVER, THE UNIQUE NATURE AND EFFECTIVENESS OF THE U.S. RESPONSE WILL NOT BE LOST ON THE GPRM IN LIGHT OF THE CONSPICUOUS FAILURE OF THE SOVIET UNION AND ITS WARSAW PACT ALLIES IN SPITE OF THEIR MASSIVE PRESENCE HERE.

8. I UNDERSTAND THE FOOD RECOMMENDED ABOVE COULD BE COVERED BY THE SUPPLEMENTAL REQUEST FOR AFRICA NOW BEING CONSIDERED BY THE PRESIDENT. I FULLY SUPPORT THAT SUPPLEMENTAL BASED ON MY VISITS ACROSS AFRICA, AND WILL INDICATE THIS IN MY REPORT TO THE PRESIDENT. WHILE MOZAMBIQUE HAS SPECIAL NEEDS, THEY SHOULD BE SEEN IN THE CONTEXT OF AN AFRICA-WISE CRISIS WHICH IS URGENT AND DESERVING OF SWIFT US RESPONSE. DE VOS

SUBJECT: MESSAGE TO THE SECRETARY FROM SENATOR DANFORTH

1. AN ESTIMATED 300,000 PEOPLE IN MOZAMBIQUE PROVINCES OF GAZA AND INHAMBANE ARE SUFFERING FROM STARVATION REMINISCENT OF THE 1979 TRAGEDY IN KAMPUCHEA. THE LAND IS ALSO DYING. CROPS ARE WITHERED. THE APPEARANCE OF DEAD RIVERS AND LAKES MAKE A SURREAL BACKDROP FOR THE BONES OF LIVESTOCK AND BLOWING DUST. THERE WILL BE LITTLE OR NOTHING HARVESTED IN THESE AREAS IN THE COMING YEAR.

2. THE MOST HEARTRENDING SIGHT IS THAT OF THE CHILDREN. THEIRS IS THE SPECTRE OF SLOW DEATH FROM STARVATION--DISTENDED BELLIES, STICK LIMES COVERED WITH FLIES, DISCOLORED HAIR, PLEADING EYES. AN ACCOMPANYING PHYSICIAN TELLS ME THAT THESE CHILDREN WILL SURELY DIE IF NOT GIVEN IMMEDIATE EMERGENCY FOOD. THE CHILDREN AND PEOPLE OF GAZA AND INHAMBANE ARE THE VICTIMS OF DROUGHT AND WAR. THEY ARE THE VICTIMS OF A GOVERNMENT UNABLE TO HELP.

3. PEOPLE BY THE THOUSANDS HAVE ABANDONED THEIR VILLAGES FOR THE COMPARATIVE SECURITY OF GOVERNMENT ESTABLISHED COMPOUNDS. THESE REMOTE SITES ARE PROTECTED BY WELL-FED SOLDIERS. BUT THE GOVERNMENT IS UNABLE TO MOUNT A RELIEF EFFORT FOR ITS PEOPLE.

4. IN THE VILLAGE OF CHANGANINE (POPULATION 9,000), GAZA DISTRICT, THERE ARE APPROXIMATELY 3,000 PEOPLE WHO RECENTLY HAVE COME FROM THE SURROUNDING AREA TO SEEK PROTECTION FROM WARFARE BETWEEN THE GPRM AND INSURGENTS. BUT MOST OF ALL THEY SEEK FOOD BECAUSE OF THE UTTER FAILURE OF THEIR LOCAL AGRICULTURE.

5. THE LAST FOOD DELIVERY TO CHANGANINE (ONE TON OF U.S. CORN SOY MILK) WAS MADE IN NOVEMBER. THE PREVIOUS DELIVERY HAD BEEN IN SEPTEMBER. THE PEOPLE ARE EATING LEAVES, ROOTS AND NUTS. THEIR SITUATION IS DESPERATE. THE PROSPECTS OF HELP FROM THE GPRM WITHOUT INTERVENTION BY THE UNITED STATES IS NIL.

6. I PROPOSE THAT THE UNITED STATES INITIATE AN IMMEDIATE EMERGENCY RELIEF PROGRAM AS FOLLOWS:

- A. SECURE AN AGREEMENT FROM THE GPRM TO ALLOW A PVO TO COORDINATE LOGISTICS AND TRANSPORT FOR THE RELIEF EFFORT.
- B. PROVIDE ADDITIONAL FOOD CEREALS, IN CONJUNCTION WITH THE WFP AND DESIGNATED PVO IN THE APPROXIMATE AMOUNT OF 200000 TONS.
- C. PROVIDE EMERGENCY FOOD PRODUCTION ASSISTANCE,

SUGGESTED TALKING POINTS FOR MEETING  
WITH SENATOR DANFORTH

-- Jack, I know you have been pretty busy since we last met in December to discuss your trip to Africa.

-- As we discussed then, the problem of starvation in Africa is a serious one, and I look forward to hearing your observations on the situation there.

(Danforth to report on his trip, possibly including a short slide presentation. Danforth will make a pitch for increased aid for Mozambique. Open discussion to include comments from Peter McPherson and others.)

-- Jack, I really appreciate this extensive and detailed report, as well as your recommendations. As you know, we are just finalizing a number of budget submissions, including supplemental measures, and I would like the opportunity to review this a little further before making a final commitment.

-- The problems you have raised are serious ones, and you may be sure that we will review this situation expeditiously.

-- Thank you again for coming down today, and we will be in touch.
