I. PURPOSE

To consult with key House and Senate Republican leaders prior to formal submission of the Administration's Budget proposal for Fiscal Year 1985.

II. BACKGROUND

Under the present schedule, the Administration's Fiscal Year 1985 Budget plan will be formally transmitted to the Congress on Wednesday, February 1, 1984. In line with the practice observed in prior years, this meeting is intended to 1) provide the elected House and Senate Republican Leadership and Republican jurisdictional leaders on the Rules, Finance/Ways and Means, Appropriations and Budget Committees with an advance briefing on the Budget, and 2) provide these Congressional leaders with the opportunity to discuss the immediate Budget outlook and related issues with the President.

In addition to a discussion of the various components of the Administration spending plan, it is anticipated that Congressional meeting participants will be particularly interested in the following: 1) the outlook and strategy for the deficit-reduction "down payment" effort; 2) the appropriate response to House Democratic leaders who have indicated a possible willingness to provide line-item veto authority on an "experimental" basis during 1984; 3) the appropriate manner of dealing with the Administration's balanced budget initiative in the Congress; and 4) the relative priority of these efforts. It is expected that meeting participants will want to discuss what budget items are negotiable, especially our flexibility on the defense and tax issues.

TALKING POINTS
FOR
GOP CONGRESSIONAL LEADERSHIP MEETING
January 31, 1984

- o I'm pleased that you were all able to join us here this morning for advance discussions on the budget.
- o Our Party has always been united behind the call for fiscal discipline at the Federal level. As we go into this election year, it's important for us to remain united behind the policies that have worked so well for our party -- and the Nation -- in the past.
- o First and foremost, that means ensuring that adequate resources are provided for our Nation's defense. While the budget I will send you tomorrow reflects some economies we've been able to find in that area, it doesn't scrimp on essential readiness-related programs, or curtail needed systems development.
- o Second, the Budget I am transmitting tomorrow stands fast on the principle that our budget problems can be solved without new taxes. It's only fair to ask that government be asked to tighten its own belt before we ask the taxpayers to take their own belts in another notch.
- o To do this, we need to keep domestic spending under sharp control -- and much remains to be done in this area. Over the last three years, we've made tremendous progress in this direction. Together, we've eliminated the explosion in domestic spending of the 1970's, and levelled off the excessive growth in entitlement spending.
- o The budget I'll be sending you tomorrow outlines the next steps in this direction -- steps that I believe can and should be enacted this year. If adopted, they would freeze the real growth of domestic spending for the remainder of this decade.
- o Even if this objective is reached this year, we'll have our work cut out for us -- for it will take more than a decade-long spending freeze to eliminate deficit spending. As I said in my State of the Union address, I'm willing, if you are, to discuss a "down payment" on these needed steps this year.

LEBANON

- Do you feel the American people support your policies there?

POLISH SANCTIONS

BACKGROUND

In December, I stated "we will give immediate and serious consideration to the issues raised by Lech Walesa." We have also has taken note of some positive developments in Poland such as the release of the vast majority of political prisoners and the successful visit by His Holiness Pole John Paul II. It is the my hope that the Administration's action will help contribute to the process of reconciliation and the improvement of human rights in Poland.

Very serious human rights problems remain, such as those still imprisoned and their treatment, and the pending trials of the 11 KOR and Solidarity activists. We will continue to do what we can to encourage a policy of reconciliation in Poland.

SANCTIONS

Sanctions remaining in place are:

- A freeze on new credits.
- The suspension of Poland's MFN status.
- Opposition to Poland's membership in the INF.
- Suspension of landing rights for regularly scheduled flights for the Polish airline, LOT.
- Suspension of travel between the two countries under the Maria-Sklodowska-Curie joint travel fund which finances joint scientific research projects.
- Suspension of the Export-Import Bank's line of credit insurance for Poland.
- Curtailment of the shipment of non-humanitarian agricultural commodities for distribution by the Polish Government.

Last November I announced that the Polish Government could enter into discussions with private fishing companies about potential fishing arrangements, but the sanction itself was left in place. The sanction has now been formally lifted.

Foreign Policy Priorities For The Future?

- Establish a more stable basis for peaceful relations with the Soviet Union;
- Strengthen allied relationships across the board;
- Achieve real and equitable reductions in the levels of nuclear arms;
- Reinforce our peacemaking efforts in the Middle East, Central America, and Southern Africa;
- Assist developing countries, particularly our neighbors in the Western Hemisphere; and
- Assist in the development of democratic institutions throughout the world.

Foreign Policy -- A Campaign Handicap?

- Proud to run on foreign policy record of accomplishments, and goals for the future.
- But politics should stop at the waters' edge.
- America is stronger, safer now.
- Alliance partnerships are working, Atlantic and Pacific.
- Seeking to maintain our security, preserve peace, solve problems, reduce tensions and improve the lot of people everywhere.
- Bipartisan approaches have worked: Scowcroft and Kissinger Commissions, the Lebanon Joint Resolution.
- Progress in East-West relations, Middle East, Central America and elsewhere more likely if we continue on the path of bipartisanship.
- World won't stand still until 1985 waiting for our election. Will continue to do what is right, regardless of politics.

Isn't Lebanon your Achilles heel?

-- Stability in Lebanon is key to avoiding war between Israel and Syria.

-- Stability in Lebanon is threatened by the spectre of Syrian intervention and the menace of state-sponsored terrorism.

-- If terrorists prevail in Lebanon, they will be emboldened to challenge objectives of free peoples around the world.

-- We cannot simply walk away from the commitment we have undertaken to help resolve Lebanon's tragedy.

-- We do not intend that our forces should remain in Lebanon indefinitely. On the contrary we will leave just as soon as we are assured of progress on the diplomatic front.

-- Our steadfastness is critical to the peace and stability of the entire Middle East, a region vital to U.S. and Allied security.

-- Our presence provides confidence to the Government of President Gemayel enabling him to deal fairly with the legitimate demands of the opposing factions.

-- If we leave precipitously we will be seen as an unreliable partner in the quest for peace and security in the Middle East.

-- Withdrawal under pressure would lead others in the Middle East and in the world who rely on U.S. leadership and support to question the value of that support.

What makes you think the Soviets will be more cooperative -- you have no new proposals, only a military buildup which they may decide to match in an arms race.

-- Our strategic programs are designed to restore the balance, not achieve superiority.

-- We have made new proposals:

- a new one in INF, just before they walked out;
- a suggestion in the last round of START that they discuss tradeoffs between areas where they have the advantage (land based ICBMs) and those where we are ahead (bombers and cruise missiles)
- they've agreed to resume MBFR talks, as we requested.
- we've made progress in hotline talks, and next round of these technical discussions is set for Moscow in the near future.

-- Soviets must decide on their response. We should not expect instant cooperation. Their system turns slowly -- like a large ship changing course.
