SUGGESTED TALKING POINTS FOR MEETING WITH
NINE GOVERNORS ON TAX REFORM

- Thank you all for coming. I know for many of you this is an especially busy time as legislatures finish up, and new fiscal years start, so I'm doubly appreciative.
- Thank you, likewise, for your interest in Tax Reform.
Yo! Leadership ~~from outstanding governors like you~~ will be indispensable to our success.
- I've been working hard to build support for the proposal. By the way, Jim (Governor Jim Martin, R-NC), I'm sorry we couldn't work out that stop we were hoping to make in your state. Chuck (Governor Robb, D-VA), Dick (Governor Thornburgh, R-PA), and Bob (Governor Orr, R-IN) thank you for making my trips to your states so successful.
- You all know what we're trying to achieve: fairness, simplicity, lower tax rates for economic growth.
- You also know that repealing the deduction for state and local taxes is necessary to make these goals a reality. I know that, as governors, you're coming under special pressure on this point, and I deeply appreciate your courage in standing fast.

- It hasn't been that long since I was a governor, and I know what you go through putting a budget together. I'm convinced that our proposal, by reducing federal taxes for most people in every state, would make your job easier, not more difficult as some have suggested.

- I know that our proposal will have different implications in different parts of the country. I'd like to hear your comments on the plan and on the way it's being received in your state.


