PURPOSE:

To ask him to serve as United States Circuit Judge for the District of Columbia Circuit

TOPICS OF DISCUSSION:

- 1. Since 1977, Mr. Scalia has been a Professor of Law at the University of Chicago Law School. In addition, he was a Visiting Professor at Stanford University Law School from 1980 to 1981. Prior to joining the faculty at the University of Chicago, he was a Resident Scholar, American Enterprise Institute, 1977; an Assistant Attorney General, Office of Legal Counsel, U.S. Department of Justice, 1974-1977; Chairman, Administrative Conference of the United States, 1972-1974; General Counsel, Office of Telecommunications, Executive Office of the President, 1971-1972; a member of the Summer Faculty, Office of Hearing Examiners, U.S. Civil Service Commmission, 1970; a Professor of Law, University of Virginia Law School, 1967-1971; a Sheldon Fellow at Harvard University, 1960-1961; and an Associate, Jones, Day, Cockley & Reavis, 1960-1967.
- 2. He attended the Georgetown University from 1953 to 1957 when he received an A.B. degree. He attended the University of Fribourg, Fribourg, Switzerland from 1955 to 1956. He attended Harvard Law School from 1957 to 1960 when he he received his LL.B. degree. He was admitted to the Ohio State Bar in 1962.
- He is married, his wife's name is Maureen, they have nine children and reside in Chicago.
