THE SO-CALLED HUMAN RIGHTS CAMPAIGN FUND IS A THREAT TO
THE AMERICAN FAMILY

WE OF THE FAMILY DEFENSE COALITION REPRESENT JEWISH,
 EASTERN ORTHODOX, PROTESTANT AND CATHOLIC AMERICAN FAMILIES
 FROM THE LARGER RELIGIOUS COMMUNITY IN NEW YORK STATE. WE ARE
 HERE TODAY TO CONDEMN THE ROLE OF PORNOGRAPHIC PROFIT IN THE
 FINANCIAL OPERATIONS OF THE SO-CALLED HUMAN RIGHTS CAMPAIGN FUND.

WE FURTHER CONDEMN ITS PUBLIC ASSOCIATION WITH DISEASE
 PROFITEERS, SUCH AS MULTI-MILLIONAIRE PUBLISHER AND INVESTOR,
 JOHN W. (JACK) CAMPBELL OF MIAMI, FLORIDA WHO OWNS THE
 "CLUB BATHS" IN 41 CITIES IN THE UNITED STATES AND CANADA.
 THE CORRELATION BETWEEN PROMISCUOUS HOMOSEXUAL ACTIVITY AND
 THE SPREADING AIDS EPIDEMIC IS SO OBVIOUS THAT ACCORDING TO
 THE DAILY NEWS EVEN PRO-HOMOSEXUAL GOVERNOR MARIO CUOMO
 "MAY CLOSE BATHS." IN NOVEMBER 1981 IN TORONTO, CAMPBELL WAS
 FINED \$40,000 AFTER PLEADING GUILTY TO "CONSPIRING TO POSSESS
 PROCEEDS FROM CRIME" FROM HIS CANADIAN BATHHOUSE OPERATIONS.
 INDEED, THOUGH HE ADMITTED BEFORE THE CANADIAN COURT THAT
 HE WAS "EMBARRASSED BY THE ANTI-SOCIAL ACTS," HE SITS
 WITH HONOR AS A PUBLIC SPOKESMAN FOR THE CAMPAIGN FUND,
 WHICH ORGANIZATION CONTRIBUTED TO THE CONGRESSIONAL CAMPAIGNS
 OF OVER 114 DEMOCRATIC PARTY CANDIDATES IN 1982. YET CAMPBELL
 IS NOT ONLY A FORMER BOARD MEMBER OF THE NATIONAL GAY TASK

FORCE AND NOW REGIONAL VICE CHAIR OF THE NATIONAL ASSOCIATION OF GAY AND LESBIAN DEMOCRATIC CLUBS, HE IS ON THE BOARD OF THE HUMAN RIGHTS CAMPAIGN FUND.

THERE IS MORE. JIM FRENCH OF THE "COLT STUDIO" IN LOS ANGELES, CALIFORNIA IS ANOTHER CAMPAIGN FUND BENEFACTOR. COLT STUDIO IS A NATIONAL HOMOSEXUAL PORNOGRAPHY OPERATION WHICH PRODUCES AND DISTRIBUTES INTERSTATE AND THROUGH THE MAIL SEXUALLY-EXPLICIT FILMS, VIDEO CASSETTES AND "SKIN" MAGAZINES, AS WELL AS SLIDES AND PHOTOGRAPHS OF PEOPLE ENGAGED IN SODOMY AND MASTURBATION. COLT "MODELS" ADVERTISE IN HOMOSEXUAL PUBLICATIONS AS MALE PROSTITUTES, IN FACT, AND PROBABLY IN LAW. THE 1.7 BILLION DOLLAR A YEAR PROFIT FROM MALE PROSTITUTION IN THIS COUNTRY IS NOTHING SHORT OF A PUBLIC DISGRACE--IN PARTICULAR BECAUSE IT INVOLVES TENS OF THOUSANDS OF TEEN AND PRE-TEEN YOUNGSTERS FROM AMERICAN FAMILIES. THE FAMILY DEFENSE COALITION CALLS UPON ALL MAJOR PRESIDENTIAL CANDIDATES TO PRODUCE A PROGRAM OF ATTACK AGAINST THIS HORRIFYING EXPLOITATION OF CHILDREN, BOTH MALE AND FEMALE.

WE FURTHER CALL UPON BOTH POLITICIANS AND ALL OF SOCIETY TO CONDEMN THE INTERNATIONAL GAY ASSOCIATION AND THE NEW YORK COMMUNITY COUNCIL OF GAY AND LESBIAN ORGANIZATIONS FOR THEIR OFFICIAL RECOGNITION OF THE NORTH AMERICAN MAN/BOY LOVE ASSOCIATION WHICH OPENLY ADVOCATES HOMOSEXUAL PEDOPHILIA WITH CHILDREN AS YOUNG AS FIVE.

MEANWHILE, EPISCOPAL BISHOP THE RT. REV. PAUL MOORE, JR. INTENDS TO GIVE THE OPENING INVOCATION AT THE CAMPAIGN FUND DINNER, AND HE SERVES ON THE ADVISORY BOARD OF THE CAMPAIGN FUND ITSELF. THIS IS NOT THE PERVERSE CONTRADICTION THAT IT APPEARS TO BE AT FIRST GLANCE. THOUGH THE BISHOP MAY NOT BE AWARE OF IT, WALL STREET'S INFLUENTIAL AND PRESTIGIOUS TRINITY CHURCH CORPORATION, WHICH IS UNDER THE BISHOP'S JURISDICTION, IS THE OWNER OF A BUILDING AT 155 AVENUE OF THE AMERICAS IN NEW YORK CITY WHICH HOUSES A NATIONAL INTERSTATE PORNOGRAPHY EMPIRE HEADED BY GEORGE MAVETY. MAVETY'S MODERNISMO PUBLICATIONS AND HUDSON COMMUNICATIONS PUBLISH AND DISTRIBUTE INTERSTATE AND

THROUGH THE MAIL SEXUALLY-EXPLICIT HOMOSEXUAL MAGAZINES SUCH AS STUDFLIX,
JUST MEN, MANDATE, HONCHO AND PLAYGUY. FURTHER, THE BISHOP'S TENANT IS
CHAIRMAN OF THE BOARD OF TORSO MAGAZINE.

THIS IS A PUBLIC SCANDAL. NEITHER BISHOP MOORE'S IGNORANCE NOR HIS
APPROVAL IS ANY EXCUSE. THUS, RATHER THAN JOIN PORNOGRAPHERS AT THE CAMPAIGN
FUND DINNER, BISHOP MOORE SHOULD PUBLICLY AND IMMEDIATELY SEVER ALL TIES
BETWEEN HOMOSEXUAL PORNOGRAPHY AND THE EPISCOPAL CHURCH.

IF HE CANNOT DO THIS, IT IS HIS DUTY TO RESIGN HIS BISHOPRIC, AND WE IN
THE FAMILY DEFENSE COALITION CALL UPON HIM TO DO EITHER ONE, OR THE OTHER.

AS FOR THE REV. JESSE JACKSON, RELIGIOUS AMERICAN FAMILIES EXPRESS OUR
SHOCK AT HIS PANDERING TO THE "PRO-CHOICE" MILITANT FEMINISTS, BOTH BECAUSE
UNTIL HIS DECISION TO RUN FOR OFFICE HE WAS AN ELOQUENT SPOKESMAN FOR THE
RIGHTS OF THE UNBORN, AND BECAUSE BY HIS OWN TESTIMONY HE WAS HIMSELF NEARLY
A VICTIM OF ABORTION. THAT HE IS CAPABLE OF SUCH A PROFOUND BETRAYAL OF
PRINCIPLE FOR THE SAKE OF VOTES MAKES HIS APPEARANCE AT THE PORNOGRAPHY-SUPPORTED
CAMPAIGN FUND DINNER TOO SADLY COMPREHENSIBLE.

THE CLERGY AND LAITY REPRESENTING THE FAMILY DEFENSE COALITION FURTHER
CALL UPON BISHOP MOORE, REV. JACKSON, AND ALL RELIGIOUS AND POLITICAL LEADERS,
TO REPUDIATE THEIR SUPPORT OF LEGAL ABORTION, AS WELL AS THEIR TACIT SUPPORT
OF PORNOGRAPHY--AND NOT LEAST, TO BREAK OFF ANY FORMAL RELATIONSHIP WITH THE
SCANDALOUS HUMAN RIGHTS CAMPAIGN FUND. WE DO THIS IN THE NAME OF THE AMERICAN
FAMILY WHO SUFFER THE MOST BITTERLY FROM THESE ATTACKS UPON ITS INTEGRITY.
