Biographical Material

KAORU "KAY" MURAKAMI
International President

Kaoru "Kay" Murakami, of Kyoto, Japan was inaugurated as the 65th President of The International Association of Lions Clubs at the conclusion of the Association's 64th Convention held in Phoenix, Arizona, USA, June 20, 1981.

A Lion since 1954, President Murakami is very active in his community. He is Vice President of the Urasenke Foundation, a Japanese Tea Culture Association which is a worldwide organization of more than four million members, a professor at the Urasenke College of Tea Ceremony, member of the Council of the Kyoto Foreign Language University, advisor to and member of the Editorial Committee of the Yukan Kyoto Press, Director of the Kitano Shinto Shrine in Kyoto, and Director of the Dog Leader Training Institute for the Blind.

Lion Murakami, the first Oriental to serve as President of the Association, brings with him a rich and varied background as a resource to aid him in his role as President of the world's largest service Club organization.

A former Public School teacher in Kyoto, President Murakami has held positions as Director of the Public Relations Department and

Vice-Director of the Politics and Economic Department of Miyako Press, and Chief of Adult Education, Public Relations and Tourism Sections of Kyoto City. He received his Bachelor of Law degree from Ritsumeikan University and has studied International Relations at Long Island University in New York, USA.

A writer, with over two hundred essays published in magazines and newspapers, Lion Murakami's published works include "New Faces of America," "Public Relations in the U.S.A.," "My Lionism" and the "Sayings of Melvin Jones."

President Murakami's theme for his year in office "People at Peace" reflects his philosophy of Lionism as a way in which the people of the world can find peace - within themselves - through service to others.

International goodwill and understanding are also high on President Murakami's agenda. "I want my term as International President to serve as a bridge of understanding between the East and the West."

For his active participation within the Association, Lion Murakami has received eight International President's Awards, three Extension Awards, the Ambassador of Goodwill Award and is a Key Member and a Melvin Jones Fellow. He has received the Keys to many cities and is an honorary citizen of the state of Texas and an honorary Senator of the state of Louisiana, USA.

President Murakami and his wife, Shoko, are the parents of three sons.




The opportunity that I had in the Rose Garden last week was one of the greatest experiences that I have ever witnessed. Even though the respect for your office has always been a personal pride, the realization of the power of an individual was overwhelming.

PRIORITY ON KENTUCKY

ROTARY FOUNDATION SCHOLARSHIP

PURPOSE

The Rotary Foundation seeks to promote understanding and friendly relations between peoples of different nations through scholarships for one academic year of study in another country. A scholarship recipient is expected to maintain high standards of academic achievement while serving as an unofficial "ambassador of good will" between the peoples of the sponsoring and host countries. During the year of study in a foreign country, Foundation Scholars are expected to be outstanding ambassadors of good will in interacting and communicating with the people of the host study country and through both informal and formal appearances before Rotary clubs, school and civic organizations and other forums.

FIELD OF STUDY

A Graduate or Undergraduate Scholarship may be awarded for any field of study.

QUALIFICATIONS

In order to serve as an effective bridge of friendship and understanding between peoples of his home and host countries, a scholar must have a friendly, outgoing personality, a sympathetic interest in the attitudes and way of life of the people of a different culture, and the ability to communicate his ideas readily and effectively.

To achieve this goal, he must be proficient at the time of application in the language of each proposed study country and study institute. He must understand the history, culture and current affairs of his own country. Finally, he must be physically and mentally able to carry on a rigorous year of study and travel in another country.

SELECTION

I applied for a Graduate Rotary Scholarship through the East Chapel Hill Rotary Club. Through a series of panel interviews, I was chosen from a group of 20 candidates to compete for the District #771 nomination for the 1983-84 Graduate Rotary Foundation Scholarship.

At the District level, I was interviewed by a selection committee consisting of educators and professionals from the District's Rotary Clubs. The committee selected me out of 22 nominees as its principal candidate to compete at the national level for the Graduate Rotary Foundation Scholarship. My selection as a national candidate was based upon my past travel experience, academic achievements and cross cultural communication skills.

In September of 1982, I was awarded a Graduate Rotary Scholarship to study Race Relations and Linguistics at the University of Minas Gerais at Belo Horizonte in Brazil. My assignment was based on institutions which I felt would be beneficial to me in my studies, and my background in Portuguese. I chose Brazil as my first choice country in which to study because of my interest in the common history and heritage the U.S. shares with Brazil.

Politically, the relationship between the U.S. and Brazil is not as good as it has been in the past. This is primarily due to misunderstanding and a lack of communication on both parts. Although I am speaking of this problem on the government level, an atmosphere of mutual misconception has filtered down to the citizens of each country.

What I hope to accomplish in Brazil is to gain a basic understanding of the affects of colonization on the societal structure of the country. More specifically, through interaction with black, white, indian and mulattoe families I want to observe and understand how slavery has influenced the Brazilian lifestyle. I believe that this is a very fascinating and valuable area to study because Brazil, with a colonial history very similar to the United States, has had a very different outcome in term of race relations.

- Coordinated Press Credential clearance and distribution for Vice President George Bush's visit to Raleigh, North Carolina.
- Directed Press Corp during Vice President's visit.
- Assisted White House Vice Presidential Advance Team and the Secret Service during Vice President's visit.
- Answered reporters questions about campaign, candidate, etc.
- Critiqued candidate's speeches.
- Learned Federal Elections Committee and Federal Communications Commission Regulations

A PROCLAMATION

Motivated by their creed "Service to humanity is the best work of life," hundreds of thousands of Jaycees have voluntarily contributed their energy to a wide variety of humanitarian projects, and have thereby enriched their own lives.

In recognition of the accomplishments of this organization, the Congress of the United States has, by Senate Joint Resolution 240, authorized and requested the President to issue a proclamation designating the week beginning on January 16, 1983, as "National Jaycee[®] Week."

NOW, THEREFORE, I, RONALD REAGAN, President of the United States of America, do hereby designate the week beginning January 16, 1983, as National Jaycee Week, and I call upon the people of the United States to observe that period with appropriate programs, ceremonies and activities.



BUSINESS PRINCIPLES AND ETHICS

of the

National Fraternal Congress of America

Our Object. To unite all Fraternal Benefit Societies of America, operating on a legal reserve basis, for the purpose of mutual interest, information, improvement and benefit and for the concert of action in harmonious, united and loyal effort for the prevention of all things tending to injure their progress.

Toward the accomplishment of this end the National Fraternal Congress of America hereby established the following Declaration of Business Principles and Ethics as a guide for the conduct of the member societies.

Relation to the Public We express our gratitude to the public for the confidence that has been shown in the Fraternal Benefit Societies. We appreciate the fact that millions of men, women and children have purchased their life protection and created estates for their own old age benefits through membership in our organizations.

We pledge to the public that we shall continue to so conduct the business affairs of the entire Fraternal Benefit System that its best interests will be preserved. Security of the protection is the prime requisite of life insurance. Our efforts shall ever be directed to preserve that security of the protection and at the same time promote the fraternal spirit that has always prevailed in the lodge rooms of our Societies.

Relation to the Member Societies The Fraternal Benefit System has been able to accomplish many worthwhile things because of a united effort. The confidence of the public has been obtained because of this united action. Greater things will be made possible in the future by cooperation.

We pledge ourselves to so conduct our business affairs that we will be fair and honest in all our dealings with other societies. We agree that we will never tolerate any person who misrepresents facts about any competitive society.

We believe that the greatest good can come about through a united effort to transmit to the public a true story of the sound values found in Fraternal Life Insurance protection.

Relation to the State and Nation We recognize the fact that Life Insurance has gained a high public interest. We realize that regulation is not only necessary but desirable. We shall therefore constantly strive to intelligently comply with the laws and regulations under which our business is conducted. We pledge our united support to the Insurance Departments in their efforts to keep Life Insurance on a high business basis.

We are ever cognizant of the opportunity before us, through our lodge system, to be of tremendous assistance in spreading the principles of loyalty and devotion to our constitutional and democratic forms of government. We pledge our organizations to a program of promoting a greater appreciation of the opportunities found in the democracies of the North American Continent.

Relation to the Membership We acknowledge the loyalty, devotion and interest of our membership to the Societies of which they are members. The assistance that has come from the members of our societies has been of importance in the program of building bigger, better and finer organizations.

We assure our membership that it will be our purpose, in the future, to so conduct the business of the Fraternal Benefit Societies that other men, women and children will be able to secure for themselves and their beneficiaries life protection which will be secure and everlasting.

We shall continue to promote fraternal activities, in addition to the insurance protection, which will bring joy, pleasure and happiness to ourselves and others.

Relation to the Field Force We acknowledge the importance of the Field Forces to our organization. We realize that they must devote many long hours to securing new members and selling life insurance protection, as well as promoting fraternal and lodge activities.

We admonish our Field Workers to: (1) Be honest, fair and upright in all their dealings with the members, the public and competitors; (2) Present all facts accurately to the policyholder or the prospective policyholder; (3) Give themselves unselfishly to their profession as life insurance counselors; (4) Be enthusiastic supporters of the plan of Fraternal Life Insurance; and (5) Be loyal to their respective organization and its management.

We pledge ourselves to make an honest effort to employ only men and women who will bring dignity and honor to our associations.

AIMS AND PURPOSES

The National Fraternal Congress of America is the national association through which, since its organization on November 16, 1886, the fraternal benefit societies of the United States of America and Canada (which comprise the Fraternal Benefit System) have worked toward the following aims:

1. To promote the general welfare of the Fraternal Benefit System in all matters of mutual concern and public interest.
2. To disseminate to the general public information regarding the Fraternal Benefit System.
3. To render service to its members and, in general, lend assistance to all fraternal benefit societies.

Any fraternal corporation, society, order or voluntary association without capital stock, organized and carried on solely for the mutual benefit of its members and their beneficiaries and not for profit, and having a lodge system with ritualistic form of work and a representative form of government, and which shall make provision for the payment of death, sick or disability benefits, or both, is eligible for membership in this association.

CONSTITUTION OF THE NATIONAL FRATERNAL CONGRESS OF AMERICA

Adopted September 21, 1977
(Amended at Toronto, Ontario, Canada, September 21, 1978)
(Amended at St. Louis, Missouri, October 3, 1979)
(Amended at San Diego, California, September 30, 1981)

ARTICLE I

Name and Location of Headquarters

This Association shall be known as the National Fraternal Congress of America. Its Headquarters' Office shall be in the state of Illinois.

ARTICLE II

Object of the Congress

The object of the Congress shall be to promote the general welfare of the Fraternal Benefit System by uniting fraternal benefit societies in all matters of mutual concern and public interest.

ARTICLE III

Membership

Any fraternal benefit society legally authorized to transact any forms of life, health or accident insurance business in the United States or in Canada that meets and agrees to follow the Business Principles and Ethics prescribed by the Congress may be admitted to membership at a meeting of the Congress or by a unanimous vote of those present at any meeting of the Board of Directors.

All applicants for membership shall complete and sign the forms of application provided by the Congress and submit the application to the Congress.

ARTICLE IV

Meetings

A regular meeting of the Congress shall be held beginning on the Sunday preceeding the fourth Monday of September each year at such place as may be selected by the Board of Directors. The Board of Directors shall have the power to change the time and place of meeting, notice of which change shall be mailed to all member-societies at least thirty days prior to the new date of such meeting.

A special meeting of the Congress may be called by the Board of Directors and shall be called upon the written request signed by the Presidents and Secretaries of the majority of the member-societies. Notice of such special meeting shall state the purpose and objects

thereof and shall be mailed to all member-societies at least thirty days prior to the date fixed for such meeting. Only subjects specified in the call may be acted upon at a special meeting.

ARTICLE V

Fiscal Year

The fiscal year of the Congress shall commence on July 1 of each year and end on June 30 of the following year.

ARTICLE VI

Representation

In all matters before the Congress, except upon a roll call vote, the voting by Member Societies and State Fraternal Congresses shall be as follows:

1. The member-society's President, Secretary, and full time Medical Director, General Counsel, Editor, Field Manager, Actuary, Investment Manager, Fraternal Director or an officer, director or employee certified by the member-society as serving in a similar capacity or position as any of the aforesaid, and so accepted by the Credentials Committee of the Congress shall be delegates and entitled to one vote each if in attendance and present at the time of the vote, but subject to the following:

a) no person holding more than one such office in a member-society shall have more than one vote; nor shall any person representing more than one member-society have more than one vote.

b) a delegate who is present at the time of the vote may cast the vote of any delegate of his Society who is registered as being in attendance but absent from the floor of the meeting.

2. Each member-society shall be entitled to additional votes determined on a representative basis as follows:

a) one vote for each 100,000 (or major fraction thereof) adult benefit certificates in force as of December 31st last past; provided, however, that each member-society shall be entitled to at least one vote on a representative basis.

b) in the event of a roll call vote, in addition to the qualified votes under paragraph (1) hereof, the President of each member-society shall be empowered to cast all votes determined on a representative basis. A member-society may designate any other of its officers to cast such votes instead of its President.

3. In all matters before the Congress the official delegate of each State Fraternal Congress shall be entitled to one vote, if registered and present, and if such delegate does not have a vote by virtue of holding an office as heretofore mentioned.

Upon request of any such officers from five or more member-societies, a roll call shall be ordered.

ARTICLE VII

Quorum

Whenever there are present sufficient persons to vote twenty-five per cent of the total voting strength of the Congress, a quorum shall be constituted; provided that a lesser number may take a recess from day to day. A majority of the members of the Board of Directors or of any other committee shall constitute a quorum of such committee.

ARTICLE VIII

Dues

The annual dues for each member-society shall be determined, following adoption of the annual budget by the Board of Directors at a meeting held prior to the first day of each fiscal year, by prorating among the member-societies the amount of the annual budget for the ensuing fiscal year. Each member-society shall be assessed dues based upon the total of the following factors:

a) 10% of the annual budget shall be divided equally among the member-societies.

b) 60% of the annual budget shall be prorated on the basis of admitted assets, as shown in each member-society's annual statement for December 31 preceding the beginning of the fiscal year, and as adjusted according to the following weightings:

First \$100 million of admitted assets	100%
Next \$100 " " " "	90%
" " " " " "	80%
" " " " " "	70%
" " " " " "	60%
All admitted assets over \$500 million	50%

c) 30% of the annual budget shall be prorated on the basis of premium income, as shown in each member-society's annual statement for the calendar year preceding the beginning of the fiscal year, and as adjusted according to the following weightings:

First \$10 million of life and annuity premiums	100%
Next \$10 " " " " " "	90%
" " " " " " "	80%
" " " " " " "	70%
" " " " " " "	60%
All life and annuity premiums over \$50 million	50%
All accident and health premiums	50%

Annual Dues of the Congress shall be due and payable July 1 of each year. If the annual dues of the member-society are not paid on or before December 31 of the year in which due, the member-society shall automatically be suspended.

A suspended member-society may be reinstated by the payment of all dues in arrears, not to exceed two years of arrears.

The first dues of the newly admitted member-society shall be prorated to the July 1 next following the date of admission, but shall not be less than one-half of the annual dues which would have been paid the preceding July 1 if the newly admitted member-society were then in good standing in the Congress.

ARTICLE IX

Officers and Term of Office

(1) The elected officers of the Congress shall be a President, Vice President, who shall be the President Elect, Immediate Past President. The Congress shall also elect nine Directors. The President, Vice President and Immediate Past President shall serve a term of one year or until a successor is elected. The Directors, when this Constitution is adopted, shall complete the term for which they were elected. At each annual meeting of the Congress three Directors shall be elected to serve for a term of three years to succeed the three whose terms then expire. Each Director shall hold office until a successor shall be elected.

(2) The foregoing elected persons shall constitute a Board of Directors which shall be the governing body of the Congress between annual meetings. The Executive Vice President shall meet with, and the Secretary-Treasurer shall act as Secretary of, the Board but neither shall have the right to vote.

ARTICLE X

Election of Officers-Nominating Committee

Election of Officers shall be the final order of business of the closing Plenary Session of the annual meeting of the Congress, followed by the installation of the officers.

The President of the Congress shall appoint a Nominating Committee consisting of five persons, giving preference to the five most recent living Past Presidents of the Congress. The Chairman of the committee shall be appointed by the President of the Congress.

The Nominating Committee shall invite suggestions from the membership for those offices and directorships which are vacant or about to expire, allowing at least thirty (30) days for suggestions before the annual meeting.

After the report of the Nominating Committee has been received, further nominations may be made from the floor.

ARTICLE XI

Duties of Officers and Board of Directors

(1) President: The President shall serve as Chairman of both the annual meeting and the Board of Directors; serve as a member, ex-officio with right to vote, on all committees except the Nominating Committee; make all required appointments of Standing, Sessional, Special and Additional Committees.

At the annual meeting of the Congress and at such other times as shall seem proper, the President shall communicate to the member-societies such matters and suggestions as may be deemed to promote the welfare and increase the usefulness of the Congress. He shall perform such other duties as are necessarily incident to the office of President or as may be prescribed by the Board of Directors.

(2) Vice President: The Vice President shall be the President-elect and if otherwise eligible shall succeed to the Presidency. The duties of the Vice President shall be as delegated by the Board of Directors. In the event of the inability of the President to serve, the Vice President shall perform the duties of the President and shall be an ex-officio member of the General Sessions Program Committee. In the event of the death or inability to serve of the President and Vice President, the most recent Past President shall assume the duties of the Presidency until the next annual meeting.

(3) Directors: There shall be nine Directors who shall be responsible for such duties as are assigned to them by the President or the Board of Directors.

(4) The Board of Directors shall have the following powers and duties:

- (a) To fill all vacancies in office and by two thirds vote of all members of the Board may remove any elective officer from office.
- (b) To suspend from membership by two thirds vote of all members of the Board any member-society which does not comply with or violates the terms and requirements of this Constitution.
- (c) To require reports from each member-society on any subject or subjects it may deem necessary for the good of the Congress.

(d) To have charge of the funds of the Congress in the interim between annual meetings of the Congress and pass upon all expenditures.

(e) To fix the compensation, and determine the employee benefits and conditions of employment of employees and staff officers of the Congress.

No expense in behalf of the Congress shall be incurred by anyone unless authorized by the Board of Directors.

An appeal shall lie to the Congress from any action of the Board of Directors.

ARTICLE XII

Staff Officers

The Board of Directors shall employ an administrative officer who shall have the title of Executive Vice President and whose term and conditions of employment shall be specified by the Board.

The Executive Vice President shall be chief administrative officer of the Congress who, subject to the direction and control of the Board of Directors, shall be responsible for the conduct of the business of the Congress, shall, with the concurrence of the Board of Directors, appoint a Secretary-Treasurer, and may employ such other professional and clerical personnel as may be required.

The Secretary-Treasurer as Treasurer shall be responsible for the maintenance of the Congress records; collect all member-society dues and shall have established proper accounting procedure for the handling of the Congress' funds; and shall report on the financial condition of the Congress at all meetings of the Board of Directors and at other times when called upon by the President.

As Secretary of the Congress shall be responsible for the proper mailing of notices to member-societies; and shall see to the proper recording of proceedings of annual meetings, and Board of Directors meetings.

ARTICLE XIII

Order of Business

The order of business for regular meetings of the Congress shall be:

First morning	Plenary Session of the Congress
First afternoon	General Session I of the Congress
Second morning	General Session II of the Congress

Second afternoon	General Session III of the Congress
Third morning	Plenary Session of the Congress

ARTICLE XIV

Standing Committees

The Standing Committees of the Congress shall be:

1. Law Committee
2. Financial Statements Committee
3. Investment Management and Valuations Committee
4. Public Relations Committee
5. General Sessions Program Committee
6. State Fraternal Congresses Committee

Except for the Law and State Fraternal Congresses Committees which shall be composed of twelve members, these Standing Committees shall be composed of nine members each. The President shall, immediately following each annual meeting of the Congress, appoint three members on each committee, except the Law and State Fraternal Congresses Committees, to serve for a period of three years. In the case of the Law and State Fraternal Congresses Committees, the President shall, immediately following each annual meeting of the Congress, appoint four members to serve for a period of three years. The Vice President of the Congress shall be an ex-officio member of the General Sessions Program Committee.

The Law Committee shall have such powers and duties and perform such services of a legal nature in the furtherance of the Congress and its member-societies as may be delegated to it from time to time by the President or Board of Directors.

The Financial Statements Committee shall review all financial reporting forms required by regulatory agencies, study any suggested changes and make recommendations to the regulatory agencies regarding such changes, and shall perform such services as may be delegated to it from time to time by the President or Board of Directors.

The Investment Management and Valuations Committee shall confer with the appropriate committee(s) of the National Association of Insurance Commissioners in regard to asset valuation and investment matters; and make such reports and recommendations to the President and Board of Directors as in its judgement seem desirable and proper as well as perform such additional duties as may be delegated to it from time to time by the President or Board of Directors.

The Public Relations Committee shall carefully consider ways and means for the improvement of the public relations of the Congress and shall, from time to time, submit its recommendations in that connection to the Board of Directors of the Congress.

The General Sessions Program Committee shall be responsible for arranging for speakers and participants and, in general, providing a constructive and worthwhile program for the General Sessions of the regular meeting of the Congress. This committee shall submit its program plans to the President of the Congress a minimum of ninety days prior to the date of the regular meeting.

The State Fraternal Congresses Committee shall assist the various State Fraternal Congresses in developing and carrying out their programs and perform such other services relating to State Fraternal Congresses as may be delegated to it from time to time by the President or Board of Directors. The Committee shall coordinate its efforts with individual states in matters of a legal nature with the Chairman of the Law Committee.

ARTICLE XV

Sessional and Special Committees

The Sessional Committees, consisting of three members each appointed by the President, shall be:

1. Credentials Committee
2. Constitution Committee
3. Resolutions Committee
4. Auditing Committee
5. Publicity Committee

The Credentials Committee shall have certified to it the credentials of all whose names are submitted as officers and delegates of member-societies and delegates of State Fraternal Congresses and shall prepare a roster thereof.

The Constitution Committee shall have referred to it all proposed amendments to the Constitution and shall submit same to the Congress along with its recommendations for action to be taken.

The Resolutions Committee shall have referred to it all resolutions except as otherwise directed by the Congress and shall submit same to the Congress along with its recommendations for action to be taken.

The Auditing Committee shall audit the reports of the Secretary-Treasurer and all expenditures authorized or incurred by the Board of Directors and shall report results thereof to the Congress.

The Publicity Committee shall prepare news releases for use by various news media and individual society publications pertaining to the annual meeting of the Congress. It shall be the official source through which publicity pertaining to the annual meeting shall be released.

The Special Committees, consisting of not less than three members each, appointed by the President, shall be a Membership Committee and such other committees as the Congress shall from time to time establish.

The Membership Committee shall recommend to the Board of Directors and to the Congress any action to be taken with respect to applications for membership by societies seeking membership in the Congress.

ARTICLE XVI

Additional Committees

Additional Committees may be organized at the discretion of the President as may be necessary or desirable.

ARTICLE XVII

Sections

There shall be the following Sections of the Congress:

1. Presidents' Section
2. Secretaries' Section
3. Medical Section
4. Law Section
5. Press and Public Relations Section
6. Field Managers' Section
7. Fraternal Section
8. Investment Section
9. Actuaries' Section
10. State Fraternal Congresses Section

Each Section may adopt by-laws for its own governing and may amend same from time to time. Such by-laws and amendments shall not become operative until approved by the Board of Directors of the Congress.

Each Section shall hold a meeting during the period of the annual meeting of the Congress at such time as the President or Board of Direc-

tors shall approve. The time of such meeting shall not conflict with the time of the Plenary or General Sessions of the Congress.

ARTICLE XVIII

State Fraternal Congresses

State Fraternal Congresses composed of representatives appointed by the various fraternal benefit societies doing business in the state may be organized under rules and regulations adopted by the Board of Directors of the National Fraternal Congress of America.

The basis of representation to any meeting of the State Fraternal Congress of each member-society of the State Fraternal Congress shall be fixed by the State Fraternal Congress.

Its annual dues shall not exceed \$35.00.

Each State Fraternal Congress shall file a copy of the Minutes of its Convention and report its activities to the Headquarters of this Congress, together with a list of its officers and their addresses.

ARTICLE XIX

Rules of Order

Robert's Rules of Order shall be the guide in all parliamentary proceedings of the Congress, subject only to specific parliamentary rules adopted by the Congress.

ARTICLE XX

Amendments

The Constitution may be amended at any annual meeting of the Congress by two-thirds of the votes cast on the question of such amendment. However, notice of the proposed amendment shall be read in open meeting of the Congress at least one day before a vote is taken thereon.
