

Dear Mr. Blackwell:

As you may be aware, America's first National Day of Prayer was proclaimed a year before the founding of our nation.

This practice was continued for some time but eventually fell into disuse. In 1952 a Joint Resolution of Congress requested that the President issue a Prayer Proclamation and this practice has been followed by eight Presidents.

In 1981 President Reagan restored the historic "first Thursday in May" as a day to celebrate together the National Day of Prayer. With the encouragement and enthusiasm of Mr. Peter Stewart, President of the National Thanksgiving Commission, efforts have been made to make the pronouncement early enough so groups could be prepared to plan for such an event.

President Ford held a ceremony at the White House with leaders of world religions at which time he signed the proclamation. A similar White House signing ceremony, in advance of the 1982 proclamation, would help give focus to the importance of the event.

Mr. Stewart was helpful in organizing the White House ceremony in President Ford's time and he has suggestions for this year, including individuals who are representative of the several religions.

#### A PROCLAMATION

National prayer is deeply rooted in our American heritage. From the earliest days of our Republic, Americans have asked God to hear their prayers in times of sorrow and crisis and in times of bounty.

The first National Day of Prayer was proclaimed in 1775 by the Second Continental Congress. As thousands gathered in prayer in places of worship and encampments throughout the new land, the dispersed colonists found a new spirit of unity and resolve in this remarkable expression of public faith. For the first time, Americans of every religious persuasion prayed as one, asking for divine guidance in their quest for liberty and justice. Ever since, Americans have shared a special sense of destiny as a nation dedicated under God to the cause of liberty for all men.

Through the storms of Revolution, Civil War, and the great World Wars, as well as during times of disillusionment and disarray, the nation has turned to God in prayer for deliverance. We thank Him for answering our call, for, surely, He has. As a nation, we have been richly blessed with His love and generosity.

Just 30 years ago, a Joint Resolution of the Congress requested the President to proclaim a day each year, other than a Sunday, as a National Day of Prayer, on which the people of the United States may turn to God in prayer and meditation in places of worship, in groups, and as individuals. Eight Presidents since then have annually proclaimed a Day of Prayer to the nation, resuming the tradition started by the Continental Congress.

NOW, THEREFORE, I, RONALD REAGAN, President of the United States of America, do hereby proclaim Thursday, May 6, 1982, National Day of Prayer. On that day, I ask Americans to join with me in giving thanks to Almighty God for the blessings He has bestowed on this land and the protection He affords us as a people. Let us as a nation join together before God, aware of the trials that lie ahead and of the need for divine guidance. With unshakable faith in God and the liberty which is our heritage, we as a free nation will continue to grow and prosper. nineteen hundred and eighty-two, and of the Independence of the United States of America the two hundred and sixth.

Several of the major religious leaders who attended the Presidential signing of the proclamation for the National Day of Prayer surely left disappointed.

Immediately prior to our bringing in the leaders for the Cabinet Room signing ceremony, Red told me that the "Big Three" had decided that the religious leaders would have to be across the table from the President rather than stand behind him.

This resulted in two problems:

1. It was impossible to shoot photographs which included the entire group with the President. When the photographers shot diagonally across the table, they got the President in the photo with only some of the visiting leaders.

2. Our proposal included a Presidential handshake with each of the religious leaders. The last-minute change in the physical arrangement prohibited this. The President only shook hands with two, the Catholic and Southern Baptist leaders who received the two ceremonial pens.

The President's remarks were fine. He spoke out in favor of voluntary school prayer and expressed his belief in intercessory prayer.

Only twenty two people, it was not a big crowd. It included very major leaders, most of whom are strongly supportive of the President.

If this had been a group of union bosses or black civil rights leaders, I have no doubt that the President would have been allowed to shake the hands of each person present.

Our failure to schedule the long hoped for pro-family coalition meeting last year has caused many of the President's religious friends to believe that someone in the White House regards conservative religious leaders as not vital elements of his coalition or somehow unclean. The ceremony this morning did nothing to dispell that impression.

PLANS ANNOUNCED FOR NATIONAL DAY OF PRAYER


WASHINGTON, D.C., March 1--Plans are under way for nationwide activities in connection with the National Day of Prayer on May 5, it was announced today.

President Reagan formally proclaimed that day, the first Thursday of May, as the thirty-first consecutive National Day of Prayer since Congress acted by joint resolution in 1952 to instruct the nation's Chief Executive to set aside one day each year for such a national observance.

Specific activities in connection with the National Day of Prayer are, however, arranged and coordinated by private groups, churches, and individuals independently of Congress or the President.

This year, a national committee composed mainly of representatives of major denominational and non-denominational prayer ministries is calling for a variety of nationwide activities including:

---coordinated proclamations at the state and local levels by governors and mayors as counterparts to the Presidential proclamation of the National Day of Prayer;



--the ringing of church bells at noon on May 5, followed by five minutes of united prayer ("Take five at 12") by all Americans wherever they may be;

- --a variety of state-level and local-level prayer-related activities appropriate to each state and local situation, coordinated by committees at those levels;
- --a gathering in Constitution Hall on the evening of May 5 for a time of prayer for the nation.

"Prayer is a way in which all Americans can truly make a significant contribution to our nation at a moment in history when we desperately need God's intervention," said Vonette Bright, co-chairman with Herbert E. Ellingwood of the National Day of Prayer Committee. Ellingwood is chairman of the U.S. Merit Systems Protection Board.

"We are praying that millions of Americans will begin now to help mobilize the entire country for a day of concentrated thanksgiving and intercession to God on May 5," Mrs. Bright added.

Assistance in the planning process has come from the members of the National Prayer Committee, whose members include: Mrs. Bright, chairman, and founder, Great Commission Prayer Crusade; David Bryant, Inter-Varsity Christian Fellowship; Mrs. Harold Christenson, United Prayer Ministries; Mr. and Mrs. Jim Dawson, Youth With a Mission; the Rev. Dick Eastman, Change the World Ministries;

Also Dr. Norval Hadley, World Vision International; Dr. Ben Jennings, Great Commission Prayer Crusade; Mr. Wyatt Lipscomb, Support for Action; the Rev. Moultrie McIntosh, Anglican Prayer Fellowship; Commissioner John Needham, The Salvation Army; and the Rev. Glenn Sheppard, Home Mission Board, Southern Baptist Convention.

# **NATIONAL DAY OF PRAYER**

## By the President of the United States of America A Proclamation

Prayer is the mainspring of the American spirit, a fundamental tenet of our people since before the Republic was founded. A year before the Declaration of Independence in 1775, the Continental Congress proclaimed the first National Day of Prayer as the initial positive action they asked of every colonist.

Two hundred years ago in 1783, the Treaty of Paris officially ended the long, weary Revolutionary War during which a National Day of Prayer had been proclaimed every spring for eight years. When peace came the National Day of Prayer was forgotten. For almost half a century, as the Nation grew in power and wealth, we put aside this deepest expression of American belief—our national dependence on the Providence of God.

It took the tragedy of the Civil War to restore a National Day of Prayer. As Abraham Lincoln said, "Intoxicated with unbroken success, we have become too self-sufficient to feel the necessity of redeeming and preserving grace, too proud to pray to the God that made us."

Revived as an annual observance by Congress in 1952, the National Day of Prayer has become a great unifying force for our citizens who come from all the great religions of the world. Prayer unites people. This common expression of reverence heals and brings us together as a Nation and we pray it may one day bring renewed respect for God to all the peoples of the world.

From General Washington's struggle at Valley Forge to the present, this Nation has fervently sought and received divine guidance as it pursued the course of history. This occasion provides our Nation with an opportunity to further recognize the source of our blessings, and to seek His help for the challenges we face today and in the future.

NOW, THEREFORE, I, RONALD REAGAN, President of the United States of America, do hereby proclaim Thursday, May 5, 1983 National Day of Prayer. I call upon every citizen of this great Nation to gather together on that day in homes and places of worship to pray, each after his or her own manner, for unity of the hearts of all mankind.

IN WITNESS WHEREOF, I have hereunto set my hand this 27th day of January in the year of our Lord nineteen hundred and eighty-three, and of the Independence of the United States of America the two hundred and seventh.

## **A Proclamation**

### From the President For a Day of Humiliation, Fasting and Prayer 1863

Whereas, The Senate of the United States, devoutly recognizing the Supreme Authority and Just Government of Almighty God, in all the affairs of men and of nations, has, by a resolution, requested the President to designate and set apart a day for National prayer and humiliation:

And Whereas, It is the duty of nations, as well as of men, to owe their dependence upon the overruling power of God, to confess their sins and transgressions, in humble sorrow, yet with assured hope that genuine repentance will lead to mercy and pardon, and to recognize the sublime truth, announced in the Holy Scriptures and proven by all history, that those nations only are blessed whose God is the Lord:

And, Inasmuch as we know that, by His divine law, nations, like individuals, are subjected to punishments and chastisements in this world, may we not justly fear that the awful calamity of civil war, which now desolates the land, may be but a punishment inflicted upon us for our presumptuous sins, to the needful end of our national reformation as a whole People? We have been the recipients of the choicest bounties of Heaven. We have been preserved these many years in peace and prosperity. We have grown in numbers, wealth, and power as no other nation has ever grown. But we have forgotten God. We have forgotten the gracious hand which preserved us in peace, and multiplied and enriched and strengthened us; and we have vainly imagined, in the deceitfulness of our hearts, that all these blessings were produced by some superior wisdom and virtue of our own. Intoxicated with unbroken success, we have become too self-sufficient to feel the necessity of redeeming and preserving grace, too proud to pray to the God that made us!

It behooves us, then, to humble ourselves before the offended Power, to confess our national sins, and to pray for clemency and forgiveness.

Now, therefore, in compliance with the request, and fully concurring in the views of the Senate, I do, by this my proclamation, designate and set apart THURSDAY, the 30th day of April, 1863, as a day of National Humiliation, Fasting and Prayer. And I do hereby request all the People to abstain on that day from their ordinary secular pursuits, and to unite, at their several places of public worship and their respective homes, in keeping the day holy to the Lord, and devoted to the humble discharge of the religious duties proper to that solemn occasion.

All this being done, in sincerity and truth, let us then rest humbly in the hope, authorized by the Divine teachings, that the united cry of the Nation will be heard on high, and answered with blessings, no less than the pardon of our national sins, and restoration of our now divided and suffering country to its former happy condition of unity and peace.

In Witness Whereof, I have hereunto set my hand, and caused the seal of the United States to be affixed.

Dear Mr. President:

National Day of Prayer Committee

Some two months ago, as you recall, you signed the Presidential Proclamation, setting aside Thursday, May 5, as the 1983 National Day of Prayer. We and others had requested the early proclamation-signing in order to have time both to publicize this important national observance and to encourage all Americans to make May 5 the meaningful day it deserves to be.

Thanks in substantial part to your much appreciated cooperation on the early signing date, the National Day of Prayer Committee has been able to move ahead toward these objectives in several ways. Now, with May 5 less than a month away, we want to express our gratitude to you again, bring you up-to-date on what has been done, and to ask your help in one other important way.

Within the past three weeks, the Committee has sent out more than 2,000 informational packets on the National Day of Prayer to secular and religious newspapers, magazines, wire services, and radio stations throughout the United States. This week, specially designed spot announcements are being sent to hundreds of television stations.

Other information and resource packets have been sent to hundreds of denominational heads and other religious leaders, as well as to all 50 governors and the mayors of the nation's 252 largest cities. (The mailing to governors followed the White House staff's action of sending a copy of your Proclamation to each governor.) A number of governors and mayors have already notified us of actions they have taken, or plan to take, to issue counterpart proclamations.

Many states and cities have volunteered National Day of Prayer chairmen and committees who are working on local plans. In addition, as you know, plans are far along for several events scheduled for Washington on May 5. The climactic Washington-based event will be the "Celebration of Prayer" at Constitution Hall that evening. We continue to be hopeful that you and Mrs. Reagan will be able to serve as co-chairmen of the broadly based Host Committee for the "Celebration of Prayer," and that you will be able to join us for what we believe will be a very memorable evening. The additional help that we ask concerns your weekly radio broadcast. Our two main goals for the nation as a whole are to make all Americans very much aware of the significance of May 5, and to urge them to observe it at a minimum by the ringing of bells at noon on May 5, and by taking at least five minutes at that time to thank God for His blessings and pray for America and its leaders. It would be extremely helpful, we believe, if you could include something about the National Day of Prayer in your regular radio broadcast on Saturday, April 30.

Specifically, we respectfully suggest the inclusion of three thoughts:

First, the fact that the National Day of Prayer is an established national observance, and has been ever since Congress instructed the President in 1952 to set such a day aside each year;

Second, encouragement to churches with bells, to ring them at noon on May 5 as a kind of national call to prayer in every community; and,

Third, encouragement to all Americans to "Take 5 at 12" on May 5 to express thanks to God and to pray for the nation and its leaders at all levels.

Background information on all of these points is enclosed with this letter.

Thank you again for your invaluable help thus far and for your consideration of this further request. Be assured of our continued prayers for you and Mrs. Reagan and our gratitude for the wonderful leadership you are giving our nation in these difficult times. God bless you.


