

Radio carries Christian message

Help! Wanted! Twenty-four Irving boys need Big Brothers. Phone Rusty Callaway, 651-0911, to volunteer.

Spring has sprung! Did you ever see anything as beautiful as the Texas bluebonnets along Highway 114? The road has been lined with camera enthusiasts. Pink and apricot Tyler roses, purple iris, yellow pansies, red tulips, coral Indian paint — a rainbow of color to delight the eyes — God's visual smorgasbord of loveliness freely given.

His slip of the tongue tickled Irvingites as Bob Bowman, president of the California-headquartered Far East Broadcasting, expressed his appreciation of "the Southern California weather you have provided for us here in Irving, Calif."

Area representatives Mr. and Mrs. Paul Reynolds, Mr. and Mrs. Steve Jones, Mr. and Mrs. Roy Watts of FEBC international radio were introduced.

FEBC (37 years old) gets 150,000 letters a year from India (600 million population and only one-tenth of the radio listeners write).

"Prior to '49 there were only one million Christians in China; half a million were killed for their faith. In the '60s there was great persecution in China, but FEBC kept broadcasting hope.

Around town



"Today the fastest growing church in the world is the China house churches. In some communes, two-thirds are believers (60-80 people). There are now 50-75 million believers in China; 12 million young believers were sent to farms to do hard labor.

"A 70-year-old man bikes 70 miles round trip to church, balancing his grown son on the handlebars. In China every family has a bike or radio.

"In Russia, because of radio, there are 39,750 isolated radio churches; radio is responsible for 80 percent of the Soviet believers. In '81, Russia — through radio — had 11,000 new believers. In Korea, evangelicals begin praying at 3 a.m. One Korean church has 200,000 members. Ninety-nine percent of the mail from Japan to FEBC comes from ages 12-22.

"Last year, 13 American volunteer construction workers came for 30 days to Saipan where rain is daily. They worked from sunrise to sunset six days of the week, praying that rain would not hinder. In that month, it rained only in the evenings and on Sundays. The volunteers saved FEBC \$100,000 in construc-

tion work.

"Before radio was invented, it was mentioned in Job 38:35. 'Sky Waves' tells the story of FEBC." (Box 1, La Mirada, Calif. 90637)

One of the largest leadership and communication seminars in the nation is ramrodded by a former brigadier general. It attracts top- and mid-management business people for week-long seminars every week of the year for a battery of tests of every kind.

One test reveals nearly identical ratings week-in and week-out for everyone. The test on interpersonal relationships finds that most people (on a scale from 1 to 10) score 7 on "want to be included," and score 3 on "think/feel I am included."

A solution? Concentrate on lowering the "7 want-to-be included" score one or two points to a 6 or 5. Work to raise the "3-think I am included" score one or two points to a 4 or 5. When the gap between "want to" and "feel/think I am included" is narrowed, interpersonal relationships improve. (verrrrry interesting.)

If you feel the slightest gratitude for Americans who died in Vietnam, a new book by Jeremiah Denton is "must" reading as a post-Memorial Day celebration.

When Hell Was in Session by former Rear Adm. Jeremiah Denton graphically recounts his seven and one-half years in several North Vietnamese prisoner of war camps after

being shot down in July of '65.

During a televised interview, his blinking the word "torture" in Morse code provided the first direct evidence of torture by North Vietnamese. Upon being released in '73, he made this statement: "We are honored to have had the opportunity to serve our country under difficult circumstances. We are profoundly grateful to our commander in chief and to our nation for this day. God bless America."

In '80, Denton was elected to the U.S. Senate from Alabama. In '81, he became board chairman of United Families of America. A free copy of the National Family Reporter is available from United Families, 1522 K St. N.W., suite 400, Washington, D.C. 20005. A donation will get you the book.

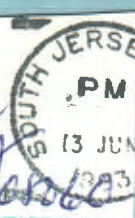

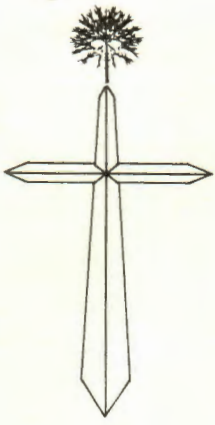

Mrs. Taylor's nomination to the Corporation for Public Broadcasting has my full support, and I submitted a statement on her behalf to the Communications Subcommittee.



Topic: Arms Control Compromise

Why are liberals and the arms control establishment welcoming so jubilantly the first major retreat from true arms control? That's what this proposed compromise in the Geneva talks really is, after all.

A quick summary of some chronology. In December of '79 the NATO Alliance decided to deploy 572 missiles, a combination of ground-launch and Pershing II weapons. NATO also stipulated that concurrent with deployment would be arms control talks aimed at avoiding the need for deployment, or at reducing the number to be deployed. The construction of the missile sites in Europe is now going on in England and West Germany, and anti-missile demonstrations have been common since 1980. The missile deployment is to begin in December '83. These arms control talks have been going on since November '81.

From the beginning of the talks, the U.S. position had been zero-zero. Or, we said we would not deploy any Pershing or ground launch missiles if the Soviets deactivated their SS-20's, SS-4's and SS-5's aimed at Europe. Or, put into English, we will not set up any missiles aimed at you if you take down those you already have aimed at us. This is arms control: no weapons for either side.

Now comes the big shift. This week it was announced that the United States would agree to deploy only a certain number of these missiles if the Soviets would agree to reduce their number of missiles. Or, we'll keep some missiles and you do likewise. Liberals consider this progress. How can that be? I thought the goal was no nuclear weapons. How can agreeing to let each side keep some nuclear missiles be arms control?

I suppose the benign interpretation would be that some kind of compromise now will alleviate the anti-nuclear civil disobedience and protests in England and West Germany. These are getting to proportions which might force abandonment of just about any European defense plans. But there is a less benign interpretation. Why is the United States moving toward the Soviet position at a time when Soviet provocation on other fronts is increasing. All along, it has been the Soviet goal to reduce their force by the least amount possible: no arms controllers making policy in the Kremlin, that's for sure.

But I've got to admit I'm still shaking my head over the reaction to this compromise. Here it's the conservatives who are holding out for zero-zero, no nuclear weapons for you and none for us. And I thought liberals were against nuclear weapons. I just can't understand why now they're acting as if they're for them.

SUBJECT: Helen Marie Taylor Appointment to CPB Board

We have done a disgraceful job of forwarding Mrs. Taylor's nomination, and she now knows it.

Today she read me a letter dated April 11 from Senator Goldwater to Martha Roundtree, head of the Leadership Foundation. Senator Goldwater wrote, tersely, that Mrs. Taylor's name has been taken off the list by the White House.

I called Nancy Kennedy about that April 11 letter this morning. She strongly denied she ever told Senator Goldwater we were withdrawing Mrs. Taylor's nomination.

What we have here at minimum is stark evidence that the White House has not given Senator Goldwater any reason to believe the President wants him to release his hold on Mrs. Taylor.

My own view is that Nancy Kennedy does not want Mrs. Taylor confirmed and is thus the wrong person to be dealing with this nomination for us.

With leaders like Falwell, Schlafly, Dolan, Weyrich and so many others asking for action and watching us carefully, we are putting on a bad show. We will be zapped on this soon in conservative media. Mr. Baker, particularly, has his credibility on the line.

A fact often unmentioned is that this appointment to the CPB Board for Mrs. Taylor is for a term which ends in March, 1984. Less than a year from now!

SUBJECT: Helen Marie Taylor Nomination

Attached is a report to me from Morton Blackwell on the status of the nomination of conservative leader Helen Marie Taylor to the Board of the Corporation for Public Broadcasting.

You will recall that Mrs. Taylor was the object of Dr. Jerry Falwell's request to the President in our Oval Office meeting March 15.

Apparently there was some confusion as the message about Mrs. Taylor was passed down the line to our Legislative Affairs Office. What happened in response to Dr. Falwell's request to the President was a query of Senator Goldwater by Nancy Kennedy, asking the senator if he had softened his opposition. Jim Cicconi believed, incorrectly, that Falwell had said to you there were indications Goldwater was coming around.

In any case, we have done virtually nothing to help change Senator Goldwater's mind on this nominee who is quite important to so many of our supportive groups. These groups point out that we "rolled over" objections by Senators Helms and East to major appointee from their own state, William Bennett at the National Endowment for Humanities.

As the attached memo indicates, Morton suggests you call Senator Warner and Senator Tribble and ask them, per former Senator Harry Byrd's wishes, to join Senator Byrd and Mrs. Taylor in a visit to Senator Goldwater to see how his objections, whatever they are, can be resolved.

SUBJECT: Helen Marie Taylor

We are approaching a crisis with respect to Helen Marie Taylor, the President's nominee for a slot on the Board of the Corporation for Public Broadcasting.

Senator Goldwater, chairman of the Commerce Committee subcommittee which has her nomination has a "hold" on her. The motive for his hold is unclear; it has different explanations. He has given no reason to our Legislative Affairs office staffer Nancy Kennedy, who is handling this.

Both Dr. Jerry Falwell and Phyllis Schlafly in private meetings with the President have asked him to intervene with Senator Goldwater in Mrs. Taylor's behalf. Twice, once to the President and Dr. Falwell in the Oval Office and again to Dr. Falwell at a subsequent meeting, Jim Baker said he would take care of the matter.

To date, nothing has been done. Jim Cicconi told me he understood from Mr. Baker that Dr. Falwell told the President Senator Goldwater may have weakened his opposition, so Cicconi asked Nancy Kennedy to check with Goldwater. She did and reported to me that Goldwater had not relented. Unfortunately, when I reported this to Dr. Falwell, he was upset and astonished. He denied he suggested Senator Goldwater might be coming around. (You were there for this conversation.) He said he had asked the President to intervene personally with Goldwater, not asked to have a staffer check with the Senator.

Attached is a fat folder of data on Mrs. Taylor's nomination. She has been a generous contributor to, and actually worked for, virtually every effective conservative group in the country. About \$1.5 million total in recent years. She's one of the biggest contributors, for instance to John Fisher's pro-defense activities. There will be real unrest if we don't fight for this nomination. Our credibility is at stake with many of our best allied groups.

Last weekend Gen. Al Wedemeyer pitched in to help Mrs. Taylor. He is an old friend of Barry, whom he called. The Senator told Wedemeyer that both Virginia senators opposed the nomination and that the Chairman of the Board of the Corporation for Public Broadcasting said she would resign if Mrs. Taylor joined the board.

In fact, Warner and Tribble both strongly state their support for her nomination. Warner testified for her and introduced her to Goldwater's sub committee. Tribble assures everyone, including me, that he strongly supports her.

It happens that the Chairman of the Board is Sharon Percy Rockefeller, a heavy contributor to Democratic committees and candidates. She is a pro-ERA leader, and Mrs. Taylor is a mainstay of Phyllis Schlafly and was a 1980 Reagan Alternate-Delegate to Detroit from Virginia.

Frankly, Goldwater's comments these days are unreliable.

Here is the strategy we are now using. Former Senator Harry F. Byrd, Jr. is an old associate of Mrs. Taylor. (She once led the successful fight to keep the Richmond airport named Byrd Airport.) Senator Byrd, an old friend of Senator Goldwater as was his father before him, has agreed to take Mrs. Taylor in with him to see Senator Goldwater, provided that Senators Warner and Tribble accompany them.

Dr. Falwell, John Alderson (1980 Virginia Reagan campaign head), and I embarked today on an effort to make sure our GOP senators from Virginia agree to join Senator Byrd and Mrs. Taylor in their visit to Barry. Political reality dictates that they will comply.

Suggested Actions

1. The President should phone Senator Goldwater and ask him to support Mrs. Taylor, "primarily because of her long record of support for a strong national defense."
2. To make good unmistakably on his statements to Dr. Falwell, Mr. Baker should chat with Senators Warner and Tribble and urge them to join Senator Byrd and Mrs. Taylor in a visit to Senator Goldwater.

Note: Helen Marie Taylor is strong-willed. The only "negative" comment I have heard about her in conservative activist circles is her reputation for talking too long on the telephone. That is not a fatal flaw. She is a Reagan team player who would cut off her arm rather than embarrass the President or hurt his battle for conservative principles. She is well qualified for the post to which the President has nominated her.


