Helen Marie Taylor is given Monroe Medal

Helen Marie Taylor, whose passion for the causes in which she believes once prompted her to stand steadfastly in front of a bulldozer sent to tear up the cobblestones of a Richmond street, yesterday was presented the James Monroe Medal awarded annually by the board of regents of the James Monroe Law Office and Memorial Library.

Mrs. Taylor ~~was given~~ the medal at a meeting of the James Monroe Memorial Foundation held here.

A member of both the board of regents and the foundation board, she was chosen to receive the medal because of things she has done during the past couple of years to benefit the museum and library, located at 908 Charles St.

Among the things she has done, she told a reporter yesterday, was to help reorganize the foundation's board, of which she is vice president and chairman of the executive committee. She also helped write new bylaws for the group.

However, the contribution Mrs. Taylor seemed most proud was in connection with the celebration of the foundation's 50th anniversary.

"I arranged for the Virginia General Assembly to pass a resolution recognizing Mr. Laurence Gouverneur Hoes," said Mrs. Taylor yesterday as she talked with a reporter. She then steered

the conversation away from what she had done to deserve the James Monroe Medal and began praising Hoes, who founded the museum and memorial foundation.

A great-great-grandson of Monroe, Hoes could have made a great deal of money by selling the contents of the library and museum, but chose instead to keep the collection together and see to it that they were left as a legacy to the nation, said Mrs. Taylor. Because of that she said she greatly admires Hoes, who lives in Germany.

Mrs. Taylor, who has worked in behalf of the James Monroe Law Office and Memorial Library for 3½ years, lives in Orange County and Richmond.

Along with her husband, J.E. Taylor, she gave \$382,000 to the Orange Board of Supervisors in 1975 to assist that locality celebrate the nation's bicentennial. When the County Bicentennial Commission began diverting some of that money toward projects that did not please Mrs. Taylor she spoke out, threatening at one point to file suit. It was a drawn-out and highly vocal controversy, during which some people criticized Mrs. Taylor for what they said was undue interference.

Laughing when a reporter mentioned that controversy, Mrs. Taylor said yesterday, "Isn't that something? Down here I'm given a medal for being a good girl, but up there I was tarred and feathered."

Helen Marie Taylor has asked me to write you concerning her nomination to the Board of Directors of the Corporation for Public Broadcasting or the National Council on the Humanities.

As I explained to your wife in our telephone conversation, Mrs. Taylor has been recommended by the Reagan-Bush Transition Team for each of these federal boards and has the support of Senator Warner and Senator Byrd.

It has been suggested to Mrs. Taylor that in addition to these two senate recommendations, a letter from you, as Chairman of the Virginia Reagan-Bush Committee, and one from Jack Reid, as Chairman of the 3rd Congressional District Republican Party, would be helpful.

I have enclosed copies of Mrs. Taylor's background information and a partial list of organizations which she and Mr. Taylor have supported during the past seven years. This kind of list doesn't mention Helen Marie's trip to New Hampshire however, where she rented four vans, paid the expenses of seven people she took with her and with the assistance of a Christian church and school covered 47 polls, manned the RB headquarters trunk lines and helped to turn what had been forecast as a losing situation into a resounding victory. RR. ✓

Again, when the polls in Illinois showed John Anderson leading 34% to Reagan's 31%, Helen Marie got word to Reagan to encourage that Phyllis Schlafly be called and her 6,000 supporters be urged to cover the polls and to vote only for those delegates and alternates who were committed to Ronald Reagan. Governor Reagan did call Phyllis Schlafly. A mailing to those 6,000 Schlafly activists included a key instructing people how they should vote in this so-called "blind election" where candidates did not reveal who they supported. As you will remember, Illinois, like New Hampshire, turned out to be an upset victory at a crucial time in the primaries.

As you also know, Mr. and Mrs. Taylor funded a thirteen-state "Good Government Seminar" series that made a substantial impact on the senatorial elections. Mrs. Taylor travelled personally with the group in 1979 and 1980.

On the local scene, Mrs. Taylor has supported Governor Reagan since 1968. In addition to working with you in the State Reagan-Bush Committee, she worked the polls in northern Virginia and contributed \$1,000 to set up the phone banks for Jack Reid in her home 3rd Congressional District area.

Those of us who have supported Reagan for so many years feel that Helen Marie Taylor is exactly the type of person that should be serving the administration to help the President carry out his program in a completely loyal and dedicated manner.

We would greatly appreciate your effort in placing these resumes with the individuals who will participate in final selection of the President's appointees. We would like to receive a copy of your letter in behalf of Mrs. Taylor for our files.
