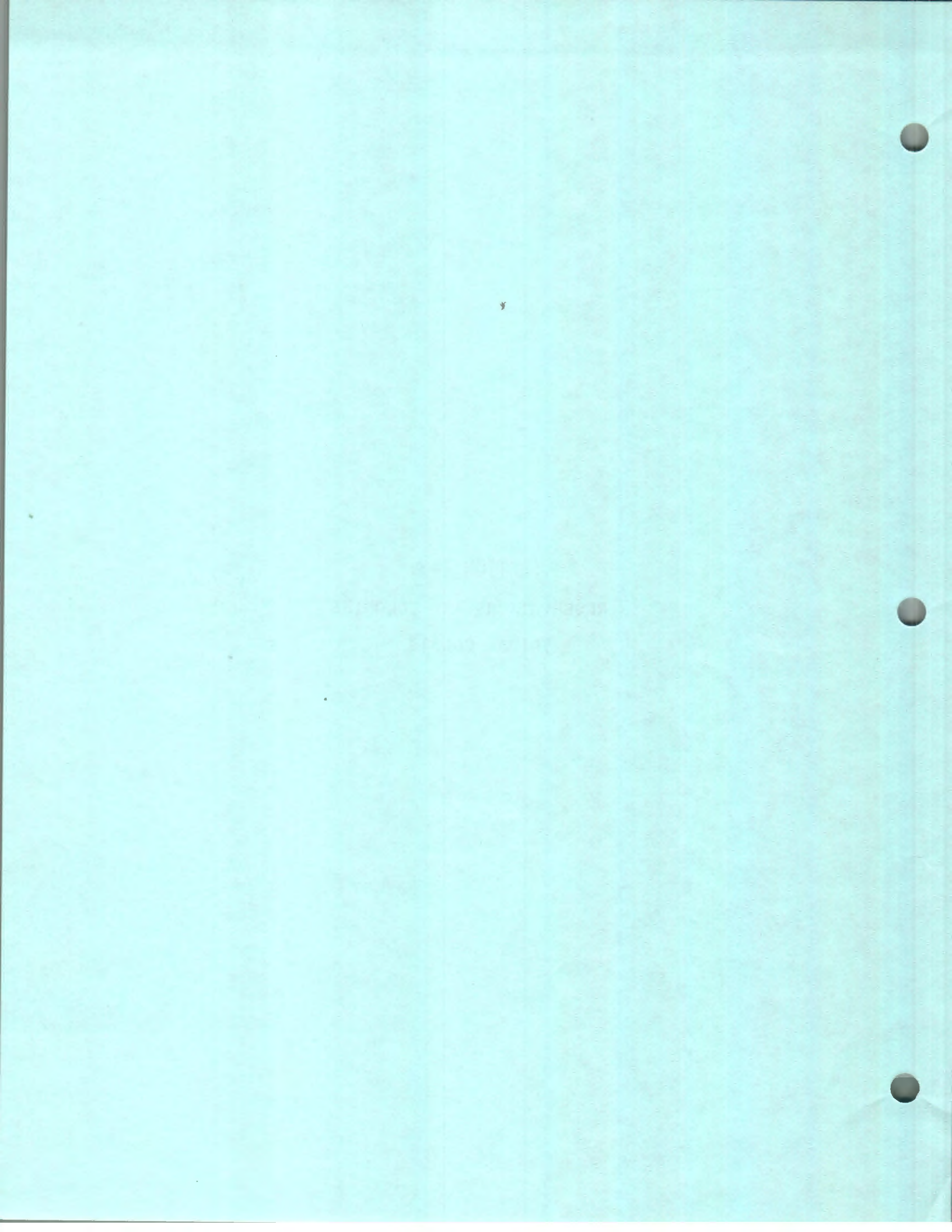

A non-profit corporation organized under Nevada laws on the 23 February 1966. Its purpose is to secure benefits for Indian peoples, preserve cultural values, promote the general welfare, education, and employment for Indians; and promote understanding between Indian and non-Indian peoples.

Membership of the Inter-Tribal Council consists of the following reservations and colonies: Duck Valley, Duckwater, Ely, Fallon, Goshute, Las Vegas, Lovelock, McDermitt, Moapa, Pyramid Lake, Reno, Summit Lake; Te-Moak and its member councils: Battle Mountain, Elko, and South Fork; Walker River, Washoe and its member councils: Carson City, Dresslerville, and Woodfords; Winnemucca, Yerington, and Yomba. The Inter-Tribal Council's Board of directors comprises the tribal chairman of each member reservation or colony.
