INDIVIDUALISTIC FREEDOMS

Regardless of recent polls we are encouraged with our new administration. The following statements are not meant to be destructive, rather constructive. We trust they will be accepted in this manner.

One of the main concerns is separation of church and state. For this to be fully effective the church should refrain from intensive guidance of government, and likewise the government restrain from church intervention.

Secondly, bringing balance to public education. Teaching theory as theory and nothing more. We are disappointed that our children have been experimented with in the classroom. Values clarification and secular humanism are definitely undermining, and we feel it is not the responsibility of public schools to present spiritual or moral guidelines unless the whole spectrum of morality is presented. If views other than secular humanism and values clarification are not presented by qualified persons, our children should not be forced to participate. We need to realize we are responsible for raising future generations.

I am much afraid that schools will prove to be the great gates of Hell unless they diligently labor in explaining the Holy scriptures, engraving them in the hearts of our youth.

"I advise no one to place his child where the Scriptures do not reign paramount. Every institution in which men are not increasingly occupied with the Word of God must become corrupt." Martin Luther (Sixteenth Century)

While we support Human Rights to a degree, we also feel that extensive freedoms granted to goups like E.R.A., Gay Rights, and promotion of common law living, are not only undermining to the family unit, but also destructive to the fabric of our society. We feel it inclusive that action be taken immediately concerning these things, not stripping persons of their individual rights but restraining their militancy.

We realize taxation is perhaps a touchy subject with the millions of dollars donated to non-profit organizations yearly. It is the ministries responsibility to steward those funds properly. We are aware there may be misuses, but at the same time the majority are innocent. Many churches would close if taxation was ever placed on them. For this reason we hope for continued freedom from taxation. The only tax we would ever support is on excessive property and business holdings. The events which led to the collapse of the Roman Empire are startling similar to the events which are occurring in our nation today.

HISTORICAL SEQUENCE:

- 1. STRONG FAMILIES: Rome was founded on high moral standards. Each father was respected as the head of the family. In the early republic, the father had legal authority to discipline rebellious members of his family.
- 2. HOME EDUCATION: The education of the children was the responsibility of the parents. This further strengthened the children's honor and respect for their parents and also deepened the communication and understanding between parents and children.
- 3. PROSPERITY: Strong Roman families produced a strong nation. The Roman armies were victorious in war. The wealth of conquered nations increased Roman prosperity and prestige.
- 4. NATIONAL ACHIEVEMENTS: Great building programs began in Rome. A vast network of roads united the empire. Magnificent palaces, public buildings, coliseums were constructed.
- 5. INFILTRATION OF "THE LIE:" As Roman families prospered, it became fashionable to hire educated Greeks to care for the children. Greek philosophy, with its humanistic and Godless base, was soon passed on to the Roman families. Women demanded more rights and, in order to accomodate them, new marriage contracts were designed, including "open marriages."
- 6. BIG GOVERNMENT: By the first century A.D. the father had lost his legal authority. It was delegated to the village, then to the city, then to the state, and finally to the empire. In Rome, citizens complained about housing shortages, soaring rents, congested traffic, polluted air, crime in the streets, and the high cost of living.

Unemployment was a perennial problem. To solve it, the government created a multitude of civil service jobs, including building inspectors, health inspectors, and tax collectors. Why the Roman Empire Fell Page 2

> 7. DECLINE AND PERSECUTION: The problems of big government only multiplied. Meanwhile, a flourishing New Testament Church was established in the Roman Empire through the preaching of the Apostde Paul and others. The final act of the Roman Empire was to bring great persecution to these Christians.

Rome was quite tolerant of all religions except Christianity. Christianity was banned and Christians were persecuted, burned, and thrown to the lions. Why? Because the very nature of Christianity is intolerant of "the lie" of Satan which is the basis of every other religion.

By the third century, Christianity conquered pagan Rome.
