LINCOLN'S GREATEST VICTORY

A telegram which announced that Lee was about to surrender came to the White House in Washington during the stormy days of the Civil War. Abraham Lincoln left Washington immediately to go to the front.



When news reached him that Lee had surrendered and the officials had made preparation for the entry into Richmond, Lincoln put his foot down and said, "There shall be no triumphal entry into Richmond. There shall be no demonstration just now." He made his way to Richmond and walked throughout the city alone. There never was such a triumphal entry as that in all the annals of history. He walked with his head bowed down, with heavy step and sad heart, and when he reached the Southern capital and went to Jefferson Davis' room, he bade his two officials step aside and leave him alone. After a few minutes had passed by, one of them out of curiosity looked to see what was taking place; there sat Lincoln with his head bowed on Jefferson Davis' desk, his face in his hands, and his tears falling. His great sympathetic heart saved the Republic. That was the greatest victory in the Civil War that bound the North and South together. The greatest victory in those days of struggle was that Christlike sympathy. The greatest victory that is ever won on any battlefield of human life in the hour when the struggle goes on is won through the wonderful element that comes down from the heart of Jesus Christ-His own divine sympathy for struggling humanity. -Cortland Meyers in The Olive Branch.



Dear Mr. Piedot:

Upon receiving your letter regarding the closing of the school at Faith Baptist Church, I asked the Department of Justice to report on the matter. They advised me that on October 5, 1981 the Supreme Court dismissed the appeal in Faith Baptist Church v. Douglas for want of a substantial federal question. As I understand it, this means that the Supreme Court will not review the decisions of the lower court.

As the President's principal liaison to the religious community, I can assure you of my strong support for church-related education. My children were enrolled for nine years in an excellent Christian school in the Virginia suburbs of Washington, D.C.

Church-related schools are growing in numbers and effectiveness because parents are willing to make economic sacrifices to give their children the education these schools provide.

I am sure you can appreciate that the accreditation of schools is primarily a matter of state law. While the Administration supports diversity in education, we believe it can best be furthered by minimizing federal interference with decisions of local educational authorities. In any event, there does not appear to be a legal basis for federal intervention into this matter.



Dear Mr. Blackwell:

Thank you very much for your timely response to my inquiry relative to governmental padlocking of Faith Baptist Church in Louisville, Nebraska. It is heartening to know that in a Government as large and as powerful as ours, that there are people such as yourself, that care about the concerns of individual Americans, such as myself. I know that you are a very busy and important man and I sincerely appreciate the fact that you took time to respond to my inquiry.

If I may be so bold, I now ask for another moment or two of your valuable time. I am sure that this issue is of such importance as to merit a few more moments.

Apparently, in my last letter, I inadequately expressed myself. Your response did not address my concerns at all. Lord willing, this writing will be sufficiently explicit.

Your response stated that "the Administration supports diversity in education..." As I shall explain, "diversity in education" has little or nothing to do with the issue under consideration.

You also implied that church - related schools provide a more effective education than public schools. It is, indeed, a shame that the quality of education in public schools is woefully inadequate. However, again, the quality of education offered by the various institutions is not really relevant to the issue.

The central issue is: Do Christians obey the Government (state or federal) or God?

God has specified in the Bible that children belong to Him, but that He has entrusted them to human parents to nourish and to love and to train in the things of God. The Christian parent must obey these clear commands of God.

The public school system, however, works against the teaching of godly Christian parents. While claiming to be religiously neutral, the public school system has become an extensive indoctrination center into religious Humanism for our nation's youth. Every single tenet of the Humanist Manifesto (1933) and the Humanist Manifesto II (1973) are openly advocated in the public schools today. (Enclosed is an article which includes a condensation of the Humanist Manifesto and the Humanist Manifesto II.) The public school system has adopted Humanist principles as the authority directing the training of the children of America.

The proper training of a child is an awesome responsibility. Success produces men like George Washington and Abraham Lincoln, while failure produces degenerates such as Nero and Antiochus Epiphanes. A glance at the fruits we are reaping from those educated in Humanism (drug addiction, robberies, assaults, murders, sodomy, rapes, anarchy, suicides, illiteracy, etc.) graphically decries religious Humanism.

The Christian parent, on the other hand, has the assurance of God's Holy Word that if they raise their children exactly as God commands, then the responsibility for success rests on God. AND GOD HAS NEVER FAILED!

God has commanded Christian parents how to train their children. When the state government (with federal consent) requires Christian parents to conform the training of their (God's) children to state mandated standards, which contradict God's standards, then the state and federal Governments are directing the Christian parents to disobey God.

That, sir, is a violation of the 1st and 14th Amendments to the Constitution of the United States. Although I am not qualified to address the legal basis for federal intervention, I do know that I, as an officer of the United States Air Force, took an oath, as you did and as President Reagan did, to defend the Constitution: Therefore, there is a definitive moral basis for Administration intervention into this violation of constitutionally guaranteed rights and God demanded obedience.

I trust that you will prayerfully consider the implications of the activity in Louisville, Nebraska.

Dear Mr. Divis:

Upon receiving your letter regarding the closing of the school at Faith Baptist Church, I asked the Department of Justice to report on the matter. They advised me that on October 5, 1981 the Supreme Court dismissed the appeal in Faith Baptist Church v. Douglas for want of a substantial federal question. As I understand it, this means that the Supreme Court will not review the decisions of the lower court.

As the President's principal liaison to the religious community, I can assure you of my strong support for church-related education. My children were enrolled for nine years in an excellent Christian school in the Virginia suburbs of Washington, D.C.

Church-related schools are growing in numbers and effectiveness because parents are willing to make economic sacrifices to give their children the education these schools provide.

I am sure you can appreciate that the accreditation of schools is primarily a matter of state law. While the Administration supports diversity in education, we believe it can best be furthered by minimizing federal interference with decisions of local educational authorities. In any event, there does not appear to be a legal basis for federal intervention into this matter.


